#### **EXECUTIVE SUMMARY:**

As a result of representations by residents of the St Pauls area of Winchester regarding difficulties finding on-street parking spaces it is proposed to revise the existing waiting restrictions in St Pauls Hill to control the non-resident parking so as to maximise the available parking of residents permit holders. There is also an anomaly in the existing traffic order schedules that is being rectified as part of this proposal.

The relevant County Councillor, City Councillors, Police and Parking Office Manager were consulted and gave their approval to proceed with the proposal. Public notices were placed in the Hampshire Chronicle on Thursday 25<sup>th</sup> January 2007, and erected on street from Thursday 25<sup>th</sup> January 2007 up to and including Monday 19<sup>th</sup> February 2007.

12 letters of objection to the proposal have been received, 6 from the businesses in the adjacent area of Stockbridge Road and 6 from customers of these businesses, stating that the existing limited waiting provision is vital to the continued economic vitality of these businesses.

In light of these comments an amendment to the original proposal is being recommended whereby the larger existing echelon parking bay on the north-east side of St Pauls Hill is to remain available to non-permit holders for a maximum limited period of 2 hours. The 2 other bays in St Pauls Hill are to become residents permit holders only 8am to 10pm Monday to Saturday as per the original proposal.

#### RECOMMENDATIONS:

- 1. That the proposed revision to the Traffic Regulation Order in St Pauls Hill, Winchester be approved such that the existing 'Echelon Parking 2 Hours Limited Waiting with Permit Holders Exemption Monday to Saturday' waiting restrictions remain unchanged but that the order be amended to reflect the corrected schedule and the Head of Legal Services be authorised to make the necessary order.
- 2. That the proposed revision to the Traffic Regulation Order in St Pauls Hill, Winchester be approved such that the existing '2 Hours Limited Waiting with Permit Holders Exemption Monday to Saturday' waiting restrictions be changed to 'Permit Holders Only 8am to 10pm Monday to Saturday' and the Head of Legal Services be authorised to make the necessary order.




