## RECENT REFERENCES:

CAB1398(TP) – Proposed Experimental Traffic Order – St Johns Street, Winchester -30 January 2007.

## EXECUTIVE SUMMARY:

Further to extensive consultation and previous report to the Cabinet (Traffic and Parking) Committee, an experimental order introducing one-way traffic in St Johns Street in the southerly direction (downhill) was approved.

This order was implemented and the revised traffic flow introduced on 15<sup>th</sup> March 2007. Since this time the order has proven to be effective and although some comments were received initially regarding the safety of the access into Blue Ball Hill from Magdalen Hill/Alresford Road no accidents have been recorded at this location.

A follow up letter and questionnaire was distributed to all properties affected by the experimental order. The results of this showed that the overwhelming majority of residents are in favour of the experimental one-way order being made permanent. Details of these are included as Appendix D and E. It should be noted that there was an error in the response form, stating that the experimental one-way flow was northbound when it is actually southbound, however many residents picked this up and made their own correction when replying. It is not believed that this error changed the outcome of the survey.

Details of the traffic speeds and volumes before and after the experimental order was introduced will be reported verbally at the meeting as the follow up data is not available at the time of the Report being circulated.

Despite some residents fears over access and visibility at the junction of Alresford Road and Blue Ball Hill there have been no recorded accidents at this junction since the experiment was introduced.

From an environment aspect the order appears to have resulted in an overall improvement

in the immediate area and a significant benefit to the quality of life for the residents of St Johns Street.

If the order is approved to be made permanent there will be some minor alterations to the kerb lines at the southern end of St Johns Street to provide better visibility for motorists exiting onto Magdalen Hill/Bridge Street. The kerb and footway levels at the junction of Alresford Road/Blue Ball Hill will be modified to remove the 'ramp' effect.

Other temporary measures will be made permanent, except that provision for a future contraflow cycle lane will be engineered into any permanent construction.

It is proposed to make the one-way traffic order permanent.

#### RECOMMENDATIONS:

- 1. That work be carried out for one-way traffic southbound in St Johns Street, Winchester as covered in the experimental traffic regulation order, to be made permanent.
- 2. That the Head of Legal Services be authorised to make a permanent order as set out in Recommendation 1.

#### OTHER CONSIDERATIONS:

The proposal is in keeping with the Corporate Strategy in its attempt to provide a high quality environment & safe and strong communities.



## THE CITY OF WINCHESTER (ST JOHNS STREET) (EXPERIMENTAL ) TRAFFIC REGULATION) ORDER 2007

Winchester City Council on behalf of Hampshire County Council in exercise of its powers under sections under Sections 1,2 4,9,10, 32,35,45,46,49,51 and 53 of the Road Traffic Regulation Act 1984 (" the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986, Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order :-

1. In this order the "Principal Order " means "The City of Winchester (Central Area)

Traffic Regulation (Consolidation) Order 1984 as amended.

- 2. The Principal Order is varied by measures hereby authorized by the addition to the Second Schedule thereof of the item listed in the Schedule hereto.
- 3. The Councils Director of Development may, if that officer considers it essential in

the interests of the expeditious, convenient and safe movement of traffic or for

preserving or improving the amenities of the area through which any road affected

by this order runs, and after consulting with the Chief Officer of Police modify or

suspend this order, or any provision thereof, at any time.

- 4. This order shall come into operation on the 12<sup>th</sup> day of March 2007 and shall remain in force until the 11<sup>th</sup> day of September 2008 or such earlier date as the Council shall determine.
- 5. This order may be cited as The City of Winchester (St Johns Street) Experimental Traffic Regulation Order 2007.

### EXPERIMENTAL ONE-WAY TRAFFIC ORDER - ST JOHNS STREET, WINCHESTER

Now that the experimental order introducing one-way traffic in St Johns Street has been in for a few months I am writing to get feedback form the residents directly affected.

The Council is aware of some issues, especially with visibility at the junction of Blue Ball Hill and Alresford Road/Magdalen Hill and is in the process of installing some additional signing and road markings which are hoped will help resolve this potential problem. The Council is also installing an edge of carriageway line in Blue Ball Hill from the Alresford Road junction through to Beggars Lane to provide a protected footway for pedestrians.

Should the scheme be made permanent it is also proposed to revise the kerb lines at the southern end of St Johns Street to provide better visibility for those exiting onto Magdalen Hill

I would be grateful if you could let me have any comments by Friday 28th December 2007 so that they can be included when this matter is taken to Committee for consideration.
