EXECUTIVE SUMMARY:

At the meeting of the Cabinet Traffic and Parking Committee on 22 February 2010 it was resolved to introduce enforceable 'Disabled Badge Holders Only', 'Permit Holders Only 8:00am to 10:00pm Monday to Saturday' and 'No Waiting At Any Time' restrictions in Canon Street, Winchester. Due to a number of problems detailed in this report it has not been possible to implement these revisions, which have subsequently been put on hold.

Further consultation has been carried out in an attempt to resolve this issue, however there are still problems that need to be overcome. This matter was raised during the public participation section of the Cabinet (Traffic and Parking) Committee on 10 June 2011 and this report is in response to that request.

The report summarises the action taken to date and possible actions to be considered.

RECOMMENDATIONS:

- 1 That the changes advertised on 1st April 2010 to the 'Disabled Permit Holders Only', 'Permit Holders Only 8:00am to 10:00pm Monday to Saturday' and 'No Waiting At Any Time' waiting restrictions in Canon Street, Winchester as approved under CAB1946(TP) on 22 February 2010 be formally revoked.
- 2 That the proposed changes to the 'Disabled Permit Holders Only', 'Permit Holders Only 8:00am to 10:00pm Monday to Saturday' and 'No Waiting At Any Time' waiting restrictions in Canon Street and the other roads in Zone C, Winchester be formally pursued as set out in 2.3 and Appendix D.

REPORT OF THE HEAD OF ACCESS AND INFRASTRUCTURE

DETAIL:

- 1 <u>Introduction</u>
- 1.1 At the meeting of the Cabinet (Traffic and Parking) Committee on 22 February 2010 it was resolved to introduce enforceable 'Disabled Badge Holders Only', 'Permit Holders Only 8:00am to 10:00pm Monday to Saturday' and 'No Waiting At Any Time' restrictions in Canon Street, Winchester. The proposed changes were duly advertised on 1st April 2010 with a view to implementing them on the 6th April 2010. Details of the Order as advertised are included as Appendix A.
- 1.2 Due to the narrow width of the footway at the location of the proposed disabled bay, the residents adjacent to the bay were contacted to see if they would be willing to have the necessary 'blue badge holders only' plate fixed to their wall on their joint boundary. Both residents refused this permission, so the plate needed to be placed on a new post. It was proposed to erect this on the back of the footway at the same location, however, this proved impossible due to the residents installing hanging baskets. There were also concerns regarding the proximity of underground vaults belonging to the properties. The footway at this location is too narrow to accommodate a post adjacent to the kerb as this would then create an obstruction for pedestrians.
- 1.3 The County Councillor for the area also questioned the validity of the Order as he felt they had not been correctly notified/consulted during the reporting process.
- 1.4 Due to the above difficulties the instruction to install the new sign and markings was put on hold and further consultation was carried out with residents in an attempt to find an alternative acceptable solution.
- 2 <u>Alternatives Investigated/Additional Consultation</u>
- 2.1 In an attempt to mitigate the objections and problems raised, the possibility of relocating the parking bays and disabled bay to the northern side of Canon Street was suggested, together with the introduction of some additional areas of on-street parking in Zone C. This was drafted and circulated to the Ward Members and all residents in the Zone. Details of these proposed changes are included as Appendix B.

- 2.2 The proposal to introduce additional on-street parking spaces was universally supported, however the suggestion of moving the parking bays in Canon Street to the northern side of the road produced significant objections from residents in the immediate vicinity. A summary of the responses was circulated to Ward Members and is attached as Appendix C. This would cause less disturbance to the user of the disabled bay.
- 2.3 An alternative solution to relocating the parking bays in Canon Street is to keep the bays on the southern side but to position the disabled bay to the eastern end of the bays. See Appendix D. This would maintain the provision of the facility whilst overcoming the difficulties in placing the necessary signage. This compromise has been suggested but is not supported by the person that currently uses the disabled bay. It would be less convenient for the user of the disabled bay because of the distance from the house.

3 <u>Assessment</u>

3.1 The original order would be difficult to be implemented due to the signing issues as identified in point 1.2 above. The proposal outlined in 2.2 would not be ideal because of the objections raised by residents regarding access and visibility issues. The other alternative is highlighted in point 2.3 above and on balance may be the only viable solution to this difficult problem.

OTHER CONSIDERATIONS:

4 <u>SUSTAINABLE COMMUNITY STRATEGY AND CHANGE PLANS</u> (RELEVANCE TO):

The proposal is in keeping with the Community Strategy in its attempt to provide a high quality environment & safe and strong communities.

5 <u>RESOURCE IMPLICATIONS</u>:

The cost of advertising and implementing the Traffic Regulation Order changes and any associated works is covered by the Traffic Management agreement with Hampshire County Council.

6 RISK MANAGEMENT ISSUES:

Risks are fully considered as part of the assessment process of all Traffic Regulation Orders. The changes/issues covered do not represent significant risks.










SUPPORTS CHANGE TO MAKE ADVISORY DISABLED BAY ENFORCEABLE. DOES NOT WANT BAYS AS A WHOLE TO BE MOVED TO NORTH SIDE OF CANON STREET. DIFFICULT ACCESS FOR REFUSE LORRY. WASTE OF MONEY.


