EXECUTIVE SUMMARY:

Commuter parking has been an on-going issue in Lynford Avenue and Lynford Way, Winchester for many years and previous consultation and the limited measures taken has not resulted in a satisfactory conclusion for residents.

The only effective solution available to resolve this problem is the introduction of residents permit holder parking restrictions. Changes in the Council policies relating to residents' permit parking schemes and other issues in the Weeke area has resulted in this matter being considered again.

This report outlines the actions taken and the measures proposed to resolve this problem.

RECOMMENDATIONS:

- That the proposed introduction of '1 Hour Limited Waiting With Permit Holders Exemption 10:00am to 4:00pm Monday to Friday' and changes to the 'No Waiting 8:00am to 6:00pm Monday to Saturday' waiting restrictions in Lynford Avenue, Lynford Way and Bereweeke Avenue, Winchester be approved as advertised.
- 2 That the Head of Legal Services be authorised to make the necessary order.

REPORT OF THE HEAD OF ACCESS AND INFRASTRUCTURE

DETAIL:

1 <u>Introduction</u>

- 1.1 Residents of Lynford Avenue and Lynford Way, Winchester have been in correspondence with the Council over many years regarding problems caused by inconsiderate parking and potential safety issues caused by commuter parking in their roads. The Council has carried out several consultations on this subject, the most recent being in July 2010.
- 1.2 The Council has recently introduced changes to the way in which traffic regulation orders in relation to residents permit schemes is considered (the 1/3rd rule) which together with possible new Monday to Friday waiting restrictions (parking light) has led to this matter being reviewed.
- 1.3 Due to other parking and access issues, the Council undertook a further areawide consultation with all residents in the Weeke area to establish whether residents as a whole would be in favour of additional parking and waiting restrictions throughout Weeke. This area-wide consultation was carried out in February 2011 and the response from residents showed that restrictions were only considered necessary in a few roads in the Weeke area.

2 Proposed Restrictions

- 2.1 Following previous correspondence with residents of Lyndford Avenue and Lynford Way it had been established that the most preferred option would be for the newer 10:00am to 4:00pm Monday to Friday restrictions, rather than the standard 8:00am to 6:00pm Monday to Saturday restrictions as used in central Winchester.
- 2.2 The proposed restrictions were drafted accordingly and were supported by the Ward Members, County Councillor and Police and subsequently advertised on 18 May 2011. Details are attached as Appendices A, B and C.

3 Comments and Conclusion

3.1 There were only 4 objections received in response to the formal adverts compared to 20 emails/letters of support and 2 additional letters of support but

- with concerns regarding the location of some of the parking bays. A summary of the responses is attached as Appendix D.
- 3.2 Although this matter could therefore have been taken forward under the Portfolio Holders Decision route, due to the potential impact of this proposal and bearing in mind other proposals for additional waiting restrictions elsewhere in Weeke, it is considered appropriate to have this proposal taken to Committee so that the wider implications can be debated.
- 3.3 It has been demonstrated that there is significant support in the local community for these restrictions and it is therefore considered that they should be implemented as advertised. However, if implemented the restrictions will displace the current commuter parking to other adjacent roads, so it is recommended that the impact of the restrictions be closely monitored and any resultant changes to the existing traffic regulation orders be actioned as a priority.

OTHER CONSIDERATIONS:

4 <u>SUSTAINABLE COMMUNITY STRATEGY AND CHANGE PLANS</u> (RELEVANCE TO):

The proposal is in keeping with the Community Strategy in its attempt to provide a high quality environment & safe and strong communities.

5 <u>RESOURCE IMPLICATIONS</u>:

The cost of advertising and implementing the Traffic Regulation Order changes and any associated works is covered by the Traffic Management agreement with Hampshire County Council.

6 RISK MANAGEMENT ISSUES:

Risks are fully considered as part of the assessment process of all Traffic Regulation Orders. The changes/issues covered do not represent significant risks.
