THE HAMPSHIRE (VARIOUS ROADS WINCHESTER)
(PARKING PLACES AND RESTRICTION OF WAITING) (CONTROLLED ZONE) (NO. 3)
ORDER 2013

Winchester City Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of the powers of the said County Council and in exercise of the powers under Sections 1(1), 2(1) to (3), 4, 45, 46, 49 and 51 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, proposes to make the following Order. This order is a replacement Order pursuant to Section 20 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 to replace the order dated 24<sup>th</sup> July 2012 which is hereby revoked.

#### PART I - GENERAL

- 1 In this Order
- 1.1 "amenity or community group" means an amenity or other organisation which provides a service to the community and conducts regular daytime activities primarily intended for adults.
- 1.2 "the Council" means Hampshire County Council or, as the case may be, Winchester City Council acting as Hampshire County Council's agents;
- 1.3 "civil enforcement officer" has the same meaning as in Section 76 of the Traffic Management Act 2004
- 1.4 "customer" means any person visiting business premises for the purpose of purchasing goods or services thereat;
- 1.5 "disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;
- 1.6 "disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 2000;
- 1.7 "driver" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;
- 1.8 "e-ticket" shall mean a ticket purchased by ringing the number prescribed and displayed in the parking place for that purpose, paying the tariff in accordance with Schedule 5 together with an additional fee payable for the use of the service, by the payment method specified and shall only be valid for the time specified and for the vehicle details given and for the parking place for which it was purchased

- "goods" include postal packets of any description; and "delivering" and "collecting" in relation to any goods include checking the goods for the purpose of their delivery or collection:
- 1.10 "goods vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description, and is not drawing a trailer;
- 1.11 "guest house" means those establishments registered with Winchester City Council which offer bed and breakfast facilities and have no more than 6 rooms available for hire to guests;
- 1.12 "Hackney Carriage" a vehicle licensed by Winchester City Council for the conveyance of passengers (does not include private hire vehicles).
- 1.13 "lay-by" means any area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002, and partly by the outer edge of that carriageway on the same side of the road as that on which the sign is placed;
- 1.14 "carriageway" in relation to a road specified in a Schedule means any carriageway of that road used primarily by through traffic and excludes any lay-by;
- 1.15 "motor cycle" means a mechanically propelled vehicle not being an invalid carriage with less than four wheels and the weight of which unladen does not exceed, 410 Kilograms;
- 1.16 "one-way street" means a highway in which vehicles are prohibited at all times from proceeding in any other than one direction;
- 1.17 "owner" has the same meaning as in Section 92 of the Traffic Management Act 2004;
- 1.18 "parking disc" means a disc, issued by a local authority, 125 millimetres square, coloured blue if issued on or after the 1st April 2000 (or orange if issued before that date) and capable of showing the quarter hour period during which a period of waiting begins;
- 1.19 "parking place" means any part of a road authorised by this Order to be used as a parking place;
- 1.20 "parking ticket" means either:-
  - 1.20.1 a parking ticket issued by a ticket machine located in the vicinity of a parking place, for which payment has been made in accordance with the tariff specified in Schedule 5 to this Order and which authorises the parking of a vehicle in that parking place and displayed in the relevant position in accordance with the provisions of article 18 of this Order; or
  - 1.20.2 an e-ticket
- 1.21 "passenger vehicle" means a motor vehicle which is constructed or adapted solely for the carriage of not more than twelve passengers, exclusive of the driver, and their effects and is not drawing a trailer;
- 1.22 "permit" means a permit issued under the provisions of this Order;

- 1.23 "permit holder" means a person or organisation to whom a permit has been issued under the provisions of this Order;
- 1.24 "permit zone" means each of those areas which comprises those roads and lengths of roads specified in Schedule 1 Parts 2 to 3, 4, 5 and 6 to this Order and which is identified by the same letter of the alphabet or number (whichever is appropriate) in the right hand column of those Schedules
- 1.25 "plying for hire" being available for hire
- 1.26 "relevant position" means:
  - 1.26.1 in the case of a vehicle fitted with a front windscreen, a position thereon with the obverse side facing on the near side of and immediately behind the windscreen so that the date, time, parking place name and fee paid shown on the ticket are clearly visible from outside the vehicle;
  - 1.26.2 in the case of a vehicle not fitted with a front windscreen, any other conspicuous position on the front of the vehicle so that the date, time, parking place name and fee paid shown on the ticket are clearly visible from outside the vehicle:
  - 1.26.3 in the case of any disabled person's vehicle, relevant position shall be defined by Regulation 4 of the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.
- 1.27 "relevant vehicle" means a passenger or goods vehicle with an unladen weight of 2 tonnes or less, provided that no such vehicle exceeds 6 metres in length;
- "resident" means a person whose usual place of abode is at premises situated in any permit zone or who is the owner of any such premises which are undergoing renovation prior to being let. For the purposes of these provisions the expression "resident" shall not include a person pursuing a course of education or training who occupies premises designed for the purposes of multiple occupation and who is in actual occupation of part thereof for less than 40 weeks a year;
- 1.29 "telecommunications apparatus" has the same meaning as in the Telecommunications Act 1984;
- 1.30 "ticket machine" means an apparatus of a type and design approved by the Secretary of State in accordance with Section 35 (3) of the Act for the purpose of this Order, being apparatus designed to indicate the time by a clock and to issue parking tickets indicating the payment of charge and the date and time at which the payment was made.
- 1.31 "Verge" means any part of a road which is not a carriageway.
- 1.32 "Visitor" shall mean any person visiting or residing with the permit holder on the day or for the period that the vehicle is left in the parking place
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (No.2) Order 2002 is hereby varied as detailed in Schedule A to this order.

- Each of the parts of a road specified in Schedule 1, to this Order is authorised to be used subject to the following provisions of this Order as a parking place for such classes of vehicles, on such days and during such hours as are specified in relation to that part of the road in the said Schedules.
- Any person duly authorised by the Council or a police constable in uniform may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary provided that no such suspension effected solely by a police constable in uniform shall continue for a period greater than twenty-four hours.
- Where in Schedule 1 to this Order a parking place is described as available for vehicles of a specified class, the driver of the vehicle shall not permit it to wait in that parking place:-
  - (a) during the available hours of use authorised under this Order; AND
  - (b) unless it is of the specified class; or
  - (c) unless it is a motorcycle; AND
  - (d) unless where required it displays (for the entire period of waiting) a valid parking ticket (as defined by Article 1 above) or a valid e-ticket is in effect: or
  - (e) unless it is a disabled person's vehicle which displays in the relevant position a disabled person's badge; AND
  - (f) unless:
    - if the parking place is not in a one-way street, the left or near side of the vehicle is adjacent to the left-hand edge of the carriageway;
    - (ii) if the parking place is in a one-way street the left or near side of the vehicle is adjacent to the left-hand edge of the carriageway or that the right or off-side of the vehicle is adjacent to the right-hand edge of the carriageway, and it is positioned within the parking areas defined by white lines on the surface of the road.
    - (iii) if the parking place is defined by white lines the vehicle is positioned within the area defined by the white lines
- 7 A driver of a vehicle shall not use a parking place:-
- 7.1 so as unreasonably to prevent access to any premises adjoining the road, or the use of the road by other persons, or so as to be a nuisance;
- 7.2 when the use of that parking place has been suspended in accordance with Article 5 of this Order.
- The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.

- No person shall use a vehicle, while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services unless he does so from the vehicle itself and the period of waiting does not exceed 20 minutes.
- A disabled person's vehicle which displays in the relevant position a disabled person's badge shall be exempt from any limitation on time specified in column 5 of Part I of Schedule 1 to this Order.
- In column 5 of Part I of Schedule 1 to this Order references to the period of time within which the return of a vehicle is prohibited shall be deemed to prohibit that vehicle from subsequently waiting in any of the parking places referred to in Parts 2,3, 4,5 and 6 of that Schedule, within that period of time.
- Subject to the proviso hereto, when a vehicle is left in a parking place in contravention of any of the provisions contained in Articles 4, 5, 6, and 7 of this Order a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be removed from that parking place; provided that when a vehicle is waiting in a parking place in contravention of the provision of Article 6(f) of this Order, a person authorised in that behalf by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision.
- Any person removing a vehicle or altering its position by virtue of the last preceding Article of this Order may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to remove it or alter its position, as the case may be.
- When a person authorised by the Council removes or makes arrangements for the removal of a vehicle from a parking place by virtue of Article 12 of this Order, he shall made such arrangements as may be reasonably necessary for the safe custody of the vehicle.
- A police constable in uniform or a Civil Enforcement Officer may move or cause to be moved, in case of emergency, to any place he thinks fit, any vehicle left in a parking place.
- 16 Nothing in this Order shall:-
- 16.1 make it unlawful to cause or permit any vehicle to wait at any time in a parking place (other than a parking place or part of a parking place the use of which has been suspended), if:-
  - 16.1.1.1 the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
  - 16.1.1.2 the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
  - 16.1.1.3 the vehicle is a vehicle being used for fire and rescue service purposes, an ambulance, a vehicle under the control of a Doctor on Duty for so long as may be necessary for him to visit a patient, a vehicle in the service of a Local Authority or Health Authority or a vehicle in the

service of a Police force in either case being used in pursuance of statutory powers or duties or a vehicle being used by a minister of religion for so long as may be necessary in the course of his duties;

- 16.1.1.4 the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
- 16.1.1.5 the vehicle is in the service of or employed by Royal Mail or any company authorised to collect or deliver postal packets, and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle, or, having been unloaded therefrom, are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or is in use in connection with the servicing of telephone kiosks adjacent to the parking place:
- 16.1.1.6 the vehicle, not being a passenger vehicle, is waiting only for so long as may be reasonably necessary to enable it to be used for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus or traffic sign;
- 16.1.1.7 the vehicle is waiting only for so long as is necessary to enable goods to be loaded onto or unloaded from the vehicle:
- 16.1.1.8 the vehicle is waiting to enable a pupil attending any school to be picked up or set down in connection with the attendance of that pupil at that school, provided no such period of waiting shall exceed 20 minutes:
- 16.1.1.9 the vehicle is waiting to take in petrol, oil, water or air from any garage situated on or adjacent to the said parking place; or
- 16.1.1.10 the vehicle is waiting at or near to any premises situated on or adjacent to the said parking place for so long as is reasonably necessary in connection with any wedding or funeral.
- make it unlawful to cause or permit any vehicle to be left in a parking place or part of a parking place the use of which has been suspended;
  - 16.2.1.1 for any vehicle being used for fire and rescue services, ambulance or police purposes;
  - 16.2.1.2 or for any purpose specified in Article 16.1.1.2, 16.1.1.4 or 16.1.1.5, to be left in that suspended parking place or part of a parking place;
  - 16.2.1.3 or for any other vehicle to be so left if that vehicle is left with the permission of the person suspending the use of the parking place or the part thereof in pursuance of Article 5.

- A person causing or permitting a vehicle to wait in a parking place by virtue of the provisions of Article 16.1.1.2, 16.1.1.4, or 16.1.1.5 of this Order shall take all such steps as are necessary to ensure that the vehicle waits in accordance with the requirements of Article 7.1 of this Order.
- Where a parking ticket is required by a provision of this Order to be displayed in a vehicle it shall be placed in the vehicle on or adjacent to the front of its windscreen so as to be easily readable from the outside of the vehicle and shall be maintained in position during the whole of the time that its display is required to comply with a requirement of Articles 6 of this Order.

#### **PART III - PERMITS**

- Any resident of a parking zone which is identified by the same letter of the alphabet or number in the right hand column of those Schedules attached to this Order may apply to the Council for the issue of a permit for the leaving of a relevant vehicle by that resident, any other person resident at the same address or by any visitor to that address at any time in any parking place specified in Schedule 1 to this Order situated in the same permit zone as that resident's usual place of abode, subject to no more than four such permits being available for use, two by residents and two by visitors, in respect of any one address; provided that any period of waiting by a vehicle left by a visitor shall not exceed the duration of such visit.
- Any proprietor of business premises situated in the parking zone, where those premises do not have sufficient off-street parking facilities to adequately meet the business needs of the business concerned, may apply to the Council for the issue of a permit for the leaving of a relevant vehicle by any customer of that business at any time in any parking place specified in Schedule 1 to this Order situated in the same permit zone as those business premises, for a period no longer than one hour in any one day, subject to no more than one such permit being available for use in respect of any one business address.
- Any proprietor of a guest house situated in the permit zone may apply to the Council for the issue of a permit for the leaving of a relevant vehicle by any guest registered at those premises at any time in any parking place specified in Schedule 1 to this Order situated in the same permit zone as that guest house, subject to no more than one such permit being available for use in respect of each room available for hire to guests at any one guest house.
- Any person or organisation whose premises are situated in the permit zone areas may apply to the Council for the issue of a permit for the leaving of a relevant vehicle by any person attending those premises for the purpose of participating in activities organised by an amenity, or community group, (or any other society or person who the parking manager deems at his absolute discretion to require a permit) at any time in any parking place specified in Schedule 1 to this Order situated in the same permit zone as those premises, subject to no more than 20 such permits being available for use in respect of any particular premises.
- Subject to the Council's agreement, any existing resident permit holder may apply to the Council for 10 scratchcard permits(or such other form of replacement permit issued for this purpose by the Council), each scratchcard to be valid for the leaving of a relevant vehicle by any person visiting that resident at any time on the day indicated on the scratchcard, in any parking place referred to in Part I of Schedule 1 to this Order and located in the same zone as the resident's address, on any of

those parts of road specified in Parts 2, 3, 4,5 or 6 of that Schedule, provided that no more than 20 such permits are issued in respect of any one address during any calendar year.

- Any proprietor of any business may apply to the Council for the issue of a permit for the leaving of a relevant vehicle in any permit zone for a period no longer than two hours in any 24 hour period by any employee of that business for the purpose of attending a customer's premises located within that permit zone.
- The Council may require an applicant for a permit or a permit holder to produce such evidence in respect of the application as they may reasonably required to verify any particulars of information given to them. Any such application shall be made on a form issued by the Council and shall include the particulars and information required by such form to be supplied.
- The Council, upon being satisfied that details supplied by an applicant are accurate, and that the applicant is eligible in accordance with the provisions of this Order, to be issued with the permit or permits applied for, and on receipt of the appropriate fee as specified in Schedule 4 to this Order, and subject to the provision of Article 31 of this Order, may issue such a permit or permits to the applicant for the leaving of a relevant vehicle as provided in the relevant article of this Order, by the owner or by any person using such vehicle with the consent of the owner (other than a person to whom such a vehicle has been let for hire or reward). Subject to Articles 23, 29, 30, and 32 of this Order, all such permits shall be valid for a period of twelve months.

#### 29 A permit holder;

- 29.1.1 may surrender a permit to the Council at any time; and
- 29.1.2 shall surrender a permit to the Council on the occurrence of any of the events set out in Article 31 of this Order;

and a permit holder who surrenders a permit

- i. before the permit becomes valid shall be entitled to a refund of the fee paid in respect thereof;
- ii. after the permit has become valid shall be entitled to a refund calculated on the balance of the period remaining unexpired at the time when the permit is surrendered to the Council, to a minimum value of £10.00;

  - (f) a cheque, cash or credit card or electronic transfer received from the permit holder as payment of the appropriate fee in respect of the permit being subsequently dishonoured or any information supplied in support of a permit application being subsequently found to be false;

  - (h) the permit having been used by any person not authorised to do so under the provisions of this order; and

  - (a) at any time on any of the sides of road specified in Schedules 2, to this Order;
  - (b) between the hours of 10.00am and 4.00pm from Monday to Friday (both days inclusive) on any of the sides of road specified in Schedule 3 to this Order.
- Nothing in Article 41 of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the sides or road referred to in that Article upon the direction or with the permissions of a police constable in uniform or Civil Enforcement Officer, or with the permission of the Chief Officer of Police given by means of an exemption certificate displayed on or adjacent to the nearside of the front windscreen of the vehicle, provided that no condition imposed on the use of that certificate at the time of issue has been breached.

- Nothing in Article 41 of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of road referred to in that Article for so long as may be necessary:-
  - (a) to enable a person to board or alight from the vehicle;
  - (b) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with the following operations namely:-
    - (i) building or demolition;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of the said sides of road;
    - (iv) the laying, erection, alteration or repair in, or in land adjacent to, the said sides of road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus;
  - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties:
  - (d) to enable the vehicle to be used in the service of Royal Mail or any company authorised to collect or deliver postal packets, for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
  - to enable the vehicle to take in petrol, oil, water or air from any garage situated
     on or adjacent to the said sides of road;
  - (f) to enable the vehicle to wait at or near to any premises situated on or adjacent

to the said sides of road for so long as is reasonably necessary in connection

with any wedding or funeral;

- (g) to enable the vehicle to be used for fire and rescue services, ambulance or police purposes; or
- (h) to enable the vehicle to wait owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident.

- Save as provided in Article 46 of this Order, nothing in Article 41 of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of road specified in Schedules 2, and 3 to this Order for so long as may be necessary to enable goods to be loaded onto or unloaded from the vehicle.
- Save as provided in Article 46 of this Order, nothing in Article 41 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait on any of the sides of road specified in Schedules 2, and 3 to this Order for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road on the same day).

#### **PART V -- HACKNEY CARRIAGES**

- 46 Nothing in this Order shall:
  - render it unlawful to cause or permit any vehicle to wait on any side of road if that vehicle is a hackney carriage plying for hire at an authorised hackney carriage stand;
  - (b) be deemed to authorise or permit any vehicle which is not a hackney carriage to wait at an authorised hackney carriage stand;
  - (c) render it lawful for a hackney carriage driver to leave a hackney carriage unattended at an authorised hackney carriage stand.

B Taylor	Objection	1/ Permit parking restrictions should be for the shortest time possible I propose 11am - 2pm or 10am-2pm one hour with permit holders exemption. 8am - 6pm is too long and not necessary to accommodate the needs and wishes of the residents. 2/ Current no waiting on Francis Gardens outside house numbers 10 - 18 (southbound carriageway) to be removed and replaced with permit parking. This piece of road is currently used by the occupants and visitors fro day to day parking. There are no issues in terms of road width or obstruction. I have measured the road width here (opposite no 10 Francis Gardens) and on Chaundler Road and Oglander Road where permit parking on both sides is planned. The road width is the same. The proposed no waiting restrictions (8am -4pm) ignore current residents' parking patterns and is unnecessary and unjustified. To prevent residents with permits parking outside their own houses is a huge infringement on private lives. The council should not be controlling residents' lives to this extent. I would be happy to clearly identify and discuss this specific location with the relevant council
B Walker	Objection	Green Park Close is made up of young families with young children who rely on visits from family and friends throughout the week. There are 6 children under 5 years old, with many working mothers. Such a proposal will create a serious problem for many in our Close. The council is slowly reducing the appeal of this very nice suburb and turning what I consider an incredible community into a very dissatisfied one.
C Day	Objection	Pay more than enouh taxes already and object to having to pay for parking permit as well. Parking problem only on part of estate.
C Day	Objection	if the Council is serious about addressing residents' original concerns about 'commuter parking' on the Estate, (rather than simply seizing the opportunity to generate additional revenue for the Council through the imposition of parking permits), then it should be proposing the <i>least</i> restrictive parking restrictions possible which still achieve that aim. It is obvious that as the Estate is only a 15 minute walk from either the City or the train Station, it is 'all-day' commuters that need to be deterred. To that end, a short period of parking restriction in the middle of the working day would achieve this whilst minimising the impact on residents (and would also help Traffic Wardens to target a specific period of the day to issue parking tickets to transgressors). C Young H Connell	Objection Objection	"I strongly oppose permit parking in Abbotts Barton."  The proposed Monday-Friday 08:00-18:00 restriction is too long. Non-resident commuters (the cause of the problem which I understand the parking scheme is being introduced to solve) could just as easily be prevented from parking within the area by the introduction of a shorter restriction period, for example 11:00-14:00 Monday-Friday with a 1 hour waiting time. 2. The 14 metre double yellow line proposed for the South-west corner of Dyson Drive (Area O, Zone 3A) is too long. The junction with Worthy Road could be kept sufficiently clear with a much shorter double yellow line. Imposing a 14 metre restriction will unnecessarily limit the parking available for the residents of Dyson Drive, who are already due to lose some of their parking provision at the South-east corner of the street. 3. I believe these complaints comes in response to a territorial instinct rather than to a real problem. #### **PERMIT PARKING TRO IN ABBOTTS BARTON**

As a resident of our community and original member of the ABCDAG team I agreed to look into the Parking Situation within the Abbotts Barton community along with others.

I have previously written in about the parking myself and made the suggestion that a number of residents were not in favour of any permit parking restrictions at all and those that were had expressed a wish for any restrictions to be targeted solely at reducing all day commuters which was the only problem our residents had to deal with. With the introduction of your latest TRO in our estate I was asked by some residents to conduct a survey of the community's views.

I am lead to believe that in discussions with Clir Maynard and Clir Hiscock some residents had understood that their Councillors also supported a reduced Permit Parking time restriction being introduced during the centre of the day which would be sufficient to deter all day commuters whilst allowing the community, who for the last 40 years had enjoyed the liberty to park as and where they chose, the maximum freedoms for parking thereafter.

Our goal here is to restrict commuter parking and nothing more.

It is not for our community to endure being punished with heavy-handed and over-restrictive restrictions.

Many in the community, particularly towards the North end of the estate, really do not want to suffer parking restrictions in any form but were reluctantly willing to accept them if the restriction times could be minimised and agreed to not veto the TRO proposals completely if they could be amended to give them maximum flexibility whilst still achieving their intended purpose. We are therefore pleased to submit a petition to you on behalf of the Abbotts Barton residents who have seen fit to express their personal views through its Petition Heading:

## Petition for reducing Permit Parking Hours in Abbotts Barton

We <u>OPPOSE</u> the Councils suggestion of no parking between 8-6pm with a 2 hour waiting period in Abbotts Barton as we believe this is far too onerous for the stated objective of deterring commuters from parking on our street during the daytime. Instead, we are in favour of the more appropriate solution of Permit Parking being introduced only during the core hours of 11-2pm (Monday to Friday) with 1 hour waiting period.

As you can see 180 households from 249 contactable households are asking the Council to introduce this revised minimum Parking Restriction period. (Cavendish Grove, Grosvenor Drive and Green Park Close have been removed from total estate numbers for this exercise but overwhelmingly support restricted permit times.) Ready access was not possible to 12 of the flats in Symonds Court due to security entrance controls and we saw no reason to disturb the elderly there so please deduct their numbers from any final household count. Similarly 5 dwellings that I visited I was told either were completely unoccupied or looked unoccupied within the estate ie with no furniture inside.

Many of the remaining houses not represented were simply unavailable to sign and I can honestly say I have had less than 20 households who I met who have said they prefer not to sign, I am therefore of the opinion that a significantly clear majority of the estate favour these changes identified within the petition and would then accept a revised TRO.

Clearly many more residents from within those properties could have signed the petition were they present or available when the petition signatures were collected but we trust you will not ask for any further names to those already collected as the total tally submitted here already represents a substantial majority household community decision.


Separate petitions have been submitted from Cavendish Grove, Grosvenor Drive and Green Park Close residents asking for no implementation of Parking Restrictions within their streets at this time, they have also stated that if permits were ever needed on their own streets in the future then they too would request for a similar reduced 11-2pm restriction.

There are insufficient parking spaces currently for householders to Coney Green (esp via Knights Close and Russel Road) and that some residents expressed a wish to discuss this with the TRO team to see if other spaces can be found in the area by reducing proposed double yellow lines at the top or Knight Road (and possibly along Chaundler road opposite Russel Road too?) We believe other spaces needed in the estate could be created elsewhere where unslightly raised cobbled areas are also used for extra parking, infact the whole estate would benefit from re-designing the ugly areas of hard landscaping and during that process new parking spaces needed could be created.

We trust you can accept these amendments from our community graciously and without contest as we feel we are already under too much stress as a community fighting unwanted council house development in our estate to have to validate every single household's view with yourselves- it takes an awfully long time to obtain everybody's personal view and collect petition signatures from a community as large as this. We trust you will accept that what we are presenting here can be accepted as a substantial working mandate from the community of Abbotts Barton for a change to 11-2 pm reduced permit times with 1 hour waiting in your TRO for our area which will then make permit parking restrictions acceptable to all those households who signed the petitions.


