EXECUTIVE SUMMARY:

This report contains details of applications for capital grant aid in 2008/09 and recommends appropriate levels of support based on the policies and criteria currently in force and the availability of resources.

This report was omitted from the Forward Plan of Key Decisions due to an oversight. It needs to be considered as part of the budget discussions occurring elsewhere on this agenda. The Chairman of Principal Scrutiny Committee has been informed.

DETAIL:

1 Introduction

- 1.1 The purpose of this report is to present details of the community capital grant applications for 2008/09 and to recommend appropriate levels of support for each, as outlined in Appendix 1.
- 1.2 The original application forms and supporting documents are held in the Partnerships and Communications Division. Any Member wishing to study the forms prior to the meeting should contact the Partnership and External Funding Officer who will make the necessary arrangements.

2 Resources

- 2.1 Budget provision of £80,000 has been made in the Council's capital programme to support eligible applications for grant aid in 2008/09.
- 2.2 There are two projects previously awarded a capital grant that have declined the grant offer in 2007/08, meaning that a sum totalling £18,747 will be unspent. It is requested that £17,560 of this unspent money is carried forward to 2008/09 for use in supporting new applications. The remaining £1,187 will remain unclaimed and will be removed from the grant budget. This means that a total of £97,560 is available for allocation.
- 2.3 In addition to this budget, a grants reserve is maintained. This is primarily to support emergency grant requests (both capital and revenue) that may arise during the course of the year. The current balance on this reserve is £46,591 after taking into account further allocations for capital grants during the year.
- 2.4 Fourteen applications for capital grant were received and the total amount of grant requested for 2008/09 was £432,323.50 which is in excess of the available budget. This report recommends grant awards totalling £97,560 for 2008/09. This could be met using the carry forward of £17,560 detailed above.
- 2.5 One of these applications was for a significantly large grant which cannot be managed within the capital grant budget. See item 3.4(i) below.

3 Application Details

3.1 Details of all the applications received are shown in Appendix 1. Each project has been subject to a rigorous evaluation to assess the level of community benefit, compliance with the policies and criteria currently in force, the level of external

- funding already secured, and sustainability. The recommended grant levels reflect the results of these considerations.
- 3.2 Members are reminded that the maximum level of City Council grant aid available to each project is double the contribution from the local parish council or the Winchester Town Account. There is an exception where the tax base for the Parish is 150 or below, which does not apply to any of the applications received.
- 3.3 Four requests for capital grant have been received from groups within the Town Forum area.
- 3.4 Four applications have not been recommended for support:
 - (i) Soberton Parish Council not able to support from this scheme as application is from the Parish Council and therefore not eligible for funding. Application needs to be from a properly constituted management committee.
 - (ii) St. Peter's Soberton Church Extension not able to support this scheme as church groups are not eligible. Application needs to be from a properly constituted management committee.
 - (iii) Winchester Judo & Martial Arts Club an application was received from this group for an extension to the building owned by the Winchester Lido Sports Association. In view of the application below requesting a grant for the same building concerns were raised about the viability and appropriateness of this project.
 - (iv) Winchester Lido Sports Association this application is for external redecoration and therefore is not eligible within the capital grant scheme. This organisation is to be encouraged to submit a more coherent application for the 2009-2010 capital grant scheme.
- 3.5 Chesil Theatre Application the size of this grant request means that it is beyond the scope of the community capital grant scheme. This application will be passed to Cultural Services for further evaluation and a report will be submitted to Cabinet in due course.

OTHER CONSIDERATIONS:

4 <u>CORPORATE STRATEGY (RELEVANCE TO)</u>:

- 4.1 The priority areas for capital grant funding are in line with the Winchester City Council Corporate Strategy 2007 2012, and the Winchester District Community Strategy (updated March 2007).
- 4.2 The community capital grants scheme helps address many of the Council's priorities for the District and in particular those under Health and Wellbeing, and Inclusive Societies.

4.3 The provision of grants to village halls and recreational facilities is authorised by S 19 Local Government (Miscellaneous Provisions) Act 1976.

5 RESOURCE IMPLICATIONS:

- 5.1 The recommendations in this report demand a total capital commitment of £97,560.
- 5.2 The proposed capital programme allocation for grants in 2008/09, which will be decided upon as part of the budget consideration taking place elsewhere on the agenda for this meeting, is £80,000 but support all of the recommendations within the report can be met using the carry forward of £17,560 of unspent grant in 2007/08. Detailed debate on the resource issues is included in Section 2 of this report.
