#### **WHEREAS**

- (A) The Original Consortium Members entered into a grant agreement with the Agency dated 22<sup>nd</sup> November 2017 (the **Grant Agreement**) as the same may be varied amended or supplemented in accordance with its terms in connection with inter alia the delivery of affordable housing pursuant to the Shared Ownership and Affordable Homes Programme 2016-2021.

# 1. **Interpretation**

## Observance

- 2.1 The Incoming Consortium Member confirms that it has been given a copy of the Grant Agreement.
- With effect from the date of this Deed (the **Effective Date**) the Incoming Consortium Member agrees to observe adhere to perform and be fully bound by all of the provisions of the Grant Agreement in all respects as if it were an original party to the Grant Agreement and was referred to therein as a Grant Member [and as the Incoming Consortium Member will assume the role of Lead Partner, it also agrees to observe adhere to perform and be fully bound by the obligations of the Lead Partner under the Grant Agreement].

## 3. Further assurance

The Parties shall do all such acts and things as shall be necessary to give effect to this Deed.

# 4. Governing Law and Jurisdiction

This Deed shall be governed by and construed in accordance with the laws of England and the parties submit themselves to the exclusive jurisdiction of the English Courts.

# 5. Contracts (Rights of Third Parties) Act 1999

A person who is not a party to this Deed shall have no rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any of its terms.
