# 150. **COMMUNICATION FROM THE LEADER**

The Leader reported that a meeting of the South East England Regional Assembly (SEERA) would be held on 13 July 2005 in the Winchester Guildhall and would be open to Councillors and the public to attend. In addition, she advised that SEERA were recommending a level of growth of 4,000 dwellings per year in the 'South Hampshire' region and 800 dwellings per year in the 'Rest of Hampshire' area. Further details were set out in Report CAB1104 which was considered by Cabinet at its meeting on 29 June 2005.

The Leader also reported that the new Customer Service Centre at the Council's City Offices was now open and had received positive feedback from customers.

# 151. ANNUAL SCRUTINY REPORT 2004/05

Councillor Allgood addressed the meeting as Chairman of Principal Scrutiny Committee and author of the Report. He summarised the work that had taken place over the year and thanked the Members and officers involved.

# 152. <u>EXTRACTS FROM MINUTES OF CABINET AND PRINCIPAL SCRUTINY</u> COMMITTEE

(Report CL31 refers)

It was reported that the Report set out the recommended minutes from Cabinet on 20 April 2005 and 1 June 2005 and from Principal Scrutiny Committee on 6 June 2005 for consideration by the Council. However, each Minute was supported by an additional Council report which should be considered in conjunction with the Minute as appropriate.

## 152.1. THE HOUSING OPTIONS APPRAISAL

(Reports CAB1071 and CL30 refer)

It was advised that as there were no amendments to the text of the Appraisal report, the version circulated with the Council agenda was the same as that considered by Cabinet on 20 April 2005. Therefore, the recommendation before Council was as set out in Report CL31 subject to the deletion of the words in the first recommendation "..subject to any amendments as a result of the process outlined in resolutions 1 and 2 below" and formally noting the contents of the additional supporting information contained in Report CL30. The full text of the composite recommendation was therefore as follows:

- " 1. That the Housing Options Appraisal be approved for submission to the Government Office for the South East.
- 2. That the Council approves a retention strategy for its housing stock and commits to repeating a detailed review of housing options in three years.
  - 3. That the contents of Report CL30 be noted."

At the request of the Mayor it was agreed that Council Procedure Rules be suspended to enable two representatives of TACT to address the meeting.

In summary, Mr C Gilbert-Wood and Mr A Rickman (TACT) outlined the work undertaken under the Housing Options Appraisal and emphasised that 95 per cent of the tenants who had responded had indicated that they wished the Council to retain control of its housing stock. They also acknowledged that more work would be necessary when a further detailed review of housing options was undertaken in three years time.

It was moved by the Portfolio Holder for Housing, Councillor Hiscock, and seconded by Councillor Mitchell, that the composite recommendation as set out in Report CL31 and amended above, be approved and adopted.

## 152.2. **PERFORMANCE PLAN 2005/06**

(Reports CAB1086, CL28 and Addendum refer)

It was reported that the text of the Performance Plan was amended to that included within Report CAB1086 and the revised text was as set out in Report CL28.

It was further reported that subsequent to the publication of Report CL28, a number of corrections and amendments had been requested and these were set out in the Addendum to Report CL28 which was been circulated at the Council meeting. The Addendum had not been made available for publication within the statutory period, but the Mayor agreed to accept it onto the agenda, as a matter requiring urgent consideration, in view of the need to publish the Plan by the Government set deadline of 30 June 2005.

It was moved by the Chairman, Councillor Campbell, and seconded by Councillor Higgins that the revised Performance Plan 2005/06, as set out in Report CL28 and Addendum, be approved and adopted. In addition, that the Chief Executive, in consultation with the Leader, be authorised to make any minor textual amendments found necessary on final checking. The full text of the composite recommendation was therefore as follows:

- 1. That the Performance Plan 2005/06, as appended to Report CL28 and amended in the Addendum to CL28, be approved and adopted.
- 2. That the Chief Executive, in consultation with the Leader, be authorised to make any minor textual amendments found necessary on final checking."
