3. <u>APPOINTMENT OF INDEPENDENT MEMBERS AND PARISH REPRESENTATIVES TO THE STANDARDS COMMITTEE</u>

The City Secretary and Solicitor reminded the meeting that Council (on 28 February 2007) had established the Special Committee, to consider applications to serve as Independent Members and Parish Representatives on the Standards Committee for the 2007/08 and 2008/09 Municipal Years. The Special Committee was requested to submit recommendations on those appointments to Council on 18 April 2007. It would also be helpful if the Committee submitted a further recommendation which nominated one of the Independent Members to act as Chairman of the Standards Committee.

Appended to the above report were the applications received for both roles.

The Committee was informed that, from the current representation, Mr John Spokes (Independent Member and current Chairman of the Standards Committee) and Mr Geoffrey Sharman (Parish Representative) did not wish to seek reappointment for a further term.

With regard to the composition of the Standards Committee, the City Secretary and Solicitor reminded the meeting that the Council had adopted the guidance from the Standards Board for England and appointed an Independent Member as Chairman of the Committee.
