1. FUTURE MEETING DATES AND TIMES

RESOLVED:

2. MINUTES

Cabinet noted a correction to Minute 6, "Inclusion Cohesion and Equality Report" (CAB1457) of the 11 April 2007 meeting, where Councillor de Peyer was referring to the effects of educational *deprivation*.

RESOLVED:

That subject to the above correction, the minutes of the previous meetings held on 28 March 2007 (less exempt items) and on 11 April 2007, be approved and adopted.

3. **PUBLIC PARTICIPATION**

Mr A Rickman made a statement on behalf of himself and David Cruden as Chairmen of TACT. He stated that TACT's aims continued to be to retain the Council as landlord, remove negative subsidy from the Housing Revenue Account, and build new Council homes. TACT looked forward to working with the Council to achieve these aims.

On behalf of Cabinet, the Chairman thanked TACT for their contributions and welcomed the opportunity to continue to work together in the future.

Mr A Weeks spoke on behalf of the Winchester City Residents' Association on a number of issues concerning the use of Open Space funds for the Bar End Athletics Track, as summarised below. He expressed concern that the funding of this scheme would not leave any Open Space monies available for other projects within the town area. He believed that the University of Winchester would have gone ahead with the scheme without Council funding.

The Chairman corrected a number of the statements made by Mr Weeks, confirming that the University would not have progressed the Bar End Athletics track scheme without Council funding. The decision to proceed with the scheme had been supported by Town Ward Councillors from all parties, when the matter came before the full Council. In addition, Cabinet noted that should other appropriate schemes come forward which required funding, the Council had committed to find monies from alternative sources.

5. LEADER AND PORTFOLIO HOLDER ANNOUNCEMENTS

Councillor Wood advised that the Planning Division were moving offices from Avalon House to Colebrook Street. In addition, during May the Division had achieved its targets regarding dealing with planning applications within a specified time and the number of complaints had greatly decreased. Cabinet requested that congratulations on these achievements be passed on to the appropriate staff.

Councillor Stallard reported on the Winchester District Sport and Physical Activity Alliance (SPAA), a joint initiative which had been formed as part of the Sport Development Strategy with other organisations, including the University. The Winchester District SPAA Website was now live.

Councillor Beckett advised that he had written to the Post Office expressing concern about the planned closure of the Winchester Central Post Office, and the lack of consultation on the proposals that had been carried out so far.

Councillor Allgood reported that the new Members' Rooms were operational in the Guildhall and thanked the staff involved for their work in achieving this.

6. SCRUTINY REVIEW – GERSHON EFFICIENCY SAVINGS

(Report CAB1463 refers)

Cabinet noted that the Report contained a recommendation that the Portfolio Holder with responsibility for performance, also be given the responsibility of driving forwards the efficiency programme. Councillor Allgood advised that each Portfolio Holder had responsibility for overseeing efficiencies in their area of work and he considered this was the best arrangement, with overall responsibility remaining with the entire Cabinet. Councillor Hollingbery agreed and added that his responsibilities included ensuring relevant and timely information was available to Portfolio Holders.

Cabinet therefore decided that Recommendation 1b) of the Report be not agreed. Cabinet also agreed that the Portfolio Holder for Finance and Resources be included in the consultation in recommendation 1c).

At the invitation of the Chairman, Councillor Higgins expressed concern that the Report contained insufficient detail.

Councillor Beckett advised that additional information was contained in Report PS281 (Scrutiny Review – Gershon Efficiency Savings) which was considered by Principal Scrutiny Committee on 26 March 2007.
