The Leader emphasised that it was only the parent company which had been placed into administration and this was as a direct result of the current economic recession. The risks had always been clearly identified and there was no action which the Council could have taken to prevent the present situation. It did not mean that the regeneration of the Silver Hill area would not happen at some stage and all options would now be reviewed to identify the best way forward.

The Leader then reported that the Council had, earlier that day, approved an agreement with East Hampshire District Council to procure a joint waste contract. This was a ground-breaking decision and would secure operational and financial benefits for both authorities.
