The Chairman of the Overview and Scrutiny Committee, Councillor Chamberlain, moved that Recommended Minute 113 be approved and adopted.

5. **NOTICE OF MOTION**

The following Notice of Motion had been submitted by Councillor Cook:-

"That this Council remove the Strategic Housing Land Availability Assessment (SHLAA) designation from green field land when it can be demonstrated that it is in the public interest for such land to be used for public recreation or sport or where it can be demonstrated that such land is not required to meet the agreed housing targets."

The motion was seconded by Councillor Mitchell.

At the invitation of the Mayor, Councillor Cook addressed Council in support of his Motion and, in summary, made the following points:-

- (a) the SHLAA process of inviting landowners and developers to submit sites which they considered were suitable for development inevitably created 'hope value' and, consequently, purchase prices for those sites rose because of the expectation of gaining planning permission
- (b) that situation had occurred in New Alresford, where the price that the owner was seeking for land which the Town Council wanted to purchase as playing fields, had increased to an unaffordable level because of the owners perception of 'hope value' due to the SHLAA submission. Such a significant increase in price could also influence the City Council in considering a related Compulsory Purchase Order request, because apart from the cost of the CPO process itself, it was evident that the Town Council could not afford the land at anything approaching the 'hope value' figure.
- (c) advice from the Council's Head of Legal Services confirmed that the SHLAA process conferred no lawful designation or special status on suggested sites, merely a recognition that the land was potentially available for housing development. Therefore the Council could, if it so wished, remove that designation from the New Alresford site at this meeting.
- (d) the New Alresford case provided a good example of how this practice may impact on other areas of the District and therefore the Council should reconsider its position, with a view to removing the SHLAA designation in appropriate cases.

At this point, Councillor Power declared a personal and prejudicial interest in those matters raised by Councillor Cook which related to New Alresford Town Council and left the meeting for the remainder of this item.

During debate, the situation regarding New Alresford was noted, but it was generally agreed that the SHLAA designation process (which had to be undertaken as part of the South East Plan) was an important issue which needed to be considered in a District-wide context. How the Council moved from the SHLAA

'long list' of developer/landowner suggested sites for development to (if and when required) an acceptable short list, was a key aspect of an ongoing process which would inform the next stages of the Core Strategy.

At the conclusion of debate, the Council agreed that the matter would benefit from further clarification and therefore a report should be prepared for consideration by the Cabinet (LDF) Committee.

RESOLVED:

That the Notice of Motion be referred to a future meeting of the Cabinet (LDF) Committee for consideration, with a request that it make recommendations back to Council.
