#### EXECUTIVE SUMMARY:

At its meeting on 5 December 2012, Cabinet considered a report (CAB2407) concerning the calculation of the draft Council Tax Base for 2013/14. At that time the Tax Bases for the parishes and the Town had not been calculated as further clarification and regulations were expected.

Cabinet instructed officers to present an update report to Council to present the final Council Tax Base calculation once the relevant regulations had been published. The regulations have now been published.

The final Council Tax Base for the District is confirmed as 45,392.95. Detailed information is contained in the Cabinet report (CAB 2407). The Tax Base for the District is shown in this report at Appendix A and the relevant amounts for the parishes and the Town are contained in Appendix B.

Under the current initiative to streamline decision-making processes, Cabinet agreed that given the technical nature of the Tax Base calculation, in future, it should be delegated to officers.

# RECOMMENDATIONS:

- That in accordance with the Local Authorities (Calculation of Tax Base) (England) Regulations 2012, the amount calculated by Winchester City Council for the year 2013/2014 is 45,392.95 properties at Band D equivalent (Appendix A).
- 2. That the amount calculated as the Council Tax Base for each Parish within the area of Winchester City Council and for Winchester Town shall be as stated in Appendix B to this report.
- 3. That the Scheme of Delegation to Officers (as set out in Part 3, Section 6 of the Council's Constitution) be amended to enable approval of the Council Tax Base in future years to be delegated to the Head of Finance in consultation with the Head of Revenues.

# OTHER CONSIDERATIONS:

The detail of the Tax Base calculation is as explained in the Cabinet report (CAB2407). One figure has been changed in Appendix A of CAB2407. The CTS Band D figure has been changed from 3,799.16 to 3,788.59 to more accurately reflect the impact of the estimated Council Tax Support expenditure on the Tax Base. This change affects the final Tax Base figure which has changed from 45,393.01 to 45,392.95.
