1. **COMMUNICATIONS FROM THE MAYOR**

The Mayor referred to Queen's Birthday Honours List and announced that letters of congratulation would be sent to the following people who lived or worked in the District:-

3. <u>DISCLOSABLE PECUNIARY INTERESTS</u>

Having regard to their roles as Hampshire County Councillors, Councillors Humby, Huxstep, Mather, Stallard and Tod each declared a disclosable pecuniary interest in any matter on the agenda which may have a County Council involvement. Councillor Godfrey made the same declaration due to his role as a County Council employee as did Councillor Thacker, whose husband was a Hampshire County Councillor. However, as there was no material conflict of interest, they all remained in the room under the dispensation granted on behalf of the Standards Committee, to participate and vote in all such matters.

Councillor Gottlieb declared a personal, but not prejudicial interest in matters on the agenda that relate to the Silver Hill development proposals due to him being a member of the Winchester Deserves Better campaign group.

The Chief Operating Officer explained that a letter from Solicitors acting on behalf of Councillor Gottlieb dated 18 June 2015 had been circulated to the meeting. The letter referred to the likelihood of legal action being taken against the Council. Councillor Gottlieb was advised that he should consider whether at such time during the meeting that the Council may wish to consider its response to the letter, it would not be appropriate for him to remain in the meeting, but the need did not arise.

5. REPORT FROM THE LEADER ON THE TERMINATION OF THE DEVELOPMENT AGREEMENT DATED 22 DECEMBER 2004, BETWEEN THE COUNCIL AND SILVERHILL WINCHESTER NO 1 LTD (PREVIOUSLY KNOWN AS THORNFIELD PROPERTIES (WINCHESTER) LTD).

Report CL110 was circulated with a Supplementary Agenda after the statutory deadline. The Mayor decided to accept the Report onto the agenda, because of the urgent need for Council to consider the matter in advance of meetings of Cabinet, The Overview and Scrutiny Committee and Council. The Mayor also clarified that should there be a need to take advice in exempt session, it was proposed to move back into open session for the debate and final decision.

The Chief Operating Officer drew attention to additional documents circulated to the meeting. These were letters from Solicitors acting on behalf of Councillor Gottlieb. The first letter was dated 17 June 2015 and included a previous letter appended, which was dated 20 May 2015. Further correspondence had been received today (18 June) from the Solicitors in response the circulation to Members of an Opinion obtained by the Council from David Elvin QC and Richard Moule dated 17 June which had also been circulated to Members.

The Mayor agreed that Council should adjourn to allow Members to familiarise themselves fully with the information in each of the three documents, although the majority had been circulated electronically in advance of the meeting.

Council reconvened and the Leader moved that the Recommendation in Report CL110 be approved and adopted. The item was seconded by the Deputy Leader, Councillor Weston. The Leader introduced the Report.
