1. **MINUTES**

RESOLVED:

That the minutes of the Ordinary Meeting of the Council held on 11 January 2017, be approved and adopted.

2. **COMMUNICATIONS FROM THE MAYOR AND THE LEADER**

The Mayor informed the meeting that she had received many nominations for people who deserved to be recognised for the work they performed in the community, through the Mayor's Awards for 2017/18. The event would be held in the Bapsy Hall, Guildhall on Wednesday 29 March 2017 at 6pm.

The Mayor also referred to her various Charity events. On Saturday 25 February, there was the Rotary Swimathon, with a Wine Tasting event in

Abbey House on Friday 24 March. A Concert with the St Swithun's Girls' Choir was to be held on Saturday 29 April. The Mayor's Charities website contained details of all events and was also where the Mayor could be sponsored for her two special events on 30 April and on 5 May.

The Leader announced that the Council's Local Plan (Part 2) had been found to be sound by the Planning Inspector. Following its adoption, the Plan will provide a comprehensive suite of policies to help guide development, providing more certainty for residents and businesses. The Council had an agreed five year supply of land for housing. The Leader thanked the Head of Strategic Planning and other officers for their work in developing the Local Plan.

The Leader also announced that, last week, the Council had received the Gold Standard Award for local Homelessness Services. Winchester was the first Council in Hampshire and only the fifth in England to have received the award. The Leader congratulated the Housing Options team for its dedication and hard work.

3. **DISCLOSABLE PECUNIARY INTERESTS ETC**

Having regard to their roles as Hampshire County Councillors, Councillors Humby, Huxstep, Mather, Porter and Tod each declared a disclosable pecuniary interest in any matter on the agenda which may have a County Council involvement. Councillor Godfrey made the same declaration due to his role as a County Council employee as did Councillor Thacker, whose husband was a Hampshire County Councillor. However, as there were no material conflicts of interest, they all remained in the room under the dispensation granted on behalf of the Standards Committee, to participate and vote in all such matters.

As the owner of the St Clements Surgery, Councillor Gottlieb advised that he would declare a disclosable pecuniary interest and leave the Council Chamber if there was any specific discussion during the meeting that related to the building.

being the amount by which the aggregate at 4(a) above exceeds the aggregate at 4(b) above, calculated by the Council in accordance with Section 31A(4) of the Act, as its Council Tax requirement for the year. (Item R in the formula in Section 31B of the Act).

(d) £210.24

being the amount at 4(c) above (Item R), all divided by Item T (2(a) above), calculated by the Council, in accordance with Section 31B(1) of the Act, as the basic amount of its Council Tax for the year (including Parish Precepts).

(e) £3,596,450

being the aggregate amount of all special items referred to in Section 34(1) of the Act (as per the attached Annex 2)

(f) £134.99

being the amount at 4(d) above less the result given by dividing the amount at 4(e) above by Item T (2(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no special item relates.
