#### 1. Application

**Applicant:** Coral Racing Ltd

**Premises:** 57 Stoney Lane, Weeke, Winchester

- 1.1 This application is for the grant of a Provisional Statement under Section 204 of the Gambling Act 2005.
- 1.2 The purpose of the application is for the premises to be converted from a video shop into a betting shop, and allow the applicant to apply for a Premises Licence after the work is completed.
- 1.3 Notice of the application was displayed outside of the premises for a period of 28 days until 27 June 2007, and advertised in the Hampshire Chronicle on 5 July 2007.
- 1.4 Coral Racing Ltd has applied to the Gambling Commission for an Operator's Licence under the Act.
- 1.5 There have been no representations from the Responsible Authorities, however there have been a large number of representations from Interested Parties relating to the objective concerning the protection of children and other vulnerable persons from being harmed or exploited by gambling. These representations are shown at Appendix 2.
- 1.6 In light of the representations, Coral Racing wrote to the Interested Parties on 29 August 2007. A copy of this letter is shown at Appendix 1 with the application.
- 1.7 Some of the representations have been discounted as they were not relevant, or the party does not reside in the vicinity of the premises. There are eight relevant representations attached to this report.
- 1.8 A Provisional Statement ensures that a Premises Licence will be granted with the mandatory and default conditions, and any additional conditions. Representations for such a grant can not be considered unless they could not have been made at the time of the application for the provisional statement.
- 1.9 Notices of hearing were sent to all parties on 23 August 2007.

#### 4. Observations

The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:

- Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime,
- ensuring that gambling is conducted in a fair and open way, and
- protecting children and other vulnerable persons from being harmed or exploited by gambling.

In making its decision, the Sub-Committee is also obliged to have regard to the National Guidance and the Council's Statement of Principles.

The Sub-Committee must have regard to all of the representations.

The Sub-Committee must take such of the following steps it considers necessary to promote the Licensing Objectives:

- 1. Grant the application.
- 2. Reject the application.

#### **Human Rights**

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, necessary in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

#### 5. Conditions

Mandatory and default conditions are attached to a Provisional Statement, and transferred to the Premises Licence when granted.

These conditions are shown at Appendix 4.

The Sub Committee may also attach further conditions to address the Licensing Objectives, or exclude a default condition if requested to do so.

#### 6. Other Considerations





# Re Application for a Provisional Statement in respect of 57 Stoney Lane Winchester by Coral Racing Limited

I have been sent a copy of your representations in respect of our application by Winchester City Council's Licensing Department and I read that you have concerns regarding the protection of children and other vulnerable persons from being harmed by gambling. I fully appreciate that you may know little about Coral or the way we operate and felt it would be helpful to write to you and give you a general overview of the Company and outline the steps we take to ensure that social responsibility is at the forefront of our trading agenda.

Coral Racing Limited is part of the GalaCoral Group and is currently the third largest off course bookmaker in the UK trading 1565 shops, many in parades similar to Stoney Lane and as you would expect, given the number of outlets, some are located close to churches and schools.

A brief summary of policies already in place in all of our units to protect children and other vulnerable persons from being harmed or exploited by gambling are as follows:-

#### 1.0 Protecting minors

Coral Racing Limited operates a strict "No under 18's" policy in all of our shops. Our staff are trained to challenge those who they believe to be underage with the onus being on the customer to prove that they are 18 or over. In addition a statutory notice confirming that Under 18's are not

allowed on the premises is prominently displayed close by the entrance of all Coral shops. If a child is brought into one of our shops by a parent or guardian the regulations will be explained to the adult and they will be politely asked to leave the shop.

In addition from 1<sup>st</sup> September we will adopt the 'Think 21' scheme where anyone appearing to be under the age of 21 will be challenged by a member of staff. If an acceptable form of ID is not produced the customer will be refused service and asked to leave.

The only acceptable forms of ID bear the holders photograph and date of birth such as a Driving Licence or Passport. We will also accept identity documents that bear the PASS logo, (for example a Citizens card) providing that the card is suer has been approved by Trading Standards appears on the identity document.

Historically we have had a small number of other locations where local residents have raised concerns in respect of the potential for underage gambling and where appropriate we have taken the extra precaution, installing external CCTV in addition to the our standard specification internal CCTV. In addition local staff receive regular briefings to reinforce our policy in respect of Under 18's. We also instigate an incident book to note any instances when we have approached any person we believe may be under the age of 18 who has entered the unit. This allows the Area Manager to review the CCTV on his regular visits to the shop to ensure that any incident has been dealt with in the appropriate manner by the staff on duty. I have enclosed a plan showing the proposed layout of the shop and you will note that all betting areas and the front door are clearly visible from the counter area.

I should advise you that a copy of our application for Stoney Lane was lodged with both the Police and Local safeguarding Children Board for Hampshire and neither body has made any representation in respect of our application.

#### 2.0 Protecting the vulnerable

In October 2004 Coral was awarded the Gamcare\* Certificate of Social Responsibility in recognition of the Company's high standards of socially responsible practices.

GamCare (National Association for Gambling Care Educational Resources & Training) takes a non-judgemental approach on gambling. They do not wish to restrict the choices or opportunities for anyone to operate or engage in gambling opportunities that are available legally and operated responsibly.

GamCare is a registered charity that has become the leading authority on the provision of information, advice and practical help in addressing the social impact of gambling.

It is standard Coral practice to ensure adequate stock levels of Gamcare leaflets are maintained in the shop and that leaflets are displayed on the counter and in the shop. Staff are briefed to direct customers towards Gamcare if they ask for help with a gambling problem.

Coral Racing Ltd also operates a voluntary self-exclusion policy, whereby a customer can request to be refused entry to one or more of our shops for a period of six months. After this time the request may be reviewed and the customer can request to extend the exclusion for another period, or decide that further exclusion is unnecessary. Customer self-exclusion forms are kept on the premises at all times.

Every Coral Shop Manager attended a Social Responsibility Training Programme led by their Regional Manager in 2004. This has been repeated in 2007, prior to the change in legislation to reemphasise the importance the Company places on trading in an ethical manner.

The aim of the training is to ensure that every staff member understands their responsibilities. The recurring message of these briefings was that for a small minority gambling can become a problem and that Coral has a commitment to protect and assist that minority.

Staff are advised of the warning signs of problem gambling, for example, is the customer chasing losses, displaying anxiety or being argumentative and if they consider it safe to do so will intervene to offer Gamcare support or self exclusion.

Any incidents that take place in the shop are recorded on a Shop Register and Head Office is advised.

#### 3.0 Compliance

Premises Licences are renewed annually and the premises may be inspected by the following official bodies, Police, Gambling Commission, Local Licensing Authority, an Environmental Health Officer and Fire Brigade. Visits will be to ensure that we are complying with the Gambling Act 2005 Licensing Objectives failure to do so could result in the loss of our Premises Licence, so I am sure you will understand why we put such an emphasis on protecting children and vulnerable persons from being harmed or exploited by gambling.

I can confirm that Coral Racing Limited has held a Bookmakers Permit since 1961 and has applied for it to be converted to an Operator Licence under the Gambling Act 2005, both confirm that Coral has been thoroughly vetted and is considered a fit and proper company to operate betting shops.

Hopefully my letter will allay your fears but if I have not answered any of the concerns you have please do not hesitate contact me or conversely I would be happy meet with you discuss our application in more detail.

WEEKE PARADE OF SHOPS
CHANGE OF USE FROM VIDEO SHOP TO CORAL RACING

I wish to object in the strongest terms possible to this proposed change of use.

Wesley Methodist Church is located on the corner of Fromond Road and Stoney Lane in close proximity to the proposed betting shop. A number of our members are residents in the Orchard Walk sheltered housing complex directly opposite the shop in question. I am writing on their behalf, on behalf of the Wesley Methodist Church Council which met last night and on behalf of the local community who worship and attend a wide variety of other activities at the church

- i. The change of use changes the "local shopping parade" to a city centre shopping area. We are not opposed to the decision to build the Waitrose development but feel that the provision of a betting shop would significantly change the character of the shopping area in an undesirable way.
- ii. The change will not be helpful to the young people in the area. In Section 2 of Winchester City Council's Gambling Act 2005

  Statement of Principles, the Council states that licensing of gambling premises should have as an objective "the protection of

children and other vulnerable persons from being harmed or exploited by gambling."

The Church provides one of the few facilities for youth work in the area. There is no local authority youth work, only that which is done by Churches and Uniformed Organisations. At Wesley Church we have a Youth Club for those aged 11 and upwards and a Fun Club for ages 7 to 11. There are two Brownie packs and one Guide Company meeting regularly in our hall. We are also the venue for the Triangle Play Group which meets daily during term time. The presence of a betting shop as our closest neighbour would be a very poor example to these young people and would have a negative social impact on our community.

The Detached youth work done by "Street Reach" will certainly be affected as they seek to help and make contact with the young people who use the Weeke parade of shops as their local "social centre."

As Minister of this Church, I represent around 100 Church Members and many others who are part of our community. We oppose this move in the strongest terms possible. The Government seem to be having second thoughts on the introduction of the large Casinos and we hope the City Council will respond similarly to the proposed introduction of gambling facilities in one of the District's relatively disadvantaged areas.

I shall be sending copies of this letter to various members of the City Council.

This is, I believe, wholly inappropriate for the local area

Betting have made an application for this.

This is, I believe, wholly inappropriate for the local area

- it is close to one of the local primary schools
- the parade of shops is one of the areas where young people congregate
- the parade provides much that the local community needs and as such is very busy with all ages of people.

It is my understanding that the councils own major objective in implementing the gambling act was 'to protect children and other young people and vulnerable persons from being harassed or exploited by gambling'.

Allowing a Betting shop to operate in this vicinity would do little to meet this objective.

We already are involved in helping a number of 'vulnerable people' housed by the council on the Weeke estate to manage debt and an added 'attraction' is likely to increase these concerns and problems.



I understand that the Council's own major objective, in implementing the Gambling Act was to protect children and vulnerable people, from being exploited by gambling. Allowing a betting shop in this vicinity will do little to meet these objectives. The churches are already involved in helping a number of vulnerable people housed by the Council, on the Weeke estate, to manage debt and an added attraction is likely to increase concerns and problems.

The detached youth work done by Streetreach aims to help young people between 13 and 19 years of age. Their work will be affected, as they help and make contact with the young people, who do use this shopping parade as their main social centre. The local Churches and other organisations are working hard to try to improve facilities and be helping the young in the area. This proposal would be regarded as being detrimental.



# Mandatory conditions attaching to betting premises licences (other than track premises licences)

- 1. A notice stating that no person under the age of 18 years is permitted to enter the premises shall be displayed in a prominent place at every entrance to the premises.
- 2.—(1) Access to the premises shall be from a street or from other premises with a betting premises licence.
  - (2) Without prejudice to sub-paragraph (1), there shall be no means of direct access between the premises and other premises used for the retail sale of merchandise or services.
- 3. Subject to anything permitted by virtue of the 2005 Act, or done in accordance with paragraphs 4, 5, 6 and 7 below, the premises shall not be used for any purpose other than for providing facilities for betting.
- 4. Any ATM made available for use on the premises shall be located in a place that requires any customer who wishes to use it to leave any gaming machine or betting machine in order to do so.
- 5. No apparatus for making information or other material available in the form of sounds or visual images may be used on the premises, except for apparatus used for the following purposes—
  - (a) communicating information about, or coverage of, sporting events, including—
  - (i) information relating to betting on such an event; and
  - (ii) any other matter or information, including an advertisement, which is incidental to such an event;
  - (b) communicating information relating to betting on any event (including the result of the event) in connection with which betting transactions may be or have been effected on the premises.
- **6.** No publications, other than racing periodicals or specialist betting publications, may be sold or offered for sale on the premises.
- **7.** No music, dancing or other entertainment shall be provided or permitted on the premises, save for entertainment provided in accordance with paragraph 5.
- **8.**—(1) No alcohol shall be permitted to be consumed on the premises at any time during which facilities for gambling are being provided on the premises.
  - (2) A notice stating the condition in sub-paragraph (1) shall be displayed in a prominent place at every entrance to the premises.
- **9.** A notice setting out the terms on which customers are invited to bet on the premises shall be displayed in a prominent place on the premises to which customers have unrestricted access.

## Default conditions attaching to betting premises licences (other than in respect of tracks)

No facilities for gambling shall be provided on the premises between the hours of 10pm on one day and 7am on the next day.
