Part A.

1. Application

Applicant: Greene King Retailing Limited

Premises: The New Inn, Chapel road, Swanmore

- 1.1 This application is to vary the premises licence for the New Inn under Section 34 of the Licensing Act 2003.
- 1.2 The application is to extend the hours for the sale of alcohol and provision of live music, to add recorded music, late night refreshment, dancing, exhibition of films, facilities for making music and indoor sporting events. The times for these activities are show in the application form at Appendix 1 and Section 5 of this report.
- 1.3 The applicant also wishes to remove conditions which prohibit the provision of recorded music and prohibit children on the premises after 2100 hours.
- 1.4 The premises licence was converted from a Justices licence in November 2005. At that time, all embedded restrictions inherent in the Licensing Act 1964 were transferred to the premises licence.
- 1.5 There was also an application to vary the licence by adding live music on Saturdays, and extending the times for the sale of alcohol on Fridays, Saturdays and Sundays. This application was determined by the Licensing Sub Committee on 7 September 2005.
- 1.6 The application to vary the licence in 2005 was granted with the conditions which are attached to the current premises licence which is shown at Appendix 1.
- 1.7 This application is to add regulated entertainment by way of films and indoor sporting events from 1100 to 2300 Sunday to Thursday and to 0100 Friday and Saturday.
- 1.8 It is also to extend live music from Saturdays only, between 2000 and 2300 Sunday to Thursday and 2330 Friday and Saturday, recorded music, facilities for making music and dancing from 2000 to 2300 Sunday to Thursday and 2330 Friday and Saturday.
- 1.9 Late night refreshment is requested from 2300 to 0100 Friday and Saturday, and for the sale of alcohol from 1100 to 2300 Sunday to Thursday and to 0100 Friday and Saturday.
- 1.10 There are requests for seasonal variations for bank holidays and the days preceding them. These are detailed in the application shown at Appendix 1.
- 1.11 No representations have been received from the responsible authorities.

- 1.12 15 representations have been received from interested parties, which are shown at Appendix 3. The representations relate to current noise and disorder from the premises, and concerns relating to all four licensing objectives.
- 1.13 There are no recorded complaints of noise or disorder since the current tenant, Mr Simon Hawkins, has been in place, either on the Council's database, Police records or the 101 tasking system.
- 1.14 Notice of the application was displayed outside of the premises for a period of 28 days until 15 January 2009, and advertised in the Daily Echo on 23 December 2008.
- 1.15 Hearing notices were sent to all parties on 16 January 2009.

3. <u>Interested Parties</u>

3.1 There have been 15 representations relating to all four licensing objectives, which are shown at Appendix 2.

4. Observations

The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

In making its decision, the Sub-Committee is also obliged to have regard to the National Guidance and the Council's Licensing Policy.

The Sub-Committee must have regard to all of the representations.

The Sub-Committee must take such of the following steps it considers necessary to promote the Licensing Objectives:

- 1. Grant the licence subject to conditions in accordance with the operating schedule (modified to such extent as the authority considers necessary for the promotion of the licensing objectives) and the mandatory conditions;
- 2. Exclude from the scope of the licence any of the licensable activities to which the application relates;
- Reject the application.

Terminal hours

Crime and Disorder

The Sub-Committee should consider any necessary conditions for the Protection of Children having regard to the Operating Schedule and the observations of the interested parties.

(Licensing Policy Part 4, D6, D7)

Human Rights

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, necessary in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

5. <u>Conditions</u>

Mandatory Conditions

Under the Licensing Act 2003, the following conditions must be imposed on the Premises Licence in any event:-

- No supply of alcohol may be made under the Premises Licence (a) at a time when there is no Designated Premises Supervisor in respect of the Premises Licence, or (b) at a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence.
- 3. Where individuals are required on premises to carry out security activities, they must be licensed by the Security Industry Authority.
- 4. No film shall be exhibited unless it has received a **U**, **PG**, **12**, **15** or **18** certificate from the British Board of Film Classification, or it is a current newsreel which has not been submitted to the British Board of Film Classification. The admission of children shall be restricted in accordance with the recommendations of the British Board of Film Classification. (Additional mandatory condition)

a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)

House is set in a rural village location and has a very good standing within the community as a well run village pub.

b) The prevention of crime and disorder

Depth of local knowledge and of community is an advantage when applied to reducing crime and disorder. Trained staff shall maintain a close watch on the trading area and behaviour of customers at all times and shall either a) take appropriate action where needed or b) report concerns to their manager where they are not authorised to deal personally with an issue. Proof of age scheme. Staff trained to refer to DPS in cases of doubt. Keep to agreed capacity limits. Will not run irresponsible drinks promotions. Site has well lit garden and outside areas. DPS has a good working relationship with the Chief of Police who lives in the locality. All external walkways and car parking areas shall be illuminated during the hours of darkness up to 30 minutes after the premises close.

c) Public safety

At least one member of staff/management is a dedicated 'first aider'. House is an active supporter of local paramedics (Bishops Waltham First Responders). Review DDA policy to ensure all reasonable steps have been taken to allow disabled customers to use premises in safety. Upkeep of emergency lighting & appropriate records kept. Upkeep of fire fighting equipment; adequate staff training and appropriate records kept. Trade within recognised capacity limits and ensure adequate levels of staff to meet expected levels of trade.

d) The prevention of public nuisance

Site has an unblemished record concerning public nuisance, partly through the fact it operates as a community local but more importantly from operating as a well run establishment. This results in having no noisy mechanical equipment being sited so as to interfere with neighbours; house ensures kitchen filters are regularly cleaned in order to reduce risk of food odours. No light pollution to neighbours, or use of external speakers. Site is regularly monitored particularly garden area to ensure no instances of excessive noise or unruly behaviour. Ensures deliveries and service providers (e.g. refuse) are at such an hour as not to cause nuisance to neighbours. Whilst music is being played as part of regulated entertainment, the licensee or appointed member of staff shall check periodically that noise levels are acceptable. Such monitoring shall be carried out at the boundary of the premises to ensure that local residents are not likely to be disturbed. Regulated entertainment shall be restricted to the inside of the premises.

e) The protection of children from harm

Adhere to the Hampshire Constabulary's Challenge 21 Scheme. No unaccompanied childern shall be permitted to be in the premises. Depth of local knowledge would help prevent any apparent attempts of underage drinking, but would be backed up by a strong policy on challenging attempts through staff training and use of photo ID schemes.





With reference to the application from Greene King Retailing Limited to vary the premises license for New Inn, Chapel Road, Swanmore, SO32 2QB. I have objections to parts of the application. I have cut and pasted the text of the application and given my objections, by item. I have in the past supported this pub's application for Music and some late night opening. I even visit some Saturday nights to listen to live music. I have lived next door to this pub for 22 years and never had reason to complain. I say this to ensure you don't get the impression that I am some kind of kill joy, I have always taken the position that if you buy a house next door to a pub then a reasonable amount of noise should be expected. But recently things have significantly deteriorated. Some of the clients leaving the premises seem to have no control of the volume of their voices, or of the language they use. Recently, a person leaving the pub has damaged my front fence, and glasses are either left on my front wall (with a Greene King logo), or last Sunday even smashed on the road. I had to risk cutting myself clearing the glass from the road. So I feel I must object to the more extreme parts of this application.

Vary the hours for sale of alcohol (on and off the premises):-

- Friday and Saturday 1100 to 0100 (current hours 1100 to 0000)
 - o I object to this on the grounds of public nuisance. Some of the customers that the pub now attracts seem to have no control on the volume of their voices and the language they use when leaving the pub and walking past my house in the early hours of the morning. My daughter has been woken many times recently at well past the current closing time of 0000. On the 31st December 2008/1st January 2009 This noise and abuse continued until well after 3:00AM

- Also Public Safety. I have recently had to clear broken glass from the pavement smashed by the departing drunken clients of this pub, and my fence damaged.
- Christmas Eve, Christmas Day, Boxing Day, New Years Day, all Bank Holidays and the day preceding a bank holiday 1100 to 0100.
 - o I have no objection to this on the day preceding a bank holiday or on Christmas Eve. - New Years Eve 2000 to 0030
 - o Reasonable request

To add late night refreshment (indoors only):-

- Friday and Saturday 2300 to 0100
 - o 0000 is reasonable for closing on normal Fridays and Saturdays. As the pub never actually closes for 30 minutes to an hour after it should anyway! But I object to the later hours on the basis of public nuisance for reasons stated above
- Christmas Eve, Christmas Day, Boxing Day, New Years Day, all Bank Holidays and the day preceding a bank holiday 2300 to 0100.
 - o I have no objection to this on the day preceding a bank holiday or on Christmas Eve.  - Twenty-four hours opening is totally unacceptable to me. I don't want this to be the pub everyone comes to, to binge drink when other pubs have closed their doors. Some of the customers that the pub now attracts seem to have no control on the volume of their voices and the language they use when walking past my house. My Daughter has been woken many times recently at well past the current closing time of 0000.

To remove the following conditions from the current licence:-

- No recorded music shall be played at the premises at any time.
 - Provided this music is played at a reasonable volume, through the pub's stereo, I have no objections to this. If it means loud discos potentially seven days a week, then I object on the grounds of public nuisance
- No children shall be permitted to be on the premises after 2100 hours.
 - Protection of children, and public nuisance, if the premises include the garden. As it is, in the summer, people drink in the pub, leaving their children to play unsupervised in the garden. I am writing in connection to the application by Greene King Retailing Limited to vary the premises licence for the New Inn Pub in Chapel Road Swanmore.

For information I live two doors from the pub at The Retreat Chapel Road and we share the rear boundary with the pub garden.

My representations, for requesting this application is refused, are as follows

• Public Nuisance

Even with the current hours we are experiencing disruption and disturbance from the pub goers standing at the front of the pub smoking and shouting. This increases towards the end of the evening and is particularly bad just after closing time and lasts regularly for up to an hour after closing. This is particularly disturbing as our childrens bedrooms are at the front of the house and they are continually woken up by shouting and foul and obscene language and car doors slamming loudly. We believe that people leaving the pub have not in any way been encouraged to do this considerately by the Landlord.

We feel that if the proposed extensions were granted this would get much worse in what is a very peaceful residential village road. Also please note that prior to the current landlord's tenancy we have never experienced any such problem in the 12 years we have lived next to the New Inn.

· Public Safety

Chapel Road is a small, quiet village road and it is now regularly congested by poorly parked cars from people visiting the pub, which causes obstruction to residential properties and a potential hazard to pedestrians and vehicles.

There has also been a marked increase in the amount of broken glasses and bottles strewn around the front of the pub and in the close vicinity including my drive and pavement in front of the house.

Public Disorder

There have been a number of occasions where clients leaving the pub have been involved in loud arguments and confrontations. We believe that increasing the amount of time alcohol is served in the pub will only increase these incidences.

General Comments

- I understand that the current Landlord is required to post notice of this application in a visible place, however he has failed to do so. I only found out about it by chance and not through the appropriate routes.
- o The current Landlord is in fact already flouting some of these application requests by continually having live music played well after the licensed hours.
- Previous Landlords have always been reasonable and considerate and have responded to any request to curb excessive noise. However the current Landlord seems to be unaware that his pub in a wholly residential area and he does not take in to account the needs of the surrounding community.

In summary I firmly believe that a village pub is an essential part of village life on the condition it is in keeping with its locality. Allowing these proposed changes to the Licence will only increase the likelihood of public nuisance, crime and disorder and detrimentally affect public safety.

We wish to enter our concerns with regard to the recent application by Greene King Retailing Ltd for a variation to the licence at the above establishment. We do so with a significant amount of regret, having previously written in support of changes to the licence when an application was made in 2005 (copy attached). You will see from that letter that there were significant provisos to that support. Unfortunately, since the relatively recent change of tenancy these concerns have become all too relevant and form part of the justification of our objection on each of the 4 allowed grounds.

It may be questioned as to why until very recently there have been no formal complaints about the premises when there are now objections to the application for the change in license. In order to explain this, we believe that, like the majority of local people who have valued the community value of a village centre pub, that complaints should not be made frivolously and, indeed, there have been very few occasions until recently when it had been necessary to consider doing so. When those very rare occasions have occurred these have been readily resolved with the landlord.

Below are representations for each licensing objective:

Public Nuisance: The frequency and, more particularly, the volume of the music that has emanated from the pub has now got to the point where even with all of our windows shut we cannot hear our television or music at levels that we consider acceptable, it is frequently significantly louder than a lawnmower (which operates at the level of 90 – 95 decibels). It has on occasions actually woken our 8 year old daughter; a point I made during the one conversation I have had with the landlord, whose response, whilst sympathetic, was that he didn't think the noise had been that bad. In an old building with small rooms not designed for music which undoubtedly do not have modern levels of sound insulation and single glazed windows, the obtrusiveness of the volume in a village centre, surrounded by houses, is entirely inappropriate.

Even worse than the volume of the music is the noise made by rowdy, loud customers who congregate in the car park, frequently using offensive language, often directly under our window as we, and our children try to sleep. I appreciate that the ban on smoking inside has created a potential issue, but the fact is that this occurs regularly and goes on long after

closing time due to customers congregating in the car park. Again, when I had my conversation with the landlord on the 4th night running of disturbance, although he apologised, the point was made that he hadn't realised how disruptive his customers had been. No remedial action appears to have been taken to eliminate this nuisance.

The application to vary the hours for the sale of alcohol, vary the hours for live music, add films and indoor sporting events, add recorded music, facilities for making music and facilities for dancing and add late night refreshment will undermine this licensing objective..

Public Safety: Our concerns centre on 3 factors. Firstly, Chapel Road is a narrow, not particularly well lit road. Increased numbers of parked cars late at night must increase the potential for traffic incidents. Secondly, since the average age of the clientele has reduced significantly there has been a regular incidence of broken glass in both the road and on the pavements on Sunday mornings. It may be questioned as to whether these originate from within the New Inn, but Greene King Glasses are, presumably, more likely to come from a Greene King pub? Photographs of glasses left on neighbours walls can be supplied if required. Finally, the age and alcohol intake of some of the customers must give rise to concerns about safety.

The application to vary the hours for the sale of hours, vary the hours for live music, add films and indoor sporting events, add recorded music, facilities for making music and facilities for dancing and add late night refreshment will undermine this licensing objective.

Protection of Children: The removal of the current limitation of times for children being present in the pub, whilst at the same time altering the target clientele seems likely to encourage under 18s to both be present and attempt to obtain alcohol. Even if, as I am sure is the case, the landlord is extremely vigilant about underage drinking, there must be the potential for some "children" obtaining alcoholic beverages. The offensive nature of some of the language used by customers must also be a concern for children using the premises.

The noise and, prospect of this occurring 7 days a week and until later times, also does nothing to protect my children (aged 8, 13, 15). Having their sleep disturbed would not offer any protection to them!

I also believe that the Hampshire Police local plan for the Meon Valley aims to reduce underage drinking or the potential for it. The removal of this restriction seems to fly in the face of this aim.

The application to vary the hours for the sale of hours, vary the hours for live music, add films and indoor sporting events, add recorded music, facilities for making music and facilities for dancing and add late night refreshment will undermine this licensing objective.

Prevention of Crime or Disorder: Having spoken to other householders in the vicinity of the New Inn, I know that we are not the only ones to have raised the issue of disorder from customers leaving the premises with the landlord. Loud, offensive language being shouted down the street late at night is disorderly behaviour. The extra opening hours, which must be aimed at either keeping customers inside drinking, both longer and later, or attracting customers from establishments that have closed earlier, must increase the potential for disorder. The broken glass issue also seems associated with disorderly behaviour.

The application to vary the hours for the sale of hours, vary the hours for live music, add films and indoor sporting events, add recorded music, facilities for making music and facilities for dancing and add late night refreshment will undermine this licensing objective.

I would refer you to the Meon Valley Safer Neighbourhoods team page of Hampshire Police website. It states:

Meon Valley Safer Neighbourhoods three top priorities are:

- · Vehicle related matters
- · Antisocial behaviour
- Criminal damage.

It goes on to mention:

- Tackling the areas of concern which affect quality of life for local residents.
- Tackling underage drinking and nuisance youths, particularly in Bishop's Waltham and Swanmore.
- Identification of 'Hotspots' such as the bus shelter in the Square at Bishop's Waltham.

Having lived next door to the New Inn for 10 years quite happily, having enjoyed the facilities and benefits that the pub has bought to the village, it is upsetting to have to raise these issues. However, the prospect of the disruption to our lives, and that of our neighbours, (most of whom, like us, have lived happily close to the pub for many years) becoming even worse is not something that we want to contemplate. The extension of the period of noise that we would have to put up with is not a prospect that we look forward to.

I hope that you will consider our comments carefully and that you come to the conclusion that as much as we, and our neighbours, would like the pub to be a successful, thriving place, it cannot be at the expense of the quality of the lives of those surrounding it. In conclusion, we would ask you to consider the comments made in similar circumstances by Birmingham City Council licensing authority in August of 2008 with regard to Public Nuisance who commented: "Public nuisance should have the common law meaning i.e. it is a nuisance which should affect 'the reasonable comfort and convenience of a life of class of Her Majesty's subjects"

Dear Sirs,

I am writing with regard to the application for the new license for the public house next door to my family home. I would confirm that generally there are very few instances of noise being a nuisance or there being any behaviour on the part of customers that could, in any way, be deemed to be anti social. Of course, there is the occasional over exuberant client who cannot resist calling goodnight to their fellow customers, but these instances are few and far between.

The only occasions that can cause the slightest upset to my family (there are 5 of us, including 3 children of 5, 9 & 12) is when the music held at the weekends is louder than normal. In most instances this is during the summer months when we, and the pub, have windows and doors open. This occasional disturbance never goes on beyond 11.00 pm and I am lead to believe that there is no intention for the music to become either more frequent nor carry on for extended hours.

As long as the hours for entertainment remain as suggested and levels of intrusion do not increase, I would have no objection to the licensing hours being extended to midnight. As we have both a reasonable landlord, who would respond to any request to curb excessive noise and, I presume, the opportunity to object should the circumstances change and the levels of disturbance become unreasonable, I have no objection to the request for a new altered licence.

The pub has been a centre for village life for a significant number of years. Most of the customers appear to be local people who themselves would object to excessive noise and bad behaviour. As such they generally respect the neighbours in the way that they would expect for themselves. It would be a shame if unreasonable objections could in any way impinge on the ability of the establishment to continue trading.

I refer to the above application.

Whilst we do not wish to prove obstructive, especially in the current economic climate, we do have concerns regarding the application to vary the premises licence at The New Inn Pub in Swanmore and therefore write to express these views.

Our first complaint is that we only recently became aware of the application, the notice being displayed in the window of the pub, resembling from the pavement a menu or the like, and certainly not obvious. We could easily have missed the application and not had the opportunity to express our views.

The pub is situated just four properties down the road from us. When the pub plays live music we can hear it quite clearly from our house. Currently this only occurs a couple of times a month, and only on Saturdays and the music always finishes by 11.30pm. However we do find it a nuisance and we have to ensure that bedroom windows (especially in our children's rooms) are closed. We would be very disappointed if the licence was extended such that the pub was able to play loud music more regularly. Our children are not yet of school age, however

we fear that if the licence was granted to enable live music to play during the week, it could be particularly disruptive.

Our greatest concern is that by extending the hours for sale of alcohol until 1am on Friday and Saturday evenings there could be increased noise and disorder in the early hours of the morning. We have a young family and have to protect our children's interests.

As a resident living in close proximity to the New Inn and as someone who has been a regular customer of the pub I wish to make representation with regard to this application.

Public Nuisance:-

The request for longer opening hours, the playing of more live music and the proposed introduction of recorded music only confirms the impression that the New Inn wishes to change its nature from that of a village public house to more of a night club.

I would be opposed to the lifting of the restriction on recorded music at any time. (Disco music?)

Opening until 0100 lends itself to attracting people who have already been drinking in other pubs in the area who continue to close at the "normal" closing times.

The coming and going of cars and people after midnight and the playing of late-night music can only cause noise disturbance in what is a residential area of family housing. This will be particularly pertinent in the summer months when both house and pub windows are open.

Protection of Children ;-

It would seem highly inappropriate to remove the restriction which at present permits children to be on the premises until 2100 hours both on moral and safety grounds.

Within the pub there is no facility for a family area. Children playing outside in the garden late in the evening will be a nuisance to neighbouring residences. The safety of the children both in the garden and the car park must be a major concern.

The request for extending the permitted hours on New Years Eve to allow all night opening would appear to be extreme.

We are writing to object to the application to:

- Vary the hours of sale of alcohol from 1100 to 2300
- Vary the hours for live music to 23.30
- Add films and indoor sporting events to 0100
- Add recorded music to 2330
- Add late night refreshment to 0100
- Remove from the licence the playing of recorded music and not permitting children to be on the premises after 2100

The New Inn sits in a residential area of Swanmore on a narrow road, surrounded by houses. Our objections to this application are based on the following concerns:

Public safety

We frequently find empty beer glasses and bottles left in the hedges, in neighbouring gardens and in the road after closing time at the New Inn. Those on the road get smashed by the traffic and several times we have cleared up broken glass from the gutter and pavement outside our house. Children walking to the local primary school along Chapel Road are at risk of injury.

Public nuisance

There has been an increase in the frequency of live music at the New Inn and while this is tolerated during the winter months, it is a nuisance during warmer months when windows and doors are open and people like to sit in their gardens. There are often brawls outside the New Inn at closing time with associated noise and bad language. This is a nuisance to the residents (some with young children) who live in Chapel Road.

Since the car parking on site is limited, visitors to the New Inn park along the road, often blocking the drives of local residents, reducing visibility and safety and the ability to get in and out. There is also a considerable noise when

visitors leave the pub to go home, slamming their car doors and carrying on loud conversation, often with bad language.

• Protection of children

We do not see the need for children to be on the premises after 2100 and in view of the increasing likelihood of brawls and fights, they are at risk of injury if present. Children, whether they are on the premises or in neighbouring houses.should not be subjected to the bad language that often ensues between customers at closing time.

We also voice our concern that the New Inn did not see fit to inform local residents of this application nor was it forthcoming from Winchester City Council, making it look as if there is collaboration between them in order to get this application approved without the knowledge of local residents.



We are extremely concerned to learn of the proposed alterations to the licensing arrangements at the New Inn. As near neighbours we wonder why we have not received any notification of this and only discovered this was being proposed when another neighbour found the application on a website?

The New Inn is a small pub with little room for anything other than a bar, pool table and a few tables for food to be served. It is situated in the middle of a residential area and is already causing the following problems:

- 1 Rowdy behaviour from smokers who congregate in the car park
- 2 Excessive noise from bands playing in the pub
- Rowdy behaviour when the pub closes car doors slamming, people shouting etc
- 4 Cars being parked along the narrow road and round into other residential streets

I object to these because this public house is situated in a quiet family residential area. During this year it has changed from a public house that sat side by side with the locals who used it without problems for many years, but now over the past few months it appears to be open after its official hours which in turn for some reason causes some of its customers on leaving to use the gardens as public conveniences, litter bins and a place to chant abusive songs. This has also coincided with recent damage to cars parked on the roadside.

We moved into Swanmore in 1992 and because our property borders the New Inn I had some reservations with regard to living next to a public house. We therefore visited the establishment on several occasions over the period of a couple of months before purchasing our house in Church Road. We found then and have done until the latest tenant took over that the establishment was run as a quiet village pub and social gathering point for locals. We have lived in harmony with the New Inn for 15 years and as I am sure you will know from your records, extended hours have been limited to the odd occasion for a fete or jazz evening which many of the villagers attended.

The latest tenant sees his business earnings related to music groups, Sky TV and any other opportunities which may entice youngsters and enhance his profits. You will appreciate that indoor live entertainment with modern electronic equipment in the late hours is as good as outdoors. I write to convey my deep concern about the above application and wish to register my strong disagreement to such variations. This was brought to my attention by a neighbour although I have seen nothing posted by the pub nor have I, as the owner of a propery which shares a boundary with the pub, received any notification that such an application had been submitted. I find this lack of information totally unacceptable.

The New Inn is situated in the very heart of our village and is surrounded on all sides by residential housing, many of which are home to young children. Our house abuts the pub's garden and my sleep is already regularly disrupted on a Satrudany night by the loud live music in the pub. Even at this time of year with windows and doors closed, the loud thump of the beat pervades my bedroom. I dread to think how those families trying to get young children to sleep during it must feel!

I am filled with horror at the thought of more frequent gigs going on longer into the night which will make sleep impossible once summer comes and windows are open. Not only that, but the pleasure of sitting quietly outside in our garden on a summer evening will be denied to us and our neighbours.

However, the music is only part of the problem. Once the pub closes we will be subjected to the noise of late night revellers making their way home. There is already much yelling and screaming as they leave and this will be exacerbated if the proposed increase and extention to opening hours should be approved.

This is not an inner city where youngsters go clubbing, it is a quiet village in the Meon Valley – I would therefore urge you to reject this application.




I write with reference to the application by Green King Retailing to vary the premises license for the New Inn, Chapel Road, Swanmore.

My family have been resident in Chapel Road since 1971 and have always been content with the country pub activities at the New Inn. However we are concerned that the character of the pub is possibly about to change. Please observe the following comments taken in the (un-numbered) order presented on the schedule published on the Winchester City Council website:-

- 1. Variation of the hours for the sale of alcohol (on and off the premises). I object on the grounds of <u>public nuisance</u> to the proposed extension to 0100 hours at weekends and bank holidays and in particular to all night opening at New Year. Recently there have been instances out in Chapel Road of noise and, particularly, bad language (<u>disorder</u>) late in the evening, mainly at weekends. Also it is common to find empty beer tins and bottles and occasional beer glasses stuffed into peoples hedges and thrown into gardens. This would be likely to increase if the closing time is extended.
- 2. Vary the hours of live music (indoors only). I fear that rowdiness and bad language in the road in the late evening and after closing time may become disorder and a nuisance to residents near the New Inn every day of the week and for this reason I object to this license variation.
- 3. To add films and indoor sporting events (indoors only). Rowdiness in the road during opening hours and after closing time may become disorder and a nuisance every day of the week and for this reason I object to this license variation. Particularly, I object to events (indoor) on the days preceding bank holidays on the grounds that extending events to two days increases the likelihood of street disorder and nuisance. Further, I do object strongly to any all-night opening on the grounds of increased likelihood of public nuisance.
- 4. To add recorded music, facilities for making music and facilities for dancing (indoors only). It is not easy to exercise control of the level of sound of recorded and making (live) music so as to prevent disturbance to people *outside* the building. Participants ususly want it to be ever louder! Even now, with present license regulations, I am conscious of occasional <u>loud</u> music noises from the New Inn, three doors away. I therefore object to this change on the grounds of most probable <u>severe public nuisance to residents near the New Inn.</u>

5. To add late night refreshment (indoors only). No objection, assuming the refreshment is food, and not alcoholic drink (it is not made clear), and the said refreshment is made available and consumed indoors and not out in the street and within the hours prescribed by the license.
6. To remove the ban on recorded music and the exclusion of Children on Premises after 2100h restrictions. Given that some music is permitted within prescribed license hours the recorded music restriction may be lifted. However on the basis of protection of children I object to lifting of the 'Children on Premises after 2100h' restrictions.



I have received notification that Greene King are applying to vary the current licensing agreement. I totally oppose any change in the current arrangements for the following reasons.

- 1. This public house is in the centre of the village surrounded by houses many with young children. The current landlord (and previous one) 'flouts' the existing agreement. As an example, loud music is played in the garden which is excluded in the current license. Even if music is played within the establishment, then all the doors and windows are left open and it is impossible to sit in one's garden in the summer. Even in the winter one can hear the noise indoors from 100 yards away through double glazing, especially the bonk, bonk of the base drum.
- 2. If you go round to the pub to tell them that they are contravening their license by the outside noise then all one gets in reply is an excuse i.e. 'there is nothing we can do it's a private party'. Or you ask them to turn the noise down and a few minutes later it is up to the previous level.
- 3. Please note the issues raised in my letter to you dated 22 July 2006, which typifies the problems we have.
- 4. Since the new landlord arrived, we have noticed a significant increase in noise levels. Also a tendency for the finishing up time of drinking to take longer than ever, leading to an increase in noise and general disruptive nuisance in the surrounding roads e.g. loud shouting and undesirable language.
- 5. This is not the case of a village losing its last pub. There are already four pubs within a few minutes walk of the centre.

In conclusion, I strongly oppose any changes to the current arrangements. The basis of my objection is on the grounds of public nuisance to those living in the surrounding area and the prevention of crime and disorder particularly when leaving the pub.

We are writing to make representation in opposition to the request from Greene King retailing Ltd. to vary the premises licence for the New Inn, Chapel Road, Swanmore, SO32 2QB on the following grounds:-

1) Public safety

The behaviour of the clientele of the New Inn late at night is perceived as a threat to public safety by those of us whose houses are located on adjoining roads, especially, in the case of the section of Church Road between the Primary School and the Vicarage Lane/Chapel Road crossroad which is inadequately lit by public street lighting.

2) Public nuisance

The lack of any soundproofing in the building of the New Inn ensures that the noise levels during current hours represent a serious public nuisance to those of us whose properties abut the premises. The decibels of the current music played are such that the music is clearly audible within our property, located to the rear of the public house, through dense thick flint walls as is the noise from smokers outside the building. An extension of these hours would increase that public nuisance.

3) Protection of children


The noise levels and behaviour described in 1 and 2 above currently disturb the sleep of and frighten children resident in adjoining properties and an extension to the hours proposed would seriously threaten their protection. Further the proposed removal of conditions regarding the permit of children to the premises after 2100 cannot be considered as anything but a severe threat to those unfortunate children whose parents are sufficiently ignorant of child safety and welfare to wish to take them to such premises after this time and thus most in need of protection.
