- 1.10 The Head of Environmental Protection recommends that conditions are attached to the licence to promote the licensing objective for the prevention of public nuisance. The recommendations can be seen in the representation at Appendix 2.
- 1.11 Representations were received from four interested parties concerned with noise from the premises and nuisance caused by patrons of the premises. Appendix 3.
- 1.12 Notice of the application was displayed outside of the premises and at the City Offices for a period of 28 days until 2 November 2010, and advertised on the Council's website.
- 1.13 Notices of the hearing were sent to all Parties on 11 November 2010.

### Public Safety

The Sub-Committee should consider any necessary conditions relating to public safety having regard to the observations of the Head of Environmental Protection and the Police.

### **Human Rights**

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, necessary in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

Bar3One situated at 31b the Square is one of three late night venues within Winchester City Centre.

Records show that the Premises Licence was issued by Winchester City Council 12th April 2006. The Designated Premises Supervisor (DPS) was varied to Lee Davies 3rd May 2007. The Premises Licence holder is K&L Leisure Ltd, of which Lee Davies and co- owner Calvin Collymore are believed to be directors.

Although authorised to provide various licensable activities including the sale of alcohol anywhere between 1000-0230 depending on the day of the week, Bar3One generally does not open for business until approximately 2100 on any given night, although often has few customers until 2200. It also rarely opens every day of the week.

The latest days and hours for trading that the licence authorises is between Thursday - Saturday. This is when recorded music and the sale of alcohol can be provided until 0230 hours.

Since the premises licence was issued in 2006 Police unfortunately have received a disproportionate level of late night violent drunken incidents relating to the premises. Police have made determined efforts attempting to work with the owners since they took over, in an effort to reduce the levels of crime and disorder relating to the venue.

Police letters of concern have been written to the Premises originating from as far back as 2006. These have been for a variety of reasons that includes violence, participating in irresponsible drinks promotions, drunkenness offences and overcrowding.

Numerous meetings have been held at Winchester Police Station. Joint licensing visits have also been carried out with Winchester City Council, Environmental Health Officers and Hampshire Fire and Rescue. Unfortunately Bar3One is consistently the most problematic premises in Winchester, which we believe contributes a great deal to the overall levels of crime and disorder within the city centre relating to the night time economy (NTE).

Police records show that there are in excess of 40 occurrences recorded on our Records Management system ( RMS) during 01/10/09 to 01/10/10. 13 reported assaults, 14 drunkenness & Public order offences along with 13 thefts of customer's property whilst inside the venue are shown within this period.

There are also a substantial number of individual officers reports recorded in the Police Licensing Register relating to visits, observations, possible overcrowding and behaviour of staff. There is also evidence of noise complaints and damage to adjacent shop premises from customers and crowd barriers placed on the pavement by Bar3One staff.

Below is a Summary of incidents that have given rise to request this Review application and relate to the period 01/10/09 to 01/10/10.

On the 2nd October 2009 the owner Calvin Collymore made a racial complaint regarding a customer at Bar3One. CCTV footage covering the front door relating to this incident where arguably this is where it would have been of most use was not available. Although there was a small camera affixed to the end of the building this was found to be defective.

Due to ongoing Police concerns a meeting was held at Winchester police station on the 8th October 2009. Present were PC Gary Miller and PS Andy Fisher with the owners Lee Davies and Calvin Collymore. During this meeting the business was placed on a voluntary 'Action Plan.' The action plan was effectively in lieu of being taken to a Review of the Licence and was agreed by the owners. The action plan agreed an increase of door staff, further investment in CCTV, a last entry time of 0100 and an over 25 year policy on Saturdays. The owners would not agree to voluntarily reduce the hours of trading to 0200 as we requested.

At 0200 on the 6th December 2009 a heavily intoxicated 25 year old male was ejected. As a result of further confrontation against the door staff fell over backwards striking his head severely in the process. The male was moved by staff across to the other side of the road and was obscured from vision. This incident was not reported to Police by the staff with the male later found unconscious and subsequently found to have fractured his skull. Although there was eventually no prosecution against the door staff involved a written Police request made 24th August 2010 for details of Public Liability insurance has been ignored.

On the 16th December around 0200 a racial complaint was made by a 24 year old male employee which resulted in the arrest of the suspect , but was later dropped by the aggrieved.

On the 5th February around 0130 a complaint of assault was made against Calvin Collymore from a male refused entry. CCTV footage from Bar3One was not available as the hard drive was apparently malfunctioning at the time. Due to insufficient evidence further investigation was not possible.

On the 28th February around 0225 a 20 year male was assaulted inside the venue during a disturbance between two groups of males.

On the 5th March around 0050 a female reported that she had been ejected and pushed up against a window by staff.

On the 9th April around 0220 a 19 year old male was punched in the mouth following the premises emptying out.

On the 4th June around 0100 a drunk male aged 20 was ejected by doorstaff, whilst being ejected he headbutted the doorman.

In the early hours of the 9th July 2010 a 19 year old heavily intoxicated female customer was taken to the A&E dept at the County Hospital by one of the doorstaff. Police received a report at 0357 that she had assaulted one of the nurses. Although our concerns were raised with the owners of Bar3One regarding the circumstances leading to this unusual behaviour our request for an explanation has never been forthcoming.

On the 21st July a meeting was again held at Winchester Police Station with Insp Taylor, PC Miller with Lee Davies and Calvin Collymore. During this meeting Police concerns were discussed regarding the ongoing level of violence within the city centre relating to the NTE and the impact we believed that Bar3One was contributing towards it. Our request for a voluntarily closure at 0200 for a trial period was again refused. The owners did however state that they would start supplying hot food for their customers which may allay Police concerns around the late night takeaways, who close at 0300. There is no evidence to date that this has commenced.

On the 8th August around 0100 outside the venue a 22 year old female was punched in the face, with another male knocked unconscious.

On the 13th August a report was received from a 19 year old female that she had been assaulted around 0030-0100 and a glass had been thrown at her.

In the early hours on 25th August a heavily intoxicated 21 year old male reported that he had been assaulted by Calvin Collymore, the co-owner of Bar3One. This incident occurred outside the venue after being ejected. Later investigations were hampered by the lack of witness evidence from staff, venue CCTV evidence and written records made by door staff. Calvin Collymore who also acted in the capacity of an unlicensed Security Industry Authority (SIA) doorstaff has subsequently been charged with assault.

#### Conclusion

Bar3One is situated within a mix of mainly commercial businesses with some residential properties in proximity. The style and operation of the premises is not conducive with a late night venue, which has unfortunately been proven time and time again.

There is significant evidence of violent drunken behaviour inside and outside the venue that has been occurring since it opened in 2006. Although all the behaviour cannot always be attributable to Bar3One it most certainly contributes towards it.

Unfortunately by the owners wishing to operate a late night venue it is clear that customers are in all probability quite intoxicated by the time they enter the premises and due to the lateness of the venue will no doubt consume a great deal more alcohol. The smoking ban has also not helped these types of venues as more inebriated customers than might otherwise be the case go outside to smoke and are not as well controlled.

The owners have also not changed the style of operation since opening and have chosen for whatever reasons to appeal to the 18-25 year age group. This group are recognised as being the most likely to be involved in crime as an offender or aggrieved.

Due to the popularity of the venue queues often form at busy times. This has resulted in complaints of damage to shop fronts and noise complaints from businesses.

There is evidence of poor management of customers and staff with 13 thefts recorded over a one year period. There is also evidence of management's failure to comply with conditions on the premises Licence relating to CCTV.

Despite Police requests for co- operation the owners have refused to reduce their hours. They have also failed to co- operate when requested for Public Liability Insurance details.

The co- owner Calvin Collymore has recently been charged for assaulting a customer.

Police resources are often stretched due to the NTE drunkenness and violent yobbish behaviour prevalent on the streets. It is paramount that any late night venue complies with the Licensing objectives should they wish to aim for this particular market. Unfortunately Bar3One undermines the Crime & Disorder, Public Safety and Public Nuisance Licensing Objectives and we therefore seek a Review of the Premises Licence.

#### Recommendations

1. The DPS Lee Davies is removed
2. A Personal Licence holder must be on the premises at all times whilst licensable activities are being provided.
3. All Licensable activity should cease at 0100 on any night.
4. The capacity of the venue should be reduced from 250 to 150
5. Door staff should be increased to 6 with at least three persons inside patrolling the floor so that they are better able to deal with the drunkenness and thefts. All door staff must wear clearly identifiable reflective tabards or jackets. Written records must be made on a

daily basis of all incidents at the venue, with details of the door staff involved. These records must be made available for inspection by Police during normal operating hours.

6. During Licensable activity there must always be a member of staff capable of operating the CCTV system. Any footage recovered must be capable of being played on any windows based computer without any additional software being installed. Any footage must be of evidential standard and must cover adequately the front door and foyer area to the satisfaction of Police. Written records must be made of maintenance and testing of the system and made available to show Police that the system is working

7. There should be no entry or re- entry to the venue by any customers within the last hour of the sales of alcohol, save for going outside into the enclosed side yard to smoke.

8. A noise limiter should be installed to the satisfaction of the Head of Environment.

9. Written evidence of public liability insurance to be provided annually on renewal.

Dear Sir/ Madam,

I have noticed during my regular Licensing visits around Winchester City Centre that you are advertising Alcoholic Promotions, specifically on Tuesdays. I am assuming that this evening is predominantly to cater for the large student population within Winchester.

I am very disappointed at the pricing levels of alcoholic drinks being advertised inside your premise, Bar3One and elsewhere within the City Centre. I consider that alcohol being sold for £1 a drink with selected shots for 50p constitutes irresponsible retailing. This goes against the BBPA and Portman Group Code of Practice. More importantly, it goes against the principles of the Winchester Pub Watch agreement to which you belong and should share the common goals.

We receive a considerable amount of complaints from the University regarding immature and impressionable students arriving back after a night out in Winchester, having over-indulged on alcohol. For many of these young people this is the first time that they have been away from their parents and they are completely unprepared for the possible consequences of drinking to excess. It is often the staff at the University and hospital who have to pick up the pieces after these young people leave the City Centre and arrive back. Unfortunately on many occasions the Police also become involved and in these instances the young people can end up with far more than just a hangover.

As a Licensed Premise you have responsibilities under the Licensing Act 2003. Anything you do must not undermine the Government Licensing Objectives. I would therefore urge you **again**, as I wrote a similar letter in February 2006, to seriously consider the potential repercussions of persisting with these types of promotions. We will deal robustly with any alcohol-related disorder or licensing offences that involve your premise. Substantial fines, imprisonment and a review of your Licence are all possible.

Dear Mr Davies

This letter is written following your phone call last week to the Station regarding customers leaving the premises in order to smoke outside and of the problems this has now generated to residents.

Unfortunately you are not alone in attracting complaints regarding additional noise and antisocial behaviour since the introduction of the smoking ban in the summer. Although I do have a good deal of sympathy with premises such as yours because of the legislation it however falls onto the Police as a Responsible Authority to enforce when complaints are received.

Please ensure that every measure is explored to reduce the complaints in the future. I recommend allowing as an example 6 people out at a time for a smoke break and also allowing them a set time of say 5 minutes or no re- entry. It may be challenging initially to control effectively but I know it can and has been done elsewhere. You have managed previously to control the queues from blocking the road but unfortunately now the same is happening again and complaints are not only being made by residents but also taxi drivers and Police Officers.

Ultimately it is your problem to manage the problem effectively and if you don't I am sure you realise that ultimately it will affect your Premise Licence, which is something that I am sure you will wish to avoid at all costs.

If I draw your attention to the following conditions on your Licence you will understand what I am referring to.

- 1. Staff shall be given instructions and training to encourage customers to leave the premises quietly and not to loiter in the vicinity of the premises so as to minimize disturbance to local residents.*
- 2. Prominent clear notices shall be displayed at the point of sale and at the exit to the premises requesting patrons to use litter bins provided and requesting customers to respect the needs of local residents, to leave the area quietly.*

Dear Mr Davies

As you are no doubt aware there was an incident outside your entrance during the early hours this morning. At approximately 0236 Police attended following a heavily inebriated female customer who had fallen over and believed to have broken her ankle. I understand that your partner Calvin Collymore was spoken to by APS Hercock regarding the state of a significant amount of your very intoxicated noisy customers who were outside smoking or just loitering about, some even being sick in the street.

Following our conversation last Thursday 8<sup>th</sup> May when I was in company with Winchester Council Licensing and Environmental health officers it was established that noise pollution was not from your premise during that part of the evening. However from the time of the Police visit last night and the Winchester City Council CCTV footage I am disappointed to say that it is clear that your premise without doubt contributed to a great deal of noise and antisocial behaviour.

Unfortunately as we are all aware since the introduction of the smoking legislation last summer many licensed Premises which do not have the benefit of a garden or terrace facility have faced problems. Despite the efforts of your door team it is clear that the current situation cannot be allowed to continue as it is at present. More robust effective measures must be put in place to prevent customers getting inebriated to excess inside your venue. Extremely drunken noisy customers make life a misery for residents and use up copious amounts of both NHS and Police resources.

I should not have to remind you again that it is your responsibility to ensure your venue complies with the four Licensing objectives.

The Prevention of Crime and disorder

The protection of children from harm

Serving drunks for example is still an offence.

I am writing this letter confirming our discussion this morning regarding the capacities at Bar3One.

I have clarified with Winchester City Council Licensing & Registration Dept that the conditions on your current Premises Licence are correct.

The figures below were carried over from the existing Public Entertainment Licence onto your current Premises Licence. The following extract has been taken from your Premises Licence.

**Public Entertainment Licence**

The number of persons permitted to be in the whole premises whilst in use for the purposes of this Licence shall not exceed 250. The maximum number of persons in the Upstairs Bar shall not exceed 120 at any time (or 200 at any one time provided that improvements to the first floor fire escape have been completed to the written satisfaction of City Secretary and Solicitor in consultation with the Head of Building Control and the Hampshire Fire and Rescue Service).

I understand that Winchester City Council Licensing & Registration Dept has not been notified of any such works having been completed to increase capacity in the upstairs bar. Even if this was the case the total capacity would still not be authorised to exceed 250 at any point.

If you therefore wish to increase your capacity or hours/conditions of trading then a Premises Licence Variation must be applied for. It is very disappointing to me that that I am actually writing this letter. This is following being shown one of your promotional posters circulated throughout the City.

I was surprised to see this poster as the event advertised drinks for 99p on the 13<sup>th</sup> November. We consider alcoholic drinks selling at 99p to fall into the bracket of irresponsible drinks promotions.

Whilst it is not my intention to tell you how to operate your business within the law, I must advise you in the strongest terms that we consider this type of promotion out of place in Winchester. It also goes against the principles of Pubwatch, of which you are a member and can only encourage the excess drinking of alcohol and the associated problems that it brings.

Not only was this event promoted throughout the city it was also promoted at the University, undoubtedly targeting impressionable students. There was also the requirement for the attendance of the Police to an assault at your premises at 0145 hrs necessitating the arrest of the male offender.

I must draw your attention to the below section under Crime and Disorder on your licence which clearly states. No irresponsible drinks promotions shall be advertised or carried out

Unfortunately it also appears that further posters are being circulated within the city centre promoting heavy discounting of alcohol. I would strongly urge you to reconsider the implications to your Licence by participating in such promotions.

I also understand that you are participating in the Stamina 7 sponsored pub crawl on Tuesday 25<sup>th</sup> November and will be the last venue. It is therefore highly probable that the participants in this pub crawl will already have consumed a considerable amount of alcohol.

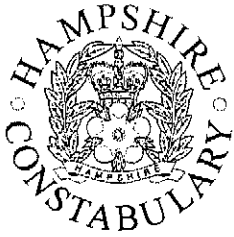

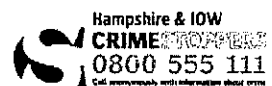

I write in response to the application for review applied for by Hampshire Constabulary. I wish to make representation on grounds of public nuisance.

In 2008, planning permission was granted for the construction of 2 apartments located on the upper floors above a retail shop at 29 The Square, Winchester. These were constructed and completed in August 2010 and are accessed via Lamb Alley.

The second floor apartment, no. 2 Lamb Alley became occupied on 20<sup>th</sup> August 2010. The first floor apartment (1 Lamb Alley) is currently vacant but the landlord is advertising for tenants.

On 6<sup>th</sup> September 2010, just over 2 weeks after the tenant had moved into 2 Lamb Alley, I received a complaint from the tenant alleging that the noise from music, especially bass noise was so loud as to prevent her from sleeping.

I met with the Licensee, tenant and Landlord on 29<sup>th</sup> September 2010 to carry out sound tests. Music being played within Bar3 One was highly audible in 2 Lamb Alley and the bass was especially intrusive and in my view constituted a public nuisance. The Licensee reduced bass levels at 63Hz octave band by 30 decibels and the bass was considered acceptable and no longer audible within the apartments.

However the following week, the tenant of 2 Lamb Alley contacted me again to advise me that bass levels had been repeatedly disturbing her sleep during subsequent evenings and are continuing to do so. The complainant has advised me that she has now started to co-ordinate staying away from the apartment on the nights that Bar3 One is open.

I am not aware of whether the Licensee had changed the settings for bass levels after my visit or whether the problem was due to different music tracks being played.

However I believe that there needs to be a more permanent solution.

1 and 2 Lamb Alley adjoin the first floor of 31A The Square, which is an empty office above Cadogan and James and this adjoins Bar3 One. It is likely that due to the age and construction of this terrace arrangement of properties that there is significant vibration and

flanking transmission between the properties that is causing the problem. Given that sound will find the weakest link and can travel through ceilings, above ceiling spaces, through floorboards, joists and partitions, light switches, telephone outlets and recessed light fittings etc, it is typically difficult to acoustically insulate and requires specialist expertise to be done effectively.

To achieve a permanent solution to this problem, I would like to make the following recommendations to the Committee:

#### Recommendations

1. No regulated entertainment consisting of amplified or live music shall be provided until an acoustic report, prepared by a competent person has been obtained by the premises licence holder and remedial works have been agreed, implemented and completed, to the satisfaction of the Director of Operations.
2. A noise limiter shall be installed, calibrated and maintained to the written satisfaction of the Director of Operations. All amplification systems shall be routed through the noise limiter.
3. A Noise Management Plan shall be in place to ensure that there are suitable measures taken to prevent unreasonable disturbance to neighbours. For the attention of John Myall,

I am the owner of the freehold property 29 The Square, Winchester.

The property consists of a retail unit on the ground floor and on the upper floors two independent apartments with their own access from Lamb Alley.

Over the last twelve months I have made a large investment in the building virtually rebuilding the upper floors. I have replaced the roof, created new dormers front and rear, constructed a new external staircase and completely reconfigured the internal layout to make two luxury apartments.

The first floor is a 2 bedroom unit with large Living room/Kitchen and Bathroom, the top floor is a vaulted ceiling 'loft style' 1 bedroom unit with large Living room, Kitchen and Bathroom. I designed these with a local architect and obtained full planning permission and building controls. Particular attention has been paid to sound proofing between the floors to avoid noise transfer, locating the bedrooms at the rear of the building and upgrading the original specification to new double glazed windows to replicate the originals throughout.

It is my intention to rent the apartments and use the retail unit for my own business. I start work early next year in major refurbishment of the shop which will complete the project. I have designed the building to allow the 2 apartments to be sold leasehold in the future.

The top floor was first occupied by the current tenant on 20 August 2010 and the first floor is now being advertised for rental.

In early September 2010 I was contacted by the tenant to advise me that the level of bass from Bar 31 was unacceptable and it was making it difficult for her to sleep and was seriously affecting her enjoyment of the apartment. I immediately contacted WCC Environmental Health and with them we have tried to negotiate with the owner of Bar 31 to reduce the level of bass being transferred through the building. Currently this has not been successful and the tenant is still suffering. The problem gets louder as the night progresses until the bar closes at 2am.

I am very concerned that having made a large investment I am in a position of potentially owning two apartments which cannot be occupied having installed sophisticated sound proofing between the floors but now affected by premises two doors along the road.

I have occupied the building for the past 9 years as a business and owned the freehold for the past 3 years.

I would welcome the opportunity to discuss this with you by appointment.

I am writing in reference to the application to review the alcohol licence of Bar 31 in The Square.

As the adjacent shop, the presence of Bar 31 in The Square has a detrimental effect on our business. Problems occur from their clientele that are not dealt with appropriately by those responsible at Bar 31.

In the interest of our business we now have to come to work early on a Friday in order to clean our shop front of the debris and dirt from the bar's busy Thursday student night. Problems encountered include our windows being left filthy- with hair gel, lipstick and blood. On some occasions there has been vomit on our pavement and once in our doorway. Cigarette butts are left on the pavement- with burn marks on our paintwork where they were extinguished. Furthermore our shop front has been damaged by the railings they use to control their queue.

We have repeatedly informed Bar 31's managers about our concerns and although these issues have been assured to receive attention, sixteen months later the situation is still completely unresolved despite efforts on our part to reach a compromise.

We fully understand that the nature of their business is entirely different to that of Cadogan and James, and that drunken incidents occur, but feel that the situations are not controlled effectively and Bar 31 management do not take sufficient responsibility for the disruptions their clientele cause to our ability to operate as smart, clean, food outlet.

We hope our concerns will be taken into consideration during the process to review the licence of Bar 31 and that some agreement can be established to protect our business in the future,

Following Abigail Toms' email dated the 13<sup>th</sup> of October regarding my public nuisance complaint stemming from the noise generated by activities carried out at Bar 3One; I wish to make a formal representation to the Winchester Council licensing committee in respect of Bar 3One.

Following my complaint about the level of noise disturbance originating from Bar 3One, an initial assessment of the noise levels was undertaken by the Winchester Council Environmental Health Officer on the 29<sup>th</sup> of September and followed up on the 7<sup>th</sup> of October. This led to an informal agreement with me for the levels of bass to be controlled to an appropriate level by the owner of the club. However, this arrangement has not led to a satisfactory conclusion. There continues to be nights where after 11pm the music originating from Bar 3One is clearly audible outside of my flat and the bass resonates through the whole of the building. In addition there are high levels of disturbance created by patrons leaving the premises between 2am and 2:30am. Both of which have led to me being severely disturbed or awoken at any time between 11pm and 2:30am. I have evidenced this in the sound log provided by email to Winchester Council on the 4<sup>th</sup> of October and updated on the 8<sup>th</sup> of October.

My very serious concern remains that the acoustic structure of the building in which Bar 3One is based, in combination with its location render it wholly unsuitable to be used as a nightclub. Further to this, a lack of any credible noise management plan or assessment by the management of the club to ensure that the noise it creates is kept to appropriate levels runs contra to Winchester Council's licensing rules. The result of these four factors is that my flat remains long term uninhabitable owing to the noise disturbance created by the operation of Bar 3One. I thoroughly enjoy living in this apartment and location. However, I am currently avoiding staying in my apartment on nights when the club is open and I would regret to have to move home in response to this nuisance.

As a next step following the licensing review in November 2010 if the license is renewed on the existing terms, as the informal solution to effectively control noise levels from Bar 3One has proven unsuccessful, I would have to look to have a formal investigation undertaken to confirm that Bar 3One is in fact creating a statutory nuisance as defined by the Environmental Protection Act.

We offer the following advices :-

Noise further to customers at Bar31 after midnight is unacceptable, especially given that local businesses offer overnight stays, and more so in respect of the immediate residential side roads and residents above retail outlets.

This is likely to be alcohol related, and can run into the very early hours. The general form is excessive shouting and screaming and running around purposelessly, even a minority can be an undue nuisance.

Items left on the street or street furniture can be targets within a drunken revelry, eg bins overturned etc.

This arena can be unsuitable for those expecting comfortable safe passageway as pedestrians later at night.



The front of the Museum and the Cathedral grounds are used as a toilet, frequently and openly.

There is always a certain amount of music noise from some venues in that part of the City and elsewhere. Some can be considered normal, some take care to limit noise as policy to before specific times, but Bar31 has a history of being louder and with the associated people noise, including from the open area to the side.

Overall the behaviour of some is unacceptable by the important standards in the context of the licence review and generally, especially in the early hours, and meaningfully so in this historic and adjacent residential area of central Winchester.

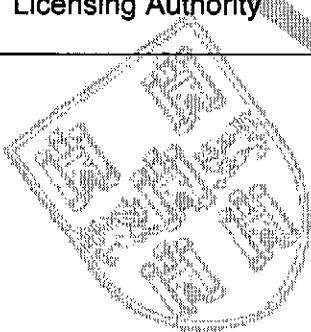

## **Annex 1 – Mandatory conditions**

1. No supply of alcohol may be made under the Premises Licence (a) at a time when there is no Designated Premises Supervisor in respect of the Premises Licence, or (b) at a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
2. Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence.
3. Where individuals are required on premises to carry out security activities, they must be licensed by the Security Industry Authority.
4. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
5. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
6. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
7. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
8. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
9. The responsible person shall ensure that–
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures–
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) customers are made aware of the availability of these measures.

## **Annex 2 – Conditions consistent with the Operating Schedule**

### **Crime and Disorder**

1. A fully functioning CCTV system with recording facilities shall be installed and maintained to a standard agreed with the Police Crime Prevention Design Advisor. Recording shall be retained for a period of 30 days and made available to Police upon request.
2. The premises shall be a member of the local Pubwatch scheme and utilize radio contact with the Local Control Room if available.

3. There shall be no entry to new patrons after 0130 on any night.
4. No irresponsible drinks promotions shall be advertised or carried out.

### **Public Safety**

1. There shall be at least two SIA registered Door Staff on duty Friday and Saturday evenings from 2100 until close, or when the premises are open for licensable activities after 0100.
2. All Door Staff to wear reflective jackets and name badges.
3. Staff shall be given instructions and training to encourage customers to leave the premises quietly and not to loiter in the vicinity of the premises so as to minimize disturbance to local residents.
4. Prominent clear notices shall be displayed at the point of sale and at the exit to the premises requesting patrons to use litter bins provided and requesting customers to respect the needs of local residents, to leave the area quietly.

### **Public Nuisance**

1. Whilst music is being played as part of regulated entertainment, the licensee or appointed member of staff shall check periodically that noise levels are acceptable. Such monitoring shall be carried out at the boundary of the premises to ensure that local residents are not likely to be disturbed.
2. Music shall be turned down every night to a background level at least 30 minutes before closing time.

### **Protection of Children**

1. The premises shall adopt and implement the Hampshire Constabulary's Challenge 21 Scheme.
2. No person under the age of 18 shall be permitted on the premises after 2100.

### **Conditions from existing licences:-**

#### **Justices On-Licence**

None

#### **Public Entertainment Licence**

The number of persons permitted to be in the whole premises whilst in use for the purposes of this Licence shall not exceed 250. The maximum number of persons in the Upstairs Bar shall not exceed 120 at any time (or 200 at any one time provided that improvements to the first floor fire escape have been completed to the written satisfaction of City Secretary and Solicitor in consultation with the Head of Building Control and the Hampshire Fire and Rescue Service).

A written plan of evacuation of the premises in the event of an emergency shall be maintained. All staff shall be made aware of the plan, which should include the role of each individual member of

staff in the event of an emergency evacuation. All staff should be trained in implementation of the plan.

All doors and windows that are capable of being opened directly to the outside of the premises shall not be kept open, wedged open, or maintained open by a mechanical or other device whilst the premises are in use for the purposes of this Licence. Both sets of doors at the front of the premises shall be kept shut as far as possible whilst music is being played and one set of doors shall be kept shut while people are entering and leaving the premises.

### INSCRIPTION

There shall be affixed and kept up on some conspicuous place on the outer side of the principal door or over and outside the principal entrance of the place licensed an inscription in capital letters not less than one inch in height in the words following: -

"Licensed in pursuance of Act of Parliament for the public ... "followed by a word or words indicating the purpose for which the place is licensed.

### HOURS OF OPENING

The place licensed shall not be opened for the purpose of public entertainment between 2.00am and 8.30am on any day.

### RESPONSIBLE PERSON

The licensee or a responsible person nominated by the licensee in writing, not being a person being under 21 years of age shall be in charge of, and present in the place licensed at all times members of the public are present.

### MAXIMUM NUMBERS

The maximum numbers of persons to be admitted at any one time to the licensed premises shall not exceed the number specified in the licence.

### ATTENDANTS AND SECURITY PERSONNEL

During the time the premises are in use for public entertainment, there shall be in attendance the following numbers of staff or other attendants acquainted with the established routine to be followed in the case of fire or other emergency. The aim of the attendants should be the avoidance of panic and the orderly evacuation of the premises:-

Up to 25 persons	2 attendants
Over 25 persons	4 attendants for the first 250 persons 1 attendant for each of the additional 250 persons
Where at any licensed function the majority of persons attending are under the age of 16 years	Double the above number of attendants plus one attendant for each exit

### OR SUCH LOWER NUMBER OF ATTENDANTS AS MAY BE AGREED IN WRITING BY THE LOCAL AUTHORITY

***Where an attendant is responsible for security, protection, screening the suitability of people entering premises or conflict management they must be licensed by the Security Industry Authority.***

### **SAFETY OF PERSONS**

The licensee shall take all precautions necessary for the safety of persons frequenting the licensed premises.

### **FORM OF ENTERTAINMENT**

No public entertainment shall be permitted or suffered to take place in the place licensed which is licentious, indecent or likely to produce riot, tumult or breach of the peace.

### **BEHAVIOUR**

The Licensee shall to the best of his ability maintain and keep good order and decent behaviour on the licensed premises whilst open for public entertainment.

### **NUISANCE**

No public entertainment shall be permitted or suffered to take place in the place licensed which is a nuisance, annoyance or inconvenience to the occupiers of any other property.

### **INTOXICATION**

No person shall be permitted or suffered to enter or remain within the place licensed while in a state of intoxication

### **OFFENDERS**

If any disorderly conduct shall take place, the Licensee shall himself and his employees assist to the utmost in the apprehension or expulsion of the offenders.

### **HYPNOSIS**

No exhibition, performance or demonstration of hypnotism shall be permitted at the place licensed except with the express written consent of the Council.

Permitted exhibitions, performances or demonstrations of hypnotism shall be in accordance with the conditions set out in the Home Office Circular 42/89.

### **SEATING**

Seating, tables and chairs and other furniture and fittings shall be so arranged as to allow free and ready access to exits.

### **FLOOR COVERINGS**

All floor coverings shall be secured and maintained in such a way as to prevent unevenness in the floor level.

### **CURTAINS AND DRAPES**



Curtains shall be adequately supported and where hung across doorways or across corridors they shall be arranged as to draw easily from the centre and slide freely, and be so hung that they are clear of the floor and shall be treated with fire retardant.

## TOILETS

Adequate and separate sanitary conveniences suitably marked shall be provided for persons of both sexes and shall be maintained in good working order and kept in a clean condition.

## EXITS

The number, size and position of all doors or openings provided for the purpose of the egress of the public from the premises shall be to the satisfaction of the Licensing Authority.

Doors and Fastenings – Unless otherwise permitted in writing by the Council, exit doors and gates shall open in the direction of exit, and shall in all cases be free from fastenings other than panic bolts or other such fastenings as shall be approved by the Council. Any panic bolts or other approved fastenings must be signed "PUSH BAR TO OPEN" or as is appropriate to the fastening to ensure that the mode of operation is readily apparent to any person.

Exit Routes – All exit routes including passages, courts, ramps, and stairways, which lead from the place licensed to the outside, shall at all times be kept free from obstruction.

## LIGHTING AND HEATING

Provisions – All parts of the place licensed shall be suitably and adequately illuminated. Except where otherwise permitted in writing by the council, all those parts to which the public have access and all exit routes shall be illuminated by at least two independent sources each of a standard approved by the Council.

Standard of Illumination – The illumination from each source shall be sufficient to enable the public, performers and staff to see their way out of the place licensed in safety at any time, and shall not be derived from pre-payment meters.

Segregation of the Two Systems of Lighting – The two or more lighting systems provided shall each be so installed so that a fault or accident arising in one system shall not jeopardise any other system.

Exit Notices – Each exit route from the parts of the place licensed to which the public has access shall be signed "Exit" in the manner approved by the Council. Each sign so provided must be illuminated, internally or otherwise, by at least two independent sources.

Special Effects – No laser beam or other hazardous effect may be used in the place licensed without prior written approval of the Council. The Licensee must give at least 21 days notice to the Council to allow adequate consideration.

The form of heating of the licensed premises shall be to the satisfaction of the Council.

Safety in Heating Appliances – No heating appliances shall be used in proximity to any woodwork, curtains, drapes or other materials likely to be ignited by use of the appliance.

All heating appliances must be sufficiently guarded or protected so as to avoid injury to any person.

## ELECTRICAL INSPECTIONS

All electrical installations shall be inspected every three years by a competent qualified electrician to the requirements of the Institute of Electrical Engineers Wiring Regulations and a Certificate as to the condition of the electrical installations shall be furnished to the Council.

In the intervening years the electrical installations shall be inspected annually by a competent electrician.

Any alterations, modifications or extensions to the electrical installations with which the premises are provided shall be carried out by a competent electrician and shall be strictly in accordance with the Institute of Electrical Engineers Regulations. Any portable electrical appliances or equipment used in the premises shall be in efficient working order and correctly wired and connected.

### FIRE PRECAUTIONS

Except with the written consent of the Council and subject to any conditions which may be attached to such consent, explosives or highly inflammable material shall not be brought in or used on the premises.

The use of naked flame shall not occur except when strictly necessary to any performance and when expressly permitted in writing by the Council.

Combustible or flammable materials or liquids shall not be stored within the place licensed except with the written consent of the Council and subject to any conditions which may be attached to such a consent.

If it appears to the council that the use of material, fabric or finish might assist the spread of fire, then it may require the material fabric or finish to be removed or treated forthwith in such a manner as to reduce the risk.

### SWITCHES

All gas taps and electric switches used in connection with the lighting or heating of the place licensed shall be rendered inoperable other than by the licensee, the responsible person in charge of the place licensed and any staff or attendant employed by the Licensee.

### FIRE FIGHTING EQUIPMENT

There shall be provided in the place licensed fire fighting equipment of a standard approved by the Fire Officer and acceptable to the Council. Such equipment shall be examined at least once annually by a competent person. All portable fire extinguishers shall be inspected and tested by a competent person. The date on the test to be clearly marked on a label firmly fixed to the extinguisher.

Where considered necessary, provision shall be made to the Council's satisfaction, for the examination from the above of any suspended ceiling over parts of the premises to which the public have access and such other parts of the premises as the Council may deem necessary.

### CONSTRUCTION

Wall and Ceiling Linings, Insulation, Treatment, etc – Any material used as a wall or ceiling lining, or as a suspended ceiling, or for acoustic or thermal insulation purposes shall be to the Council's

satisfaction and shall be fixed and supported in such a manner as may be approved by the Council.

Note: For the purpose of this condition the council will normally require such material to be non-combustible or be rated class 1 of the classification for the surface spread of flame when tested in accordance with the appropriate British Standards and be throughout its thickness of no greater flammability than its surface. Certain other materials may, however, be accepted subject to compliance with such conditions as the Council may consider appropriate in the circumstances of the case.

### **ALTERATIONS**

No structural or other alteration of the place licensed or of the means of exit there from shall be made during the continuance of this licence without the written approval of the council except such alterations as shall from time to time be approved by the licensing justices under the Licensing Acts.

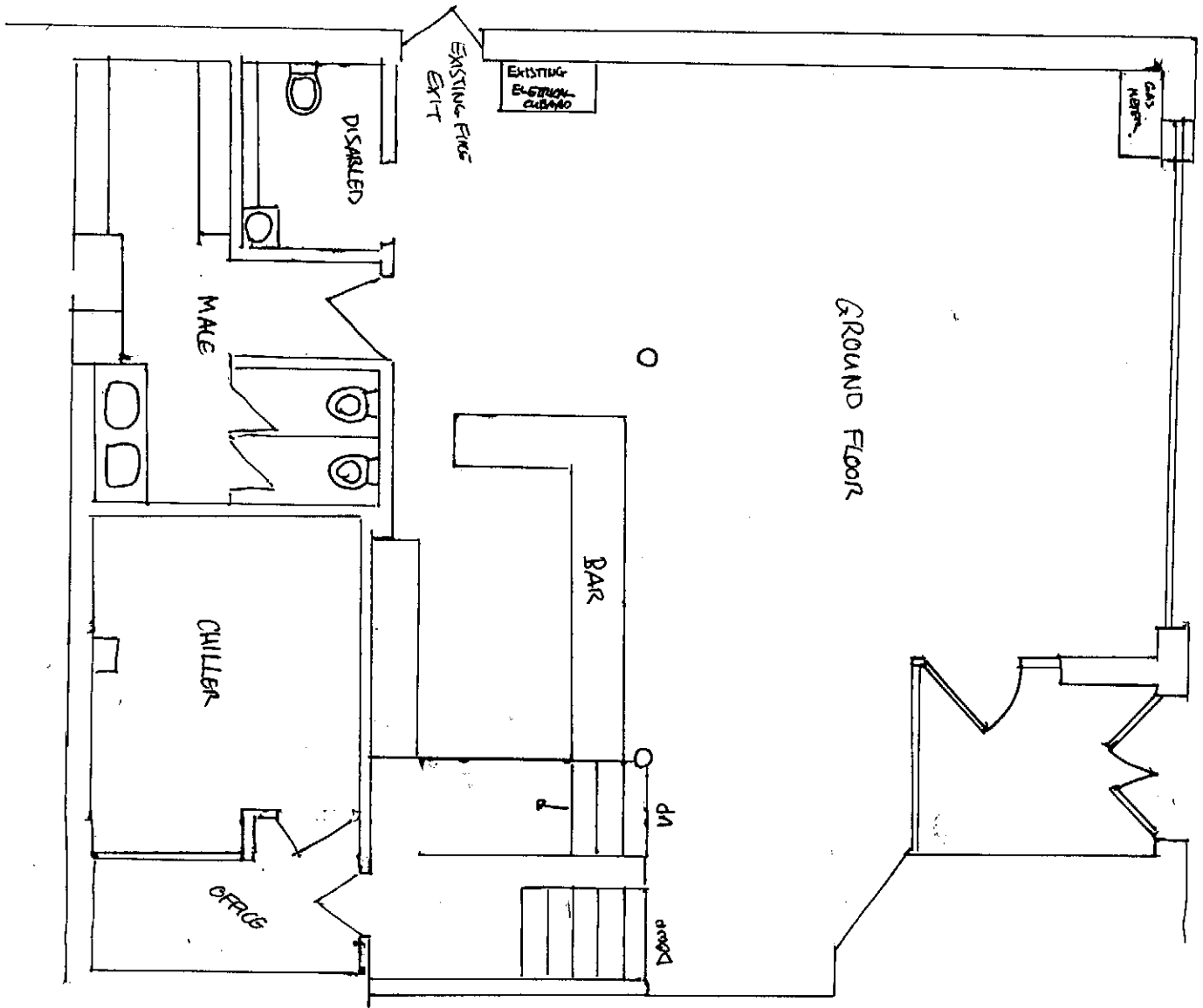
NB: The council has no power to retrospectively approve unauthorised alterations made during the period of the licence.

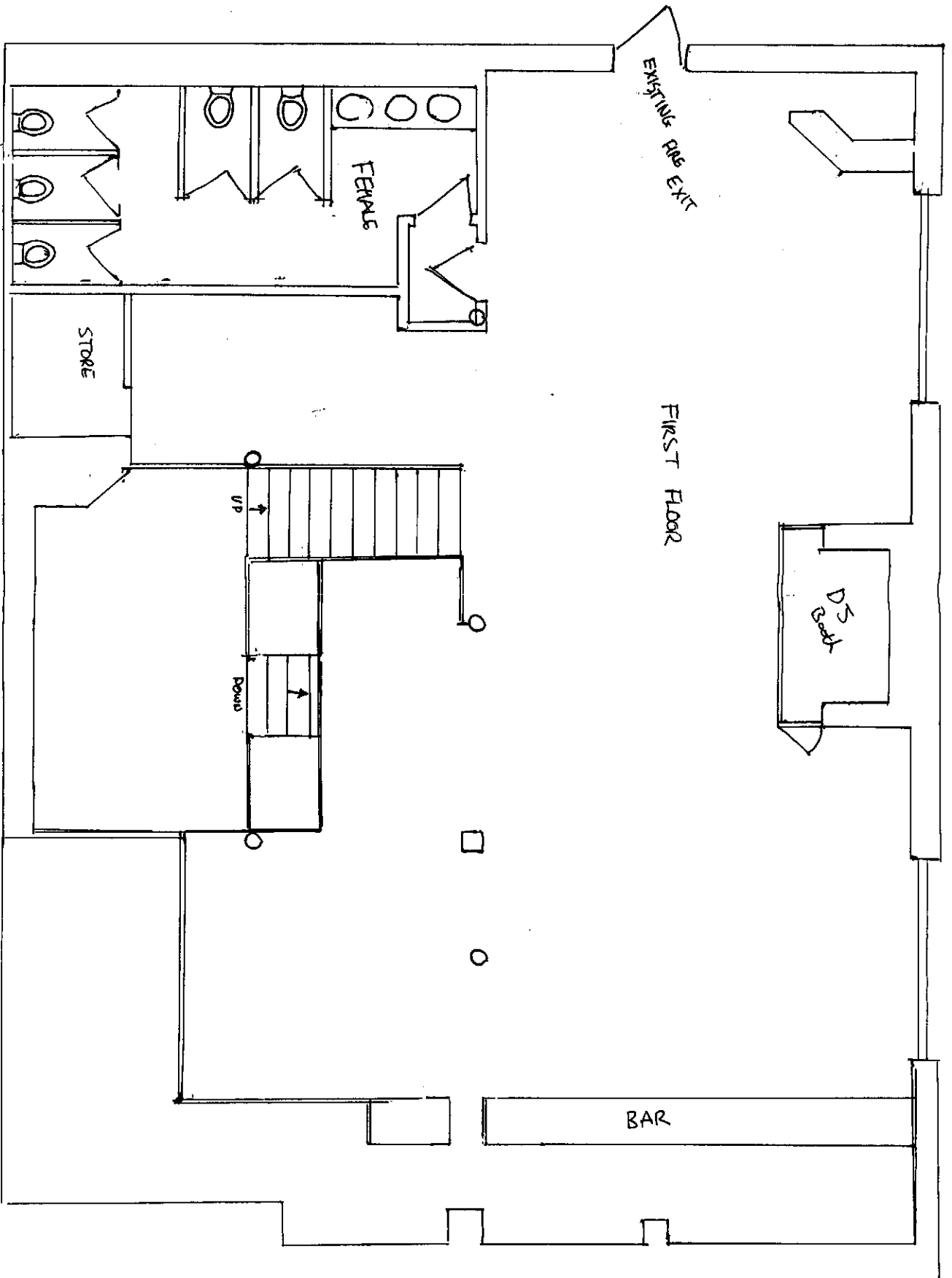

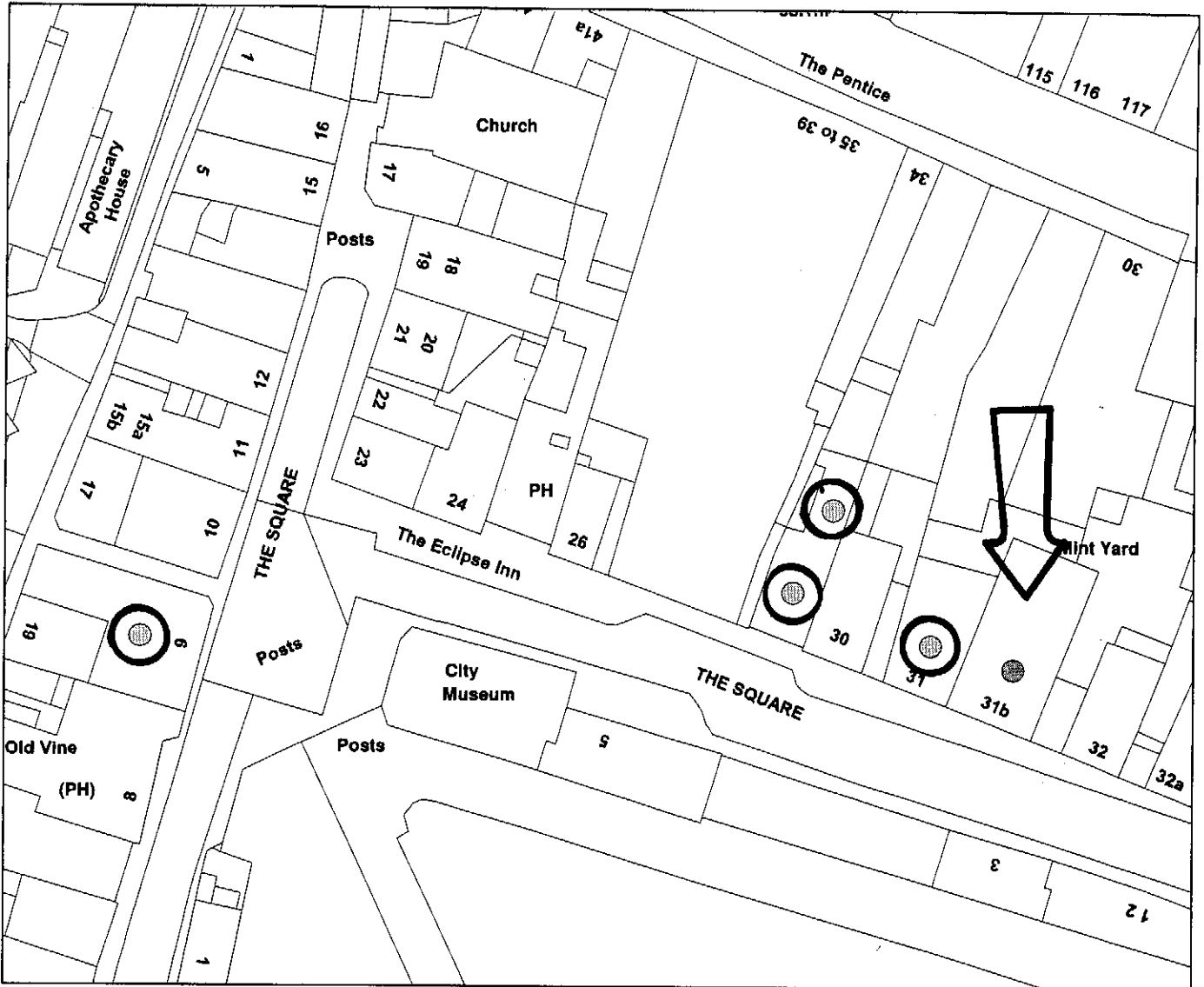
