Part A.

1. Application

Applicant: Hampshire County Council Trading Standards Service

Premises: R & K News, 12 Stockbridge Road, Winchester, SO23 7BZ

- 1.1 This application is for the review of the premises licence for R & K News, under Section 51 of the Licensing Act 2003.
- 1.2 R & K News is authorised under a premises licence for the supply of alcohol for consumption off the premises and has been since 24 November 2005 when the Licensing Act 2003 came into force.
- 1.3 Mr Jay Patel and Mr Manoj Patel have been joint premises licence holders since 24 June 2009.
- 1.4 An application for the review of premises licence number PREM 56 for R & K News was received by Hampshire County Council Trading Standards Service, a Responsible Authority, on 5 March 2012 (Appendix 1).
- 1.5 The review application relates to the prevention of crime and disorder and the protection of children from harm licensing objectives. This has been prompted following two failed alcohol test purchases within three months.
- 1.6 The first sale took place on 17 November 2011 by a cashier to a 16 year old male.
- 1.7 The second sale on 20 January 2012 was made by the shop manager, Mr Jayesh Pathak to a 16 year old female. Mr Pathak did not hold a personal licence at the time. It is believed that he had passed the Award for Personal Licence Holders before the relevant date, however this cannot be confirmed.
- 1.8 The Applicant has asked for the premises licence to be revoked.
- 1.9 Following the first test purchase failure, Stephen Lawford, a Trading Standards Officer for Hampshire County Council and PC Gary Miller of Hampshire Constabulary met with the licence holders at the premises on 25 November 2011. They agreed an action plan in order to prevent further underage sales and were advised that another test purchase would follow.
- 1.10 On 15 February 2012, Stephen Lawford interviewed the licence holders following the second test purchase failure. The licence holders admitted

that they had left Mr Pathak to adhere to the action plan and accepted that the plan had not been adhered to except for sending Mr Pathak on the Award for Personal Licence Holders course. A record of refusals was kept for one week only.

- 1.11 Mr Madhavdas Menon was the Designated Premises Supervisor (DPS) at the premises from 7 December 2009 until 15 February 2012. It is understood that Mr Menon did not have any involvement with the premises from November 2011.
- 1.12 An application to vary the premises licence was received on 15 February 2012 to specify Mr Jayesh Patel as the DPS.
- 1.13 On 5 March 2012, Mr Lawford served a Closure Notice under Section 169A(2) of the Licensing Act 2003. This notice gives the licence holders 14 days to decide whether they agree to suspend the licensable activities, in this case the sale of alcohol, for 48 hours. Failure to agree or respond, can lead to prosecution by Trading Standards officers for persistently selling alcohol to underage persons.
- 1.14 On 9 March 2012, Mr Lawford received notice that the licence holders accepted the closure notice. This took affect from 1800 21 March 2012 to 1800 23 March 2012.
- 1.15 At 1810 on 21 March 2012, Mr Lawford attended the premises and reported that all alcohol had been moved to the rear of the shop where there was no public access and a sign was displayed on the door explaining that the premises could not sell alcohol.
- 1.16 A further application to vary the premises licence was received on 21 March 2012 to specify Mr Manojkumar Patel as the DPS. He is still currently in this position.
- 1.17 A copy of the application was sent to the other responsible authorities and to the licence holders.
- 1.18 Notice of the review was displayed at the premises for a period of 28 days until 2 April 2012 and a copy was placed on display at the City Offices and on the Council's website.
- 1.19 A representation was also received from the Chief Officer of Hampshire Constabulary on 14 March 2012, relating to the prevention of crime and disorder and the protection of children from harm licensing objectives.
- 1.20 Notices of the hearing were sent to all Parties on 4 April 2012.

There were no representations from interested parties.

- 3. Observations
- 3.1 The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:
  - The prevention of crime and disorder
  - Public safety
  - The prevention of public nuisance
  - The protection of children from harm
- 3.2 In making its decision, the Sub-Committee is also obliged to have regard to the National Guidance and the Council's Licensing Policy.
- 3.3 The Sub-Committee must have regard to all of the representations.
- 3.4 The licensing authority must, having regard to the application and any relevant representations, take such steps showed below as it considers necessary for the promotion of the licensing objectives:
  - a) Modify the conditions attached to the licence either permanently or for a period not exceeding three months.
  - b) Exclude a licensable activity either permanently or for a period not exceeding three months.
  - c) Remove the Designated Premises Supervisor.
  - d) Suspend the licence for a period not exceeding three months.
  - e) Revoke the licence.
- 3.3 If the Sub-Committee decides that none of the above measures are appropriate, it may take no action.

#### Human Rights

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, necessary in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

#### 4. Conditions

The Mandatory Conditions are imposed on a premises licence in any case.

- 4.1 No supply of alcohol may be made under the Premises Licence (a) at a time when there is no Designated Premises Supervisor in respect of the Premises Licence, or (b) at a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 4.2 Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence.
- 4.3 Where individuals are required on premises to carry out security activities, they must be licensed by the Security Industry Authority.
- 4.4 The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 4.5 The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 4.6 The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

#### **Possible Conditions**

The Sub-Committee may wish to consider whether any further conditions are considered necessary to promote the prevention of crime and disorder and protection of children from harm licensing objectives, in the light of the application and the representation by Hampshire Constabulary.

No conditions are suggested for consideration as the recommendation from the applicant and the Police is that the premises licence should be revoked.

Hampshire County Council Trading Standards Service wish to apply for a review for this premises under the licensing objectives :- The Prevention of Crime and Disorder and The Protection of Children from Harm.

This premises has failed two consecutive alcohol test purchase operations within two months. The first failure was on 17 November 2011 and was conducted by Hampshire Constabulary using a 16 year old male volunteer and the second failure on 20 January 2012 was to a 16 year old female volunteer working with HCC Trading Standards Service.

Following the first failure an action plan was served on the licence holders. None of the points listed in the action plan have been adhered to fully.

**Please provide as much information as possible to support the application** (please read guidance note 2)

Listed below are the details of test purchases, mediation meeting and visits made to the store by Trading Standards Officers (TSO's)

17/11/11 – The store failed a police test purchase by selling a can of Fosters lager to a 16 year old male volunteer. The 22 year old male cashier was issued with an £80 Penalty Notice for Disorder.

**25/11/11** – As a result of the above failure, TSO Lawford and police licensing officer PC Miller visited the store and dealt with licence holders Jay Patel and Manoj Patel. They said DPS Mr Menon had gone to India earlier in November 2011.Training records could not be produced; a refusals book was not in use and a 21 policy was not in operation in the store. An action plan was issued to the licence holders (copy at Annexe A) this was issued in order to prevent further underage sales and they were advised how vitally important it was that they adhere to it. They were advised that another test purchase would follow. They were warned of the dire consequences of a 2nd sale within the next three months and failure to adhere to the action plan, which would lead to a closure notice being issued in lieu of prosecution and a Review of the premise licence which could lead to revocation.

20/01/12 - The store failed a Trading Standards test purchase by a 16 year old female volunteer, when a 1.5 litre bottle of Frosty Jack's cider was sold to her without any questions being asked by shop Manager Mr Jayesh Pathak. An £80 Penalty Notice for Disorder (PND) was issued to Mr Pathak.

15/02/12 - TSO Lawford interviewed the two licence holders at a mediation meeting. During this meeting they admitted that the DPS Menon had left the store in November 2011 and had never returned to the store. They said their plan was to make Mr Pathak the new DPS after sending him on an APLH course. They admitted that they had not advised the Licensing Authority nor the police of their plan. They admitted that they had left Mr Pathak to adhere to the action plan and accepted that the plan had not been adhered to at all except for sending Mr Pathak on an APLH course and keeping a record of refusals for one week only. Mr Pathak's wife who also worked in the store had not received any training. They stated that TSO Lawford was going to send them some Challenge 25 posters, but when they did not arrive they admitted doing nothing about it.

Trading Standards and Hampshire Constabulary have tried to assist this store with their problems of making underage sales of alcohol. A joint visit was made to the store on 25 November 2011 when an action plan was served on the two licence holders and advice was given on best practice to prevent further underage sales. TSO Lawford explained the consequences of a 2<sup>nd</sup> underage sale and failure to adhere to the action plan. TSO Lawford mediated with the licence holders on 15 February 2012 and advised that he would be applying for a Review and asking for the premise

licence to be revoked.

This premises has been operating with a DPS who has not had anything to do with the business as he has not been anywhere near the premises since November 2011.

The licence holders have failed to adhere to the action plan and have a 100% failure record of underage sales test purchases. Trading Standards believe this is entirely due to poor company practice and have no confidence in this business selling alcohol. Therefore Trading Standards say that the only option is for the premise licence to be Revoked.

Applying conditions to the licence would not be an effective nor proportionate action to take.

May we also highlight paragraph 11.24 of the Secretary of State's Guidance issued under Section 182 of the Licensing Act 2003, with a particular emphasis on paragraphs 11.26 and 11.27.

11.24 Where the licensing authority is conducting a review on the ground that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licensee and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any necessary steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives in the interests of the wider community and not those of the individual holder of the premises licence.

11.26 There is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously. These are the use of the licensed premises:

• for the purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people.

11.27 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered. We would also encourage liaison with the local Crime and Disorder Reduction Partnership.

Dear Sirs

Please adhere to the following action plan.

A written log shall be kept of all refusals including refusals to sell alcohol. The holder of the premises licence shall ensure that the refusals log is properly maintained and check and sign it on a weekly basis.

The holder of the premises licence shall ensure that every individual who appears to be under 25 years of age seeking to purchase alcohol at or from the premises shall produce means of identification acceptable to the licensing authority - passport, photo driving licence or PASS accredited photo ID - proving that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.

All staff shall be trained to challenge every individual who appears to be under 25 years of age and to refuse service where individuals cannot produce acceptable means of identification. Such training shall be provided not less than every three months, and written records shall be kept of all training and refresher training, but for the next three months training shall be provided every month.

'Challenge 25' posters shall be displayed in prominent positions at the premises.

All documents to be produced on request to police and trading standards officers.

Hampshire Constabulary are making a representation in respect of Hampshire Trading Standards call for a review of the of the premises licence of R&K NEWS under the licensing objectives of The prevention of crime and disorder and The protection of children from harm. This follows two successive test purchase failures for alcohol at the store the details of which are listed below

On 17th Novenber 2011 The police carried out the a test purchase for alcohol using a 16 year old male volunteer. On this occasion the sales assistant Gohil SATYAYITSNH sold the volunteer a can of Fosters lager. The sales assistant was issued with a penalty notice fine of £80.

As a result of this failure the store was visited on 25th November 2011 by Police licensing officer Gary MILLER and Mr Steven LAWFORD of HCC Trading Standards. Both Premises licence holders were interviewed and it was noted at this meeting that training records could not be produced, a refusals book was not in use and there was no challenge 21 policy in operation at this store. An action plan was agreed at this meeting to address these issues and this was confirmed in writing to the premises licence holders by Mr LAWFORD on 25th November 2011. Both Premises licence holders were warned that as a result of this failure that the store would be retested in due course and that should they fail again there would be a review of the premises licence.

On 20th January 2012 officers from Trading Standards carried out a test purchase for alcohol at the store using a 16 year old female volunteer. The volunteer purchased a 1.5 litre bottle of Frosty Jack's cider from the stores manager Mr Jayesh PATHAK who was subsequently issued with a Penalty notice fine of £80.

On 15th February 2012 enquiries by Mr LAWFORD of Trading Standards with the premises licence holders revealed that there had been no adherance to the action plan he had given them and that they intended to name Jayesh PATHAK as the DPS due to the absence of the existing DPS Mr MENON.

Despite interventions and advice from Hampshire Constabulary and more so by Trading standards the Premises licence holders have failed to grasp the seriousness of these

matters which is clearly demonstrated by the fact that they both failed to implement the action plan set out by Trading standards or even take an active role in the supervision of those they employed following the first test purchase failure

Having failed two test purchases for alcohol within three months the premises licence holders have clearly demonstrated that they are incapable of running the store in compliance with the Licensing law or in a way that promotes the licensing objectives. They have nominated one of the persons who actually made one of the underage sales (PATHAK) as the proposed new DPS which is unacceptable.

Hampshire constabulary can see no further intervention or condition that could be applied to the licence that could assist the Premises Licence holders in running the store in a way that promotes the licensing objectives. Hampshire Constabulary would ask the committee to revoke the premises licence and feel that this is a necessary and proportionate response to the circumstances described above and the only real way to promote the licensing objectives.

Hampshire Constabulary would also ask the committee to consider the following case law and Secretary of State's guidance coming to their decision:

B) Bassetlaw V Worksop 2009 which deals in part with the issues of the committee's decision being deemed a "punishment":

"Strictly speaking, the provisions of the 2003 act cannot be used for punishment. However, deterrence is an appropriate objective, and one contemplated by the guidance when dealing with a review of the licence where there has been criminal activity on the premises (in this case, the sale of alcohol to underage persons)."

The police would also ask the committee to consider the following parts of the Secretary of States Guidance under section 182

Par 11.26 The question of the sale of sale of alcohol on the premises for underage drinkers is considered where it states:

" There is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously these are the use of the premises for the purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people."

Par 11.24 This provides that the licensing Authorities duty in circumstances such as these is:

"To take steps with a view to the promotion of the licensing objectives in the interests of the wider community and NOT those of the individual holder of the premises licence."

Par 11.27 It is envisaged that licensing authorities, the Police and other law enforcement agencies which are responsible authorities will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to


