Subject : Representation in relation to Variation application made by Bar 3 One

Dear John,

Further to my representation dated 28<sup>th</sup> May 2012 regarding the proposed variation to the premises licence of Bar 3 One I would like to include the following into my representation. The reason for this is that some time has now passed by since my representation was made due to the delays involved in bringing this matter before the committee the portion of my report relating to matters reported to the police is no longer up to date and current and the below matters need to be brought to the committees attention to demonstrate that there are on going issues in relation to the premises.

Further research of the Police record management system has revealed that since the representation was made the following matters have occurred at the premises:

9/6/12. 0242 hrs Person ejected from premises.

10/6/12. 0229hrs Assault on door staff during ejection no complaint forthcoming

10/6/12. 0230 hrs Male ejected by door team refused to leave and police attended and gave male dispersal order to leave.

16/6/12. 0155 hrs Male ejected from bar for being drunk and issued with dispersal notice bu Police.

8/7/12. 0125 hrs male drunk passed out vomiting outside premises incapable of even giving his name. No assistance from door team who were only concerned with getting male moved so they could clear up the vomit. Male taken by ambulance to hospital. PC SKINNER reports door staff actions as very poor.

8/7/12. 0150 hrs Male aggd inside premises assaulted (punched in face) by offender. (Matter still being investigated)

8/7/12. 0220 hrs Male reporting assault (punch to face) inside the premises. Offender not identified.

14/7/12. 2355 hrs Noise complaint

**15/7/12. 0041 hrs two females fighting on dance floor were ejected by door team and then started fighting again outside. The fight had been broken up prior to police arrival and no complaints were forthcoming.**

**22/07/12. 0040 hrs Complaint regarding noise from premises.**

**29/07/12. 0240hrs Door staff requested police assistance having ejected a drunken male from the premises who was being aggressive and abusive this continues outside the premises. The male then had an altercation with his brother and this was broken up by door team and public who were restraining original male when police arrived male continued to be highly aggressive towards door team and police. He was restrained arrested and has been charged with drunk and disorderly behaviour.**

**29/7/12. 0130 hrs Theft of phone from handbag reported (handbag being carried by aggrieved at time of theft)**

**The Winchester Street Pastors also reported two males claiming that their drinks were spiked on the same evening in June (no details of when this was) both reported being in Bar 3 One. The street pastors reported they believed that this had occurred.**

**The committee are respectfully asked to consider these further incidents in conjunction with my original report when making their decision with regard to the application.**
