Part A.

1. Application

Applicant: Sainsbury's Supermarkets Ltd.

Premises: Sainsbury's Bishops Waltham Petrol Forecourt Store

- 1.1 This application is for a premises licence under Section 17 of the Licensing Act 2003 for a forecourt store at a new petrol station in Bishops Waltham.
- 1.2 This petrol station is being built on the site of the previous Total petrol station, and will comprise of a petrol forecourt and a convenience store which is to sell a broad range of groceries, household products and alcohol.
- 1.3 The application is to authorise the sale of alcohol for consumption off the premises from 0600 to 0000 every day.
- 1.4 It is also to supply late night refreshment from 2300 to 0000 every day.
- 1.5 The Operating Schedule, copied at Appendix 1, proposes the Relevant Licensable Activities.
- 1.6 Notice of the application was displayed outside of the premises for a period of 28 days until 14 March 2013, and advertised in the Hampshire Chronicle on 21 February 2013.
- 1.7 Copies of the application were sent to all of the responsible authorities.
- 1.8 No representations were received from any of the responsible authorities, however, a set of conditions were agreed between the applicant and the Head of Trading Standards. These are shown in Section 5 of the report.
- 1.9 Representations were received from 11 other persons. These representations are concerned predominately with the crime and disorder and public nuisance objectives. Appendix 2.

4. Observations

The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- · The protection of children from harm

In making its decision, the Sub-Committee is also obliged to have regard to the National Guidance and the Council's Licensing Policy.

The Sub-Committee must have regard to all of the representations.

The Sub-Committee must take such of the following steps it considers necessary to promote the Licensing Objectives:

- Grant the licence subject to conditions in accordance with the operating schedule (modified to such extent as the authority considers necessary for the promotion of the licensing objectives) and the mandatory conditions;
- 2. exclude from the scope of the licence any of the licensable activities to which the application relates;
- 3. refuse to specify a person in the licence as the premises supervisor;
- reject the application.

Terminal hours

The Sub-Committee should take account of the National Guidance and the Council's Licensing Policy with regard to terminal hours and take such steps as it considers necessary to promote the Licensing Objectives.

(Licensing Policy Part 4, D6, D7)

Human Rights

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, necessary in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

5. Conditions

Mandatory Conditions

These conditions are imposed on a premises licence in any case.

- No supply of alcohol may be made under the Premises Licence (a) at a time when there is no Designated Premises Supervisor in respect of the Premises Licence, or (b) at a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence.
- 3. Where individuals are required on premises to carry out security activities, they must be licensed by the Security Industry Authority.
- 4. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 8. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 9. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Possible Conditions

If the application is granted, the Sub-Committee may wish to consider the following conditions to reflect the Operating Schedule:

Operating Hours

- 1. The hours the premises may be used for the sale of alcohol shall be:
 - (i) Monday to Sunday 0600 to 0000

For consumption off the premises.

- 1. The hours the premises may be used the provision of late night refreshment shall be:
 - (i) Monday to Sunday 2300 to 0000

Crime and Disorder

- 1. The licence holder shall ensure that a CCTV system is installed, to the satisfaction of the Hampshire Constabulary, and operated at all times the premises is open for licensable activities.
 - a. The system shall incorporate cameras covering each of the entrance doors and the main alcohol display area.
 - b. The system shall incorporate recording facilities and recordings shall be retained for a minimum of 30 days.
 - c. The recordings shall be made available to the police on request. (Subject to data protection legislation)
 - d. The system shall be able to export recorded images onto removable media and have its own software to enable playback or review of the recordings.
 - e. There shall be a member of staff trained in the use of the equipment available at all times that the premises are open to the public.
 - f. The system shall display the correct date and time on any recording.

Public Safety

Public Nuisance

1. Prominent, clear notices shall be displayed at all exits requesting customers to respect the needs of local residents, to leave the premises and the area quietly.

Protection of Children

- The premises licence holder shall operate a scheme to challenge any person who attempts to purchase alcohol and appears to be under the age of 25 years of age to produce suitable identification. Acceptable forms of identification are:
 - Passport, photocard driving licence bearing a holographic mark, or other form of identification bearing the person's photograph, date of birth and the PASS hologram. (Proof of Age Standards Scheme, or similar accredited scheme)

(Mandatory Conditions 8 and 9)

- 2. All staff engaged or to be engaged in the sale of alcohol on the premises shall receive the following training in age related sales:
 - a. Induction training which must be completed and documented prior to the sale of alcohol by the staff member. This will include due diligence, recognising the signs of drunkenness and refusal of sale due to intoxication.
 - Refresher/reinforcement training at intervals of no more than 6 months.
 - c. Training records will be available for inspection by a police officer on request and will be maintained at the premises for a period of 12 months.
- All cashiers, management and security personnel shall be instructed to record in an incident book/register:
 - a. All incidents of crime and disorder occurring at the premises;
 - b. Details of occasions when the Police are called to the premises.
 - c. This book/register will be available for inspection by a police officer on request.
- 4. All cashiers shall be trained to record refusals of sales of alcohol in a refusals register. The register will contain:
 - a. Details of the time and date the refusal was made:

- b. The identity of the staff member refusing the sale;
- c. Details of the alcohol the person attempted to purchase.
- 5. This register will be available for inspection by a police officer or other responsible authority officer on request.
- 6. The licence holder is to ensure that the refusals log is properly maintained and checked on a weekly basis.

The selling of alcohol at the site would encourage drinking after the public houses have closed which would be detrimental to the neighbours and create a public nuisance. The requested opening hours are outside those agreed under the planning application and would have a detrimental effect on the amenities of the immediate neighbours.

We can see no reason for licensing these premises when only a short distance away there will soon be a Sainsburys store as well as existing Budgens Supermarket and two Co-operatives in the village that are licensed to sell alcohol as well as light refreshments until late hours. I suggest it would be quite wrong if a licence to sell alcohol from 6.00am until Midnight was granted in such a heavily populated residential area on a site which previously traded quietly.

It is already possible to buy alcohol in The High Street from 6.00am until 11.00pm and the town is amply provided with Pubs and Restaurants. You will be aware that the ESSO garage nearby on a less densely populated part of the B2177 does NOT sell alcohol at all and closes at 10.00pm,

With the UK slipping down national health ratings partly due to a significant proportion of the population using alcohol to excess, it would be wrong to allow alcohol to start to be sold on this site (it probably shouldn't be sold on any petrol forecourts) thereby encouraging drivers to come from miles around to get a last minute shot of vodka.

Sainsburys promised not to sell petrol at their out of town Superstore in BW and promptly bought the garage almost next door and now they want to sell alcohol on the site 18 hours a day (as well of course in the superstore). All the super markets are pushing their luck like this to the detriment of small town traders and residents living nearby.

I would ask the Licencing section not to fudge this issue by allowing alcohol to be sold for less than the 18 hours applied for. No alcohol should be sold on this site-full stop!

I am strongly opposed to this application.

While the area has been residential, it has even more dwellings now. The original Little Chef has been converted to flats next door. Likewise, opposite, the original kebab sales has not only been converted to dwellings but all of the land for the car park etc. is now dwellings. The Asphaltic site is now dwellings. Increased noise and disturbance (see below) would be suffered by the increased concentration of local residents.

There are already several responsible outlets, which sell alcoholic drinks in the area. This has dangers both (a) social as well (b) traffic related.

The hours from 0600 to 0000 are completely unacceptable.

1. The prevention of crime and disorder

The Winchester Road is a major thoroughfare in the area. It is inconceivable that people could stop drinking in, say, the Priory public house or other public houses in the town, and then be able to buy alcoholic drinks after 'drinking-up time'. This application could lead to disruptive behaviour in the area. A 'crowd' of drinkers could descend on the service station and continue in their rowdy way without concern for local residents. Their earlier consumption would lower their levels of awareness and responsibility.

Individuals or groups could be at risk from traffic. While there is a 30 mph speed limit, this is rarely adhered to. At whatever time of day or night drivers can think that there is a clear road and drive well in excess of the speed limit. This appears to be worse with btraffic coming from the Winchesr / Upham direction.

As discussed below, there is also the problem of under-age drinking. (Points 3 and 4 below.)

2. Public safety

This is a main road, which is used by heavy traffic during the day. Not only is there heavy traffic in the mornings and evenings, when people travel to and from work plus the school runs, Bishop's Waltham is used as a short cut from the Portsmouth area to get to the M3 at Winchester by lorry drivers of very big vehicles.

Any link between driving and alcohol consumption should not be allowed to take place. Thoughtless individuals should not be able to take a break, drink alcoholic drinks and then continue driving. (They may purchase the alcoholic drinks and consume them a short distance away from the service station.) There should be no close link between driving and the purchase of alcoholic drinks. A service station, which by definition is used by drivers, should not be such a point.

As noted above, individuals or groups could be at risk from traffic. While there is a 30 mph speed limit, this is rarely adhered to. At whatever time of day or night drivers can think that there is a clear road and accelerate.

The service station is very close to the roundabout for the B2177 (Winchester, Waltham Chase and Wickham) and the B3035 (Corhampton Road to the A32). There should not be the link between drinking and driving so close to a traffic island, which some drivers do not use responsibly e.g. driving at speed. Other drivers may inadvertently pull out of the service station, when vehicles have just come round the traffic island. There should be no link between drinking and driving at such a site.

3. The prevention of public nuisance

As noted above there is the strong possibility of noisy behaviour from drinkers.

There is the national concern about

- (a) the easy availability of purchasing strong alcoholic drinks from supermarkets (Sainsbury's is the applicant)
- (b) under-age drinking.

While the salesperson may sell to a person, who is eighteen years of age or older, there is no guarantee that it will not be consumed by someone younger than eighteen years of age.

A well lit area, whether it is the service station site or its immediate surrounding area, will be a magnet for young people.

This will lead to noise and nuisance to local residents.

They will also be at risk from the traffic.

4. The protection of children from harm

As noted above, there is a national concern about under-age drinking. It is widely known that alcohol is consumed by under-age drinkers, which is obtained from outlets.

This application should not be an opportunity for the problem to be exacerbated in the area around the service station and beyond

Irresponsible drivers, who may purchase and consume alcoholic drinks could put children at risk, when the drivers' ability to drive has been impaired.

This is an objection to the licence to sell alcoholic drinks. While Sainsbury's as a company may claim that their staff will be responsible, there is the danger that problems will arise in the immediate area and beyond.

There are several outlets in the area, which sell alcoholic drinks responsibly. They also operate in reasonable hours: **not** 0600 to 0000.

One needs to:

(a) take a wider view of the social factors, which can arise from an outlet, which sells alcoholic drinks

(b) there should not be the easy availability of alcoholic drinks to drivers on a very busy road. There is not only for traffic to and from the M3 but the Winchester Road is also a major local thoroughfare from local pedestrians (including older people who may not cross the road quickly and young mothers with babies and young children), cyclists and drivers.

I am writing to object to the application from Sainsbury's Supermarkets Ltd to sell alcohol to take off the premises between the hours of 0600 to 0000 daily.

It is totally unnecessary and totally inappropriate for alcohol to be sold from a petrol station forecourt.

In July 2012 Rowlands Castle Parish Council won a landmark ruling from the High Court against Shell concerning the sale of alcohol from Whichers Gate Garage. The High Court ruled that as it was primarily a garage forecourt this was not acceptable. Sainsbury's are replacing a petrol station with another one they are constructing from new. It will not primarily be a convenience store, but a garage forecourt shop, therefore the same ruling would apply as for Whicher's Gate Garage. Sainsbury's cannot argue that they are constructing a convenience store, since they have acquired the site specifically to sell petrol to customers from their planned supermarket on the Abbey Mill site.

As regards opening hours, I wish to object to the proposal to open from 0600 until 0000. No other retail outlet in Bishops Waltham opens later than the Co-operative which closes at 23.00. This part of Winchester Road has changed greatly in character in recent years. Since the building of several developments of flats, it is now predominantly residential and the local people will not welcome late night disturbance.

Although it may seem that Bishops Waltham is not a particularly difficult area for social problems we have had a continuous problem with bored young people with nowhere to go. Late night retail with the chance of the purchase of alcohol is too tempting for young people looking for entertainment. Recently a great deal of effort has gone into re-opening the Youth hall to try and reduce this problem - easy access to alcohol will undo a lot of that good work.

These are my objections, i hope very much you will turn down this




