#### Part A.

#### 1. Application

**Applicant:** Amsric Foods Limited

Premises: KFC, 47 Upper Brook Street, Winchester, Hampshire, SO23 8DG

- 1.1 This report relates to a new Premises Licence application under Section 17 of the Licensing Act 2003 for KFC, 47 Upper Brook Street, Winchester, Hampshire, SO23 8DG.
- 1.2 The purpose of the application is to allow for the provision of late night refreshment on Fridays and Saturdays between 2300 and 0400 the following day.
- 1.3 Representations were received from local residents objecting to the application in relation to the public nuisance licensing objective. The list of residents who have submitted representations can be found at Section 3 of the report and copies of the representations can be found at Appendix 3.
- 1.4 Representations were also received from PC Brian Swallow on behalf of Hampshire Constabulary and Mr Phil Tidridge on behalf of Winchester City Council's Environmental Health Team, both of which are responsible authorities. These representations relate to the prevention of crime and disorder and the public nuisance licensing objectives. Copies of these can be found at Appendix 2.

#### 4. Observations

The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

In making its decision, the Sub-Committee is also obliged to have regard to the National Guidance and the Council's Licensing Policy.

The Sub-Committee must have regard to all of the representations.

The Sub-Committee must take such of the following steps it considers appropriate to promote the Licensing Objectives:

- Grant the licence subject to conditions in accordance with the operating schedule (modified to such extent as the authority considers appropriate for the promotion of the licensing objectives) and the mandatory conditions:
- 2. exclude from the scope of the licence any of the licensable activities to which the application relates;
- 3. reject the application.

#### **Terminal hours**

The Sub-Committee should take account of the National Guidance and the Council's Licensing Policy with regard to terminal hours and take such steps as it considers appropriate to promote the Licensing Objectives.

(Licensing Policy Part 4, A8)

#### Licensing Objectives.

#### Crime and Disorder

The Sub-Committee should consider any appropriate conditions to prevent crime and public disorder relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy 1.6, 2.11, 2.17)

#### Public Safety

The Sub-Committee should consider any appropriate conditions relating to public safety having regard to the relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, B3, B4)

#### **Public Nuisance**

The Sub-Committee should consider any appropriate conditions to prevent public nuisance caused by noise and light pollution from the premises relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, Section C)

#### Protection of Children

The Sub-Committee should consider any necessary conditions for the Protection of Children relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, D6, D7)

#### **Human Rights**

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, appropriate in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

#### 5. <u>Conditions</u>

**Mandatory Conditions** 

There are no mandatory conditions that relate to the supply of late night refreshment.

Should security be provided at the premises, the following mandatory condition would apply;

Where individuals are required on premises to carry out security activities, they must be licensed by the Security Industry Authority.

#### **Possible Conditions**

If the application is granted, the Sub-Committee may wish to consider the following conditions to reflect the Operating Schedule:

#### Operating Hours

- 1. The hours the premises may be used the provision of late night refreshment shall be:
  - (i) Friday and Saturday 2300 to 0400 the following day

#### **All Licensing Objectives**

#### **Crime and Disorder**

1. One member of SIA security personnel will be on the premises on Fridays and Saturdays between 2300 and 0200 the following day.

#### **Public Nuisance**

- 1. Prominent, clear notices shall be displayed at all exits requesting customers to respect the needs of local residents, to leave the premises and the area quietly.
- 2. Staff shall be given appropriate instructions and training to encourage customers to leave the premises quietly and not to loiter in the vicinity of the premises so as to minimize disturbance to local residents.
- 3. The premises licence holder shall ensure that the number of litter bins in the vicinity of the premises will be increased.

## **Protection of Children**

- 1. Customers shall not be permitted to bring alcohol onto the premises.
- 2. No person who appears to be intoxicated will be allowed to enter the premises.

## 6. Other Considerations

#### **Resource Implications**

This is an application for a late night refreshment licence to be granted to an existing fast food retail outlet. The application seeks the provision of LNR on Friday and Saturday's from 23:00-04:00.

The Chief Officer of Police is making representations regarding this application under the licensing objectives of:

The Prevention of Crime and Disorder

**Public Safety** 

The Prevention of Public Nuisance

A few token steps are mentioned within the application as to how the licensing objectives are to be promoted:

The application states that there are CCTV cameras on site. I am unaware if these cameras have a recording facility and if they do, for how long the images are stored for, or to what standard of quality images are produced. None of this is explained in any detail or expanded upon within the application.

The applicant states that "if we receive complaints that are justifiable" they would employ "A" security guard between 23:00 and 02:00. I am not sure why their timings for this are so specific, especially as the application requests the provision of LNR until 04:00. It is also disappointing to read that they will wait until there are complaints rather than to be proactive and to prevent them in the first instance.

They will increase the number of litter bins "if needed and necessary" Again I would have expected a more proactive approach to this issue.

The applicant also states that they will "prevent any customer who obviously appears drunk from entering the store" How?

The police have serious concerns with regards to this application. It is our belief that the application is being made to benefit from the exiting footfall from the very near by; Vodka Bar night club.

Upper Brook Street also contains the official taxi rank for the area.

Persons coming from the nightclub late at night are predominantly in a state of intoxication. Inhibitions are lowered, bravado is increased. People talk louder and have less respect for persons, residents, their property and littering is increased.

As such, incidents of alcohol fuelled anti social behaviour, assaults and crimes against property are already prevalent within the area that can be directly attributed to the nightclub and persons who have frequented it. From police crime statistics held on the police Record Management System, these peak towards the end of the trading hours for the night.

A late night food venue very near to the nightclub will hinder the dispersal away from the club and area. People will use the restaurant as gathering place.

They will be intoxicated. As mentioned above, the applicant has said that intoxicated people will not be allowed entry into the restaurant but have not offered SIA security personnel as a

condition to fully promote the licensing objective.

By refusing entry, conflict will occur; the risk of assaults and public order situations is increased. In order to perform a security function, i.e. to prevent entry or remove persons by force; you have to be SIA registered as defined by the security Industries Act and mandatory licensing condition.

CCTV is also not only a proven deterrent and a device for monitoring staff and building safety and security but a valuable tool for capturing images for evidence following incidents. The lack of any information upon the application regarding the CCTV undermines the application.

Unless the above concerns can be alleviated by the applicant, the police object to this application in its entirety.

This premises has residential properties in close proximity. The operation until 4am on Friday and Saturday nights is likely to attract persons from the nearby night club, which is referenced in the application. It is my view that such persons will therefore be encouraged to remain in the area consuming take away food rather than dispersing. Such persons are usually in some state of intoxication and are therefore more likely to cause a noise disturbance.

#### Please state grounds for representation (con'd)

The applicant has stated that they will prevent drunk persons entering the premises but it is considered from a noise perspective such individuals have already been attracted to this location and noise disturbance will have occurred irrespective if they are served. Refusing access may in fact cause arguments to occur increasing noise disturbance. Similarly I am not convinced that CCTV or SIA guards will prevent persons congregating in the area, it will simply move the problem from immediately outside the premises, potentially nearer to residential dwellings. Further it is unclear why the suggestion of SIA guards, if complaints are received, would only be between the hours of 11pm and 2am. The notice asking customers to "respect the privacy and feelings of any neighbouring units." is suggested but only "subject to KFC approval" so it is unclear at this stage if this notice could in fact be provided.

I therefore do not consider that the controls measures offered by the applicant will prevent the potential for public nuisance from noise discussed above.

NOTE - Although not a material consideration with regards to this representation the applicant is also advised that there are restrictions on the existing planning permission (07/02345/FUL) which restricts opening hours from 11:00 until 23:00. This condition was included for exactly the same concerns as expressed above.

As residents in Upper Brook Street, we are aware of the popularity of the said takeaway and are concerned that the revised opening hours could impact on the licensing objectives.

My concern refers to the licensing objective "prevention of public nuisance" on a weekly basis we are subjected to noise, litter, fighting and public disorder in the early hours from people leaving the city centre pubs and bars. Should KFC have their application granted there would be an increase in the footfall in the street and with this the increase of the above disturbances.

I am writing regarding the licensing application for KFC, 47 Upper Brook Street, Winchester, Hampshire, SO23 8DG covered by Document 2742, received from Amsric Food Limited Friar House Copse Road St Johns Woking Surrey GU21 8ST.

As a resident of Upper Brook Street, I wish to register my objection to this application on the following grounds;-

# The prevention of public nuisance

Upper Brook Street is, in the main, a residential street located within the Winchester Conservation area. This places certain restrictions upon what residents may do that may damage the conservation of the area. Unfortunately there are a number of businesses in the same street which cause considerable disturbance/nuisance. These include KFC, 47 Upper Brook Street in that it is a restaurant that also provides a take away service. This results in considerable nuisance in the form of noise, litter, congestion and smell which affects the environment along the whole street.

Whether there is a requirement for such "refreshment" on "Friday and Saturday from 2300 to 0400 the following day" is debateable. However the extension of opening hours over such a long period can only lead to an increase in nuisance and disturbance to residents along with an increase of litter along the street. With the proposal to develop a new surgery on the site of the carpark opposite, it can only be that any customers visiting the premesis will have to park in the carpark on the opposite side of North Walls and then walk to and from the premesis along the entire length of Upper Brook Street. This will extend after midnight when most residents are trying, often with difficulty, to sleep. It is also likely as is now the case that some vehicles will be left at the side of the road causing further congestion in an already overloaded thoroughfare.

### Public Safety

There is often waste (litter) from the particular premesis left by customers in the street. If this contains food it is a potential health hazard as it attracts vermin. Increased quantities can only result in an increased health risk.

### Disorder

There is already considerable noise and disorder (including altercations) late at night from customers of facilities around this premisis. Extending these hours and the potential for a number of eating and drinking establishments to be open with this proposal for most of the night will only increase the incidence of disorder.

I implore you to reject this licensing application as it will cause considerable issues for residents.

(One assumes that if granted the company concerned will close much earlier on Sundays in order to comply with Sunday trading laws.)

# Representation against the application of KFC, Upper Brook Street, to extend their opening hours

I am writing to object to the application of Amsric Food Limited for a New Premises Licence for KFC, 47 Upper Brook Street, Winchester. As a local resident, who is already affected by litter and noise resulting from late night establishments in the city centre, I do not believe that this licence should be supplied.

In relation to the prevention of crime and disorder: there have been a number of occasions, where people have been disruptive and potentially dangerous late at night, who have visited the KFC on Upper Brook Street (marked by their takeaway bags). There have been heated arguments with extremely foul language, and those involved have become violent. On one occasion, one of the residents went outside to intervene as it was aimed at a young female. If the licence is given, there will be more incidents like this, and with more likelihood of drunk and vulnerable individuals being involved. This is not only a risk for those involved but for residents who wish to keep the peace around their homes.

In relation to public safety, the prevention of public nuisance and the protection of children from harm: the takeaways on the road encourage people in the evening to an otherwise quiet residential street. It is concerning that this may continue into the night if the licence is given. Often people wait in the Upper Brook Street car park whilst others collect their takeaway from KFC or Dominos. There have been numerous occasions where people have played extremely loud music whilst waiting, which has caused many people on the street to come outside their homes to find out what is causing it. While it is inconvenient for adults, this noise is extremely disruptive for children and infants, of which there are a growing number on the street. Whilst Dominos is currently open later than KFC, this has minimal impact on residents, due to the late night orders only being available by delivery, rather than collection.

In relation to the prevention of crime and disorder: last year, two young males climbed a wall into the Heritage Centre and were witnessed to be tampering with one of the cars parked there. Whilst this cannot be directly connected to either of the food establishments, the opening of late night establishments will increase the likelihood of this behaviour.

I believe that if KFC extends its opening hours, it will become a place where crowds gather when they leave the nearby nightclub, and that Upper Brook Street will become a footpath for students and other revellers on their way home after a night out. I don't believe that the road would remain a family-neighbourhood and I would reconsider my residency here.

### Representation against the application to extend the opening hours of KFC, Upper Brook Street

I am writing to oppose the application of KFC, 47 Upper Brook Street, Winchester by Amsric Food Limited for a New Premises Licence. As a local resident, who is already affected by the results of late night establishments in the city centre, I do not believe that this licence should be granted.

My objection is partly based on the prevention of public nuisance. I firmly believe that the extension of KFC's opening hours will increase both noise and litter. My garden is already regularly polluted with discarded bags and napkins that are branded with the KFC logo. If the opening hours are extended, it is more likely that the customers will have been drinking beforehand, and will be less conscious about disposing of their rubbish appropriately.

As well as the prevention of public nuisance, my objection is based on the protection of children from harm. During certain times of the year, the road is already affected by customers of the bars and clubs in the city centre, especially as it is a route home for students. This impacts the residents with noisy, inappropriate language and behaviour, litter from takeaways, bottles and often vomit on the pavements. The language can be extremely foul, and due to the proximity of houses to the pavement, conversations can be heard clearly inside our homes. There have been instances where people have become violent on the road, which is frightening for both children and adults. However, this is completely inappropriate for children and infants to be hearing or witnessing.

I believe that this would also be at risk of affecting public safety. Winchester is a very safe city, especially the area that we live in. Currently, it feels safe to walk home from the railway station at night, however if the licence is extended, I would not be comfortable if my partner or I were to walk back at night. With more people loitering around KFC and the car park, especially if they are under the influence of alcohol or drugs, there is increased risk that something would happen, from verbal to physical assaults.

To protect both residents and the reputation of the city, I feel that this application should be rejected.

As a long term resident (22 years) of Upper Brook Street, I wish to oppose the agreement to allow KFC to extend their opening hours until 4 am. This area of Winchester has been serviced by take away food outlets for many, many years. The pollution from the back of them has spoiled the residents of Parchment Street enjoyment of the use of their gardens and has allowed drunken customers from the Vodka Night Club to purchase food, as they leave the night club right up until 2,00-2.30pm. Some of them sit on the wall of the car park opposite, and scream, shout, vomit and generally display bad behaviour. In spite of the existing rubbish bins being available on the spot, they toss masses of litter into the car park area and those who do walk on with their food, continue to distribute the packaging along the pavements and gardens of Upper Brook Street and other residential areas nearby. It makes me very angry when I get up in the morning to find beer cans etc. floating in my small pond in my front garden.

However the worst and most annoying part of having these food outlets nearby is the amount of screaming, shouting and bad behaviour, which residents have to put up with, as these drunken customers wend their way home in the early hours. It is particularly bad on Friday and Saturday nights and I would be extremely concerned if the KFC would get permission to stay open until four in the morning

As a resident at 8 Merchants Place, Upper Brook Street, Winchester, I wish to protest most strongly against a grant of the above Licence, on the following grounds:

Prevention of Crime and Disorder: however tightly the venue and its environs might be controlled, there would be even more scope than already exists via the Vodka Bar nightclub for drunken people to misbehave and commit crime around the area in the early hours of the morning. Additional strain will be put on the Police, and additional costs will be incurred to be borne by the taxpayer.

Public Safety: alcohol-fuelled individuals and groups already pose a threat in the area, and this would be likely to increase exponentially. We hear fights and screaming on a regular basis at night.

Public Nuisance: we are woken regularly by the noise made by people entering or leaving the Vodka Bar, and that venue is situated 50 yards further away from us than KFC. In addition, extended hours will almost certainly generate more litter, and KFC already has a problem in coping with current litter levels. And you can bet that Domino's Pizza would not waste any time in applying for a similar Licence if this one were to be granted.

The protection of Children from harm: to extend refreshment hours in this area would increase the opportunities for young, often underage, girls to be preyed upon.

Upper Brook Street and the neighbouring streets constitute a highly residential area. It has already been blighted by the food outlets and the nightclub. Property values are affected adversely, and would be further diminished should this licence be granted. The Council should put the concerns of its residents at the top rather than at the bottom of its priorities, the latter of which has been the case hereto.

I am writing to register my objection to the application for a New Premises Licence for KFC, 47 Upper Brook Street, Winchester, Hampshire, SO23 8DG.

I am a resident of Upper Brook Street and am concerned that extending KFC hours will attract more people, late at night, to Upper Brook Street. These people will then walk down the residential part of Upper Brook Street on their way home. It effectively funnels people from town, down the residential part of the street. A number of late night revellers already use this route and cause disruption down the street. Extending the opening hours will make this worse and prolong the time in which this happens.

I object for the following reasons:

# The Prevention of Public Nuisance

The terraced houses of Upper Brook Street face directly onto the street, there are no gardens to block out the noise. People walking down the street from the late night restaurants are often loud and drunk. I am frequently woken by shouting, singing and fighting. They often stop at one of the two raised flower beds to eat their takeaways. This is immensely noisy and can last a while. They frequently leave their food wrappers. Both KFC and Dominos rubbish is found in these flower beds and on the street.

### The Prevention of Crime and Disorder

People walking down the street from these restaurants are often drunk and can be threatening, particularly as they are often in groups. They can damage the buildings and cars.

For example, I have had the windscreen wipers of my car bent and on a separate occasion, have found footprints on my car. The gutter downpipes have been pulled off the wall (one is currently loose) and cable boxes have been broken. These crimes are all too minor to report to the police but they are a big inconvenience and cost money to repair.

I have also heard fights outside my house.

### Public safety

Threatening behaviour of groups as mentioned above. On occasions I have returned home late and felt scared to enter my own house as there have been people sitting on the flower bed outside my house. Also, the litter and vomit left on the street is a cause of concern to health.

### The protection of Children from harm.

Sleep deprivation due to the noise. Health issues of food waste, vomit and rubbish

Extending the licensing hours will attract more people from town to Upper Brook Street and funnel them down the residential part of the street thus increasing and prolonging the disturbance to residents. Please don't allow it.

We write to object to the recent application made by Amsric Food Limited to open KFC, 47 Upper Brook Street, Winchester, Hampshire, SO23 8DG.

I understand the four licensing objectives that have to be considered are set out below and I understand objections have to be filed by today - I am not aware of any specific time by when the objections had to be filed today.

- The prevention of crime and disorder

The KFC is located next to the local nightclub, Vodka Bar. This already leads to Police often being called out due to antisocial behaviour and violence.

By having KFC open till 4am on Friday and Saturday evening, this is only likely to lead to people loitering outside even more and this will no doubt lead to an increase in conflicts and potential violent behaviour. The wall opposite KFC is often used in the day by people when eating their KFC and this will no doubt increase in the night time should the licence be granted.

It is inevitable that, given it will be one of the only food premises open so late in the evening, that this will lead to further people arriving when the pubs and clubs close around the local area. Taking into consideration the fact that people will loiter and the amount of people that will be there, this will no doubt lead to increase in crime in the area; including violence and criminal damage to property and cars.

As a young couple (mid 20s) we often see on our way home from a night out in other towns that fights can easily erupt outside such food establishments and whilst this is not appropriate in any circumstances, it is certainly not appropriate so close to residential housing and nor would it be safe for local residents.

Further, KFC Eastleigh has had a number of incidents occur late at night in the past with its later opening hours and this means the KFC staff could be subjected to intimidating and violent behaviour.

- Public safety

There are a number of elderly residents along Upper Brook Street and they will no doubt feel endangered and intimidated by

The prevention of public nuisance and cause them to fear for their own safety.

Further, it goes without saying that there is a risk of when people are returning to their homes late at night that if crowds of people are gathering outside KFC after nights out that this could lead to resident's safety being endangered.

- The prevention of public nuisance

The extended opening hours will lead to large numbers of crowds being extremely close to residential propertys and no doubt will lead to many people diverting their journies via KFC on the way home. It is already a relatively noisey street to live along in the evenings and we often hear fights/arguments taking place outside our property which disrupts residents' enjoyment of their properties.

If KFC is open till 4am, this will significantly increase and continue to later on in the evening. Further, littering will increase given people will not take due consideration when drunk and disposing of their rubbish. There is already a significant amount of litter along the roads which seems to increase at weekends and this will be worsened by the extended open hours.

- The protection of children from harm

Whilst children should not be out this late, the after effect the following day could cause harm to children if there have been fights and, for instance, glass bottles have been smashed along the ground which could cause harm to a child.

We trust that, in light of the above and the objections we understand have been filed by the Police and many other residents, that the application will be refused.

Taking into consideration that residents were asked to remove their skydishes from the front of their properties as it is not "in keeping" with the surroundings/buildings, I find it hard to see how a fast food establishment open till 4am is appropriate and it would make us question there was an ulterior purpose should this application be accepted.




