Head of Landscape (Trees) No Objection subject to conditions

Change of wording to condition 11 and addition of conditions 13 – 15 relating to tree protection:

- 11 Prior to the commencement of development plans/sections showing proposed ground levels and finished ground floor levels above AOD of the new building in relation to existing ground levels and levels of neighbouring buildings shall be submitted to and approved in writing by the Local Planning Authority. The development shall not be completed other than in accordance with the approved details.
- 11 Reason: In order to ensure that the proposal does not have a detrimental impact on the residential amenity of neighbouring properties, and has an acceptable impact on the character of the area, as required by policy DP3 of the Winchester District Local Plan Review 2006.
- 13 Protective measures, including fencing and ground protection, in accordance with the Arboricultural Method Statement reference AMS 19BA/07115/PC written by Mr. Peter Harding of Pyramid Consulting and submitted to the Local Planning Authority shall be installed prior to any demolition, construction or groundwork commencing on the site.

Inspection of fencing

A representation has been received responding to the Lighting assessment raising a number of points:

In particular the report does not record the date when the measurements were taken and thus gives no reference to or allowance for:

- the phase of the moon and its effect on the ambient light?
- the prevailing weather and level of cloud cover?
- the state of the foliage on the trees and their reflective properties.
- the fact that the light is on from 7.00am through to the dawn period for many months of the year, which produces an entirely different effect.
- the parameters being measured when the light is switched off at 10.00pm are clearly no indication of the real human impact of the light on the amenity of the area, as any first hand observation would confirm.
- the report uses as a datum reference, standards that apply to two story houses or bungalows. All the affected houses are in fact three stories.
- -although reference is made to the Institute of Lighting Professionals the report chooses to entirely ignore the fact that their main recommendation for such an installation is the use of precisely directed down lighters? This would also neatly solve the vandalism problem.
