


Background - The lack of affordable housing is considered to be a serious national as well as local issue. It is therefore important that Members are advised on the local supply and demand information to enable the local context to be scrutinised.


Progress - The end of year total for new completions is 143 (original estimate 100). The long term trend in total number of households on the waiting list has continued to rise although and is now at an all time high reflecting the difficulties of households in accessing the property market.


Issues - Property prices in the Hampshire postcode area have remained stable over the period May 2010 to April 2011. The volume of sales has fallen by 40% (source Land Registry). Property prices have now generally recovered to the 2007 peak.


Resources - In order to access its far share of the resources available from the Homes and Communities Agency the Council must ensure the continued supply of land for new housing as well as offering encouragement for Developers to bring sites forward despite the economic downturn.
















Sport and Physical Activity Report Card
