EXECUTIVE SUMMARY:

This Report asks the Committee to appoint six Councillors nominated from its membership to lead Informal Scrutiny Groups (ISGs) for the 2015/16 Municipal Year. Existing ISGs are set out in the Scrutiny Work Programme (Report OS125 refers, elsewhere on the agenda).

The Report also requests appointments to four other bodies that it would be appropriate for The Overview and Scrutiny Committee to appoint representatives to. These are detailed at paragraph 3 of the Report.

Finally, Members are also asked to confirm appointments proposed by Group Managers to the River Park Leisure Centre ISG and the Hampshire Home Choice ISG established at previous meetings of the Committee.

DETAIL:

- 1 <u>Background</u>
- 1.1 This Report asks the Committee to appoint six Councillors nominated from its membership to lead Informal Scrutiny Groups (ISGs) for the 2015/16 Municipal Year. Members are also asked to consider appointments of non-executive Members to four other bodies related to scrutiny.
- 1.3 Members are also asked to confirm appointments proposed by Group Managers to ISGs established at the previous meetings of the Committee and also at full Council (where applicable).

2 Appointments to lead Informal Scrutiny Groups (ISGs)

- 2.1 The ISG lead Councillors guide and manage a previously agreed programme of ISGs throughout the year. These ISGs are set out in the Scrutiny Work Programme (Report OS125 refers, elsewhere on the agenda).
- 2.2 The Committee is therefore asked to consider six appointments from its membership to lead Informal Scrutiny Groups (ISGs) for the 2015/16 Municipal Year.
- 2.3 For information, the existing scrutiny lead Members are as follows:
 - a) Councillor Power
 - b) Councillor Sanders
 - c) Councillor Cook
 - d) Councillor Wright
 - e) Councillor Evans
 - f) Councillor Byrnes

2.4 The nominations received for 2015/16 are as follows:

Councillors Gemmell, Humby, Sanders and Stallard (Conservative) Councillors Hiscock and Tod (Liberal Democrat)

3. At its meeting on 19 January 2015, The Overview and Scrutiny Committee agreed to establish an Informal Scrutiny Group (ISG) to overview the work undertaken by Hampshire Home Choice. Councillor Byrnes was appointed to Chair this meeting. However, following his appointment to Cabinet, a Chair has not been appointed in his place. As a result the Committee will need to appoint a Chair for this ISG in addition to the remainder of the membership.

4. Appointments to External Bodies related to Scrutiny

4.1 There are currently four external bodies that it would be appropriate for The Overview and Scrutiny Committee to appoint non Executive Member representatives to. These are detailed below.

4.2 Portsmouth City Council - Health Overview and Scrutiny Panel

This Panel was established by Portsmouth City Council. Its membership is drawn from appropriate interest groups, stakeholders and Councillors from adjoining local authorities 'when discussing issues that have significant effect upon their area'.

The current Winchester City Council representatives are Councillor Read and Councillor Newman-McKie (deputy).

4.3 The Centre for Public Scrutiny (CfPS) – Scrutiny Champions' Network

The CfPS has previously requested a Member representative as a 'scrutiny champion' for the Council. The Member receives a monthly bulletin and is also invited to attend an Annual Conference. The current representative is the Chairman of The Overview and Scrutiny Committee and it is suggested that the Chairman of The Overview and Scrutiny Committee remains as the appointed representative for 2015/16.

4.4 Partnership for Urban South Hampshire Overview & Scrutiny Committee

The Partnership for Urban South Hampshire (PUSH) established a PUSH Overview and Scrutiny Committee in 2007 and it has previously been agreed that the Committee appoint a non-executive representative from those Wards within the PUSH area.

The Council's current representatives are Councillor Gemmell (Deputy Councillor Achwal.

4.5 <u>Environmental Services Joint Scrutiny Committee (ESJSC) (with East Hants</u> <u>District Council)</u>

At its meeting held on 17 September 2012, The Overview and Scrutiny Committee established this Joint Scrutiny Committee with terms of reference as set out in Appendix 1. Members are reminded that at its meeting on 7 April 2014, the Committee resolved to change its name from the Joint Environmental Services

Scrutiny Committee (JESSC) to the above, to avoid confusion with the Joint Environmental Services Committee (JESC) which is the executive body. The terms of reference were amended to reflect the name change, attached as Appendix 1 below.

The Committee met on two occasions in 2014/15 with the following membership:

Winchester City Councillors: Thompson (Chair), McLean and Pines (deputy J Berry)

East Hampshire District Councillors: Onslow (deputy Denston) and two other Councillors (tba)

In order for the meeting to be quorate, three Members from either Winchester City Council or East Hants District Council would need to be present.

It is meeting held on 16 February 2015, the Chairman of The Overview and announced that minutes of the Joint Environmental Services Scrutiny Committee (JESSC) would be taken to future meetings of the Committee for Members' consideration.

When appointing to external bodies, the Committee should be satisfied that these arrangements are supporting or scrutinising the delivery of the Council's priorities, or working towards identifying future priorities.

When selecting the number of ISG topics each year, The Overview and Scrutiny Committee should give consideration to the likely number of meetings that will take place and the officer time that will be required. Appendix 1

Terms of reference - Environmental Services Joint Scrutiny Committee (ESJSC)

- 1. The following principles will apply to the work of the ESJSC:
 - a) The ESJSC may raise any issues directly with the Joint Environmental Services Committee.
 - b) The ESJSC may also raise any issues with the parent Councils. Each Council will determine its own procedures as to whether the report back will go to the Council's appropriate parent scrutiny committee or direct to their respective Cabinets or portfolio holders.
 - c) An annual report will be produced by the ESJSC and reported to the parent scrutiny committees of each Council.
 - d) Any matters of concern will be referred to the parent Councils if requested by resolution of the Committee or at least 2 or more Members from either authority.
- 2. The role of the ESJSC will be as follows:
 - a) To have a general remit to scrutinise any executive decision made by the Joint Environmental Services Committee.
 - b) To have the right to review Joint Environmental Services Committee policies insofar as the policy concerned relates to the delivery of Environmental Services.
 - c) To have authority to require any member of the Joint Environmental Services Committee or any Officer of the Joint Client Team to assist in its work by attending at a meeting of the Committee, by supplying information or by other means.
 - d) To have an overview of performance and use of resources in respect of the services within the responsibility of the Joint Environmental Services Committee including but not restricted to
 - The Joint Client Team;
 - The Contractors;
 - Implementation of work programmes;
 - Performance against national and local performance indicators;
 - Identification of risks and monitoring action taken to mitigate those risks and responsibility for the monitoring and implementation of action plans.
 - e) To monitor developments within the Project Integra Partnership and scrutinise its performance and policy development in terms of the impact upon the work of the ESJSC.

To hold the Joint Environmental Services Committee and relevant Portfolio Holders at each authority to account for the services within their areas of responsibility.
