- 1.1. Members will remember that to date, the Forum has considered:

- 1.2. The only public meeting set for 2005 is:

2.4. A Possible Ban on Smoking in Public Places: A Notice of Motion has been submitted for consideration at the 5 January 2005 meeting of Council and further investigation is likely to be necessary before the City Council is able to determine its stance on this issue.

# 3. <u>Background Information</u>

- 3.1. The previous report that set the programme for public meetings (WTF31) included a review the results of the Best Value Performance Indicator Satisfaction Survey (2003/4). Members may consider the repetition of this at Appendix One helpful. This Survey selected 2,500 people at random from the Post Office Address file and achieved a response rate of 56.4% (1,409 people).
- 3.2. An analysis of the responses of those that lived in the town centre wards (postcodes SO22 and SO23) showed no significant differences in what people thought was important to make somewhere a good place to live and what they though most needed improving.
