'Cittaslow' - the Slow Cities Movement

1 <u>Introduction</u>

- 1.1 At the Town Forum on 4th November which discussed the 'Vision for Winchester' project, the City of Winchester Trust brought to the forum's attention the concept of *Cittaslow*.
- 1.2 In order to investigate *Cittaslow* the Trust sent a delegation to Ludlow, the first *Cittaslow* accredited town in Britain, to explore what it meant to be a *Cittaslow*, and whether it would be a designation worth pursuing for Winchester town.

 Antonia Perkins attended the visit as a City Council representative.
- 1.3 The City of Winchester Trust is keen to gain the *Cittaslow* designation for Winchester, and is seeking a response from the City Council as to whether or not it will actively support the movement and, if so, in what capacity. Antonia is currently the principal contact for the Trust.
- 1.4 This report describes the *Cittaslow* movement, how it was setup in Ludlow and sets out benefits and concerns regarding a possible application by Winchester to join the movement for consideration.

2 The Cittaslow Movement

- 2.1 *Cittaslow* started in Italy as an international movement founded on the back of the Slow Food movement. It aims to provide a set of goals and aspirations for small towns based on the following principles:
 - encourage diversity not standardisation
 - support and encourage local culture and traditions
 - work for a more sustainable environment
 - support and encourage local produce and products
 - encourage healthy living especially through children and young people
 - work with the local community to build these values
- 2.2 To join the movement, a town must not have a population of more than 50,000. It also must not be a county town, although there is some dispute as to whether the original intention in Italy was to exclude provincial towns, which would not necessarily align with English county towns.
- 2.3 To be accredited as a Slow City, a town must assess itself in relation to a set of goals (**Appendix A**) under the headings: Environment, Infrastructure, Urban Fabric, Local Produce and Products, Hospitality and Awareness. The town is required to initially to comply with at least 30% of the aspirations, and subsequently work to attain all the *Cittaslow* goals.
- 2.4 The town is then required to pay a 500 euro fee to the international *Cittaslow* Co-ordination Committee, followed by an annual subscription.

3 The Movement in Ludlow

- 3.1 *Cittaslow* was initiated in Ludlow by the Ludlow 21 Group, their Local Agenda 21 group. This was then launched at a public meeting, involving organisations such as the Chamber of Commerce, the Civic Society, the Women's Institute and South Shropshire Tourism.
- 3.2 Ludlow's role as a *Cittaslow* is overseen and owned by a sub-committee of Ludlow Town Council. The committee is made up of a variety of local organisations, including a district council Member and three officers.
- 3.3 The project forms part of the area's Market Towns strategy, and links to the Ludlow Marches Partnership which was set up to oversee the area's Market Town Healthcheck.
- 3.4 The South Shropshire District Council does not fund the project, although three of its officers are closely involved in the project's work, particularly the conservation officer.
- 3.5 The Chair of the *Cittaslow* sub-committee in Ludlow recommended that the idea of *Cittaslow* be seen as management tool rather than a range of new, individual projects. She felt that the role of the sub-committee is to lobby and influence organisations, (particularly statutory organisation) to achieve *Cittaslow* goals, and to give focus and identity to disparate organisations in order to help co-ordinate their efforts.
- 3.6 One of the principal areas in which the *Cittaslow* sub-committee has sought to influence and lobby the district council is in planning. The *Cittaslow* ideal is for shopping districts to contain small, independent shops as opposed to large amounts of chain stores. Chain stores wishing to open a branch in Ludlow are subject to the uncompromising enforcement of planning restrictions, even at the expense of the withdrawal of an application, in order for the town centre to maintain its historic character.
- 3.7 Two separate projects have commenced under the *Cittaslow* banner. Firstly an after-school club has been set up in partnership with restaurateurs to demonstrate cooking with local produce. These clubs also serve to help those attending gain qualifications in basic food hygiene. The second project is coordinated by the district council's conservation officer, encouraging the setting up of a lime centre and the re-opening of quarries to promote the use of traditional building skills and to provide local building materials which are used in historic building restoration work in Ludlow.

4 Links to current City Council initiatives

- 4.1 The goals of *Cittaslow* clearly describe sustainable development and principles which the City Council, as well as its partners, is working towards. The goals and aims of *Cittaslow* deal with improving the quality of life for residents and visitors and so there is the potential that this movement could align with Community Strategy aims and goals, with this project dealing specifically with the Winchester town area.
- 4.2 Many of the goals listed as the *Cittaslow* criteria are being worked towards either by the City Council, the Local Strategic partnership or by the Council's partners. Participation, therefore, in a movement to gain *Cittaslow* status

would therefore be relatively simply and mainly require co-ordination of our and others' efforts.

- 4.3 The *Cittaslow* idea can be considered as another aspect of community planning, along with Parish Plans and Market Town Healthchecks, for example. As such, this process could potentially provide an opportunity to gain community and cross sector involvement in informing the future of Winchester town. Undertaking this community planning exercise under the banner of *Cittaslow* may also have the potential to provide a brand to which people find it easy to understand and relate.
- 4.4 The benefits of being involved in an application for Winchester to become a *Cittaslow* include the potential for a high community participation rate in the project. The City Council's involvement will also add a degree of democratic legitimacy to the process.

5 Issues to be considered

- 5.1 The City Council is involved in a number of initiatives, and whilst the *Cittaslow* vision could link in with the Community Strategy and the work of the LSP, it may practically be difficult to gain ownership of a *Cittaslow* project and work will need to be done in creating a means for it to inform future Community Strategies. If work to achieve *Cittaslow* status is led by external organisations, it may be difficult to influence the project in a way so that it can be used by the LSP to inform its work.
- 5.2 The creation of the parallel 'Vision for Winchester' document may mean that work is being duplicated in creating a vision for Winchester town. These two may be in tension and cause confusion not only for residents, but for organisations which may be approached separately to work to achieve each vision. The City Council may want to decide to only support the 'Vision for Winchester', and promote community and partner involvement in this project, whilst capturing some of the *Cittaslow* ideals in the 'Vision for Winchester'.
- 5.3 The *Cittaslow* principles are far reaching, and seek to positively influence a wide variety of aspects which go to make up 'quality of life' for a resident or visitor. There is a danger that one aspect may receive more attention than others, to the detriment of the inclusivity of *Cittaslow*. For example, the promotion of small, independent traders at the expense of discouraging larger chain stores may negatively affect those who rely on larger stores for goods at a cheaper price than a small retailer could offer. In adopting *Cittaslow* ideals, the City Council would need to be aware of the potential to exclude sections of the community if one aspect of the ideals is over zealously pursued.
- 5.4 The direction promoted by Cittaslow is only one of a multitude of directions that a town like Winchester could develop in. Rigorous consultation would be needed to ensure that there is a desire within the majority of Winchester's community to follow the principles of *Cittaslow* before a commitment can be made to pursue this designation.
- 5.5 As highlighted in 2.4, there is an initial cost to join *Cittaslow*, followed by an annual subscription. It is not presently clear of the benefit that will be received from the international Co-ordination Committee in return for the fee. Any future discussion on a possible submission for *Cittaslow* status would also need to consider where the subscription would be funded from.

Appendix A

Below are the criteria for becoming a *Cittaslow*, at least 30% of which must be met in the initial application. This version of the criteria has been reviewed by the Ludlow *Cittaslow* sub-committee to apply to British towns wishing to gain the designation. The 'Comments' column refers to which of the Italian criterion are to retained or deleted as the British criteria.
