- 1. Purpose
- 1.1 The purpose of this Report is to formulate the Work Programme of the Winchester Town Forum for the remainder of the 2015/16 Municipal Year with the aim of setting it's main items of business going forward. The setting of this Work Programme does not preclude additional items being included by Cabinet or suggestions being made by the Town Forum during it's meetings throughout the year.
- 2. The 2015/16 Municipal Year
- 2.1 The Forum is now a well established part of the Council's democratic process and Cabinet has previously indicated its support for the Forum playing a greater role in providing a 'Winchester voice' on issues that affect the Town area.
