# 2. <u>Informal Groups</u>

- 2.1 During the previous Municipal Year, the Forum appointed the following Informal Groups and should consider whether it wishes to re-appoint these Groups and nominate Members as necessary:
- 2.2 Town Account Informal Group
- 2.3 In 2015/16 the membership comprised of Councillors Weir (Chairman), J Berry, Hutchison and Sanders, together with Officer Representation from Darren Kennedy, Principal Management Accountant.
- 2.4 To accommodate working Members, it was agreed that this meeting for 2015/16 would commence at 6.30pm.
- 2.5 The Group had agreed its terms of reference as:
- 2.6 "To make recommendations on the draft financial strategy to the Winchester Town Forum and that the Group examine the detailed heads of terms in the budget, with a view to making recommendations in assisting in the budget process."
- 2.7 It is recommended that this Group be re-appointed on the same terms.

- 2.8 Town Account Grants Informal Group
- 2.9 In 2015/16, its membership comprised of Councillors Scott (Chairman), Gosling, Hiscock and Tait, together with Officer Representation from Eloise Appleby, Assistant Director (Economy and Communities).
- 2.10 In volunteering to serve on this informal group, Members should be mindful of the restrictions placed on them by the Code of Conduct. From this, Members who are officeholders or otherwise clearly active (for example, on the management board) in any of the organisations that have submitted an application will have a personal and prejudicial interest and should take no part in the consideration of that *particular* organisation's applications. Members are reminded that the Code makes no distinction between whether or not the Member was appointed to the body concerned as a Council representative, because the potential for conflict can arise in either case.
- 2.11 It is recommended that this Group be continued.
- 2.12 <u>Winchester Town Forum (Vision for Winchester) Informal Group</u>
- 2.13 In 2015/16, its membership comprised of Councillors J Berry, Burns, Hutchison, Maynard, Tait and Weir, together with Officer Representation from Steve Tilbury, Corporate Director.
- 2.14 This Group was created at the Town Forum meeting held 12 June 2013 and at the first meeting of the Group, the Group agreed that its first task would be to examine the issues relating to the area around the station and then discuss other projects as and when they arise. Members will recall that at the Town Forum meeting held on 25 June 2014, it was agreed that the terms of reference for the Group be amended to clarify its terms of reference to "Examine progress against the aspirations set out in the Vision for Winchester Document and make any recommendations as necessary to Cabinet, the Forum or the Council's partners as appropriate; and recommend to the Forum any amendments to the Vision as necessary."
- 2.15 <u>Winchester Town Forum (St Maurice's Covert) Informal Group</u>
- 2.16 In 2015/16, its membership comprised of Councillors Hutchison, Mather and Tod, together with Officer Representation from Eloise Appleby, Assistant Director (Economy & Communities) or representative and Catherine Turness, Winchester Business Improvement District (BID) plus other stakeholders as invited attendees.
- 2.17 At its meeting held on 11 September 2013, the Forum agreed to re-convene this Group to consider with officers the contents for the brief for the improvement for St Maurice's Covert and to suggest any additional issues they would like to see included in the brief for consultants. The Town Forum received a progress report from the Group at its meeting held on 10 June 2015 (WTF219 refers) and oral updates on progress at the meetings held on

- 18 November 2015 and 9 March 2016. Further progress updates by the Group to be considered at this meeting of the Town Forum (27 June 2016).
- 2.18 It is recommended that this Group be continued into 2016/17.
- 2.19 Town Forum Representative on the Walking Strategy Group
- 2.20 In 2015/16 Councillor Hiscock was appointed as the Town Forum's representative on the Walking Strategy Group.
- 2.21 The Town Forum received an oral update by the Assistant Director (Environment) at its meeting on 10 June 2015, outlining the details of the Walking Strategy Workshop Event formed at the request of the Walking Strategy Group entitled 'Creating a More Walkable Winchester' which took place on 18 September 2016.
- 2.22 It is recommended that the Town Forum continues to appoint a representative to this Group.
- 2.23 Winchester Town Forum (Play Areas) Informal Group
- 2.24 In 2015/16, its membership comprised of Councillors E Berry, J Berry, Hiscock, Maynard, Osborne and Scott, together with Officer Representation from Susan Croker, Head of Landscapes and Open Spaces.
- 2.25 This Group was created at the Town Forum meeting held 10 June 2015 and at the first meeting of the Group on 26 January 2016, it was agreed they would establish the condition of the play areas and existing equipment within the Town area. The findings of the Play Areas Informal Group would be reported back to the Town Forum in the new Municipal Year.
- 2.26 It is recommended that this Group be continued into 2016/17.
- 2.27 <u>Winchester Town Forum (Community Engagement) Informal Group</u>
- 2.28 This Group was created at the Town Forum meeting held on 18 November 2015 with the purpose of identifying what was required from community engagement in the Town Area and to establish the best format to progress this matter for the future. The Group met several times throughout January and February 2016 and a report of the outcome of those meetings was considered by the Town Forum at its meeting on 9 March 2016 (WTF239 refers). As a result, the Town Forum agreed that a working group be established in the 2016/17 Municipal Year to further investigate the matters set out in the Report.
- 2.29 It is recommended that the Forum consider whether to continue the Community Engagement Informal Group into 2016/17.

# 3. Special Meetings of the Town Forum in 2015/16

3.1 During 2015/16, the Town Forum met on two further occasions with arranged special meetings held on 28 July 2015 to consider the Station Approach Brief and Magdalen Hill Cemetery Extension and on 5 October 2015 to consider Presentation and discussion regarding Winchester Chapter of District Local Plan Part 2 (Appendix M (Winchester) – CAB2721(LP) refers).

# **OTHER CONSIDERATIONS:**

- 4. COMMUNITY STRATEGY AND PORTFOLIO PLANS (RELEVANCE TO):
- 4.1 This paper seeks to ensure that:
  - a) the Town Forum fulfils its terms of reference in a way that is well planned and executed, and
  - b) the role of Councillors elected to lead and serve their communities is properly supported and developed.

Both these objectives support the corporate outcome of being an Efficient and Effective Council.

# 5. RESOURCE IMPLICATIONS

5.1 Currently none, beyond the cost of room hire and officer support from within current budgets. If officers are involved in work of the Forum in the same way as they would be with Parishes; then their time will not be a specific charge to the Town Account.
