WINCHESTER CITY (BARFIELD CLOSE AND ST. CATHERINE'S VIEW) (OFF STREET PARKING PLACES) ORDER 2003

Notice is hereby given that Winchester City Council proposes to make an order in respect of the management and control of the Barfield and St. Catherine's View Park and Ride car parks in Winchester. The proposed order will supersede the existing order and will make provisions as to the use of parking places, the vehicles or classes of vehicle which may be entitled to use them; the conditions under which they may be used and the charges to be levied in connection with their use. The proposed order will include the extension to the St Catherine's View Park and Ride Car Park as well as all parking places covered by the existing park and ride Order.

The driver of a vehicle bearing a disabled persons badge shall be exempt from paying car parking charges in all of the car parks covered by the proposed order.

The owner of a vehicle which contravenes the proposed order will by liable to pay a Penalty Charge of £60.00 which will be reduced to £30.00 if paid within 14 days.

The Schedule hereto gives details of the locations of the car parks referred to in the proposed order, the rate of charges and the time limits for their use and the classes of vehicle for which they will be available.
