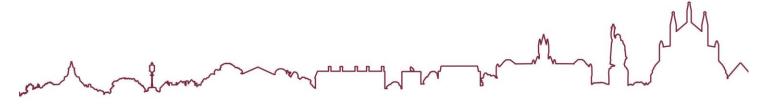

Update

- 1. Correction of typo in paragraph 4 on page 60 which should read 'public realm improvements are encouraged and supported by the SPD (paragraph 3.12.2)'.
- 2. Deletion of the reference to a listed building application in the opening paragraph of the Historic Environment section on page 63 which should read 'The following legislation and policies are taken into account in the assessment and determination of this planning application.'
- 3. For confirmation, the long-distance views of the site from key viewpoints such as St Giles Viewpoint have also been assessed. The site sits as part of a developed urban environment and due to the low-lying nature of the scheme it does not interrupt Winchester's important historic views or roof scape. The demolition of the

building does not result in a large gap which is harmful from this perspective. The proposal is considered by officers to comply with policy WIN3 of the LPP2.

4. For confirmation, the proposal also includes 4x 6m lighting columns spread throughout the site, alongside low height lighting and strip lighting to illuminate the hoardings at the rear of the site. The lighting has been assessed from an ecological perspective and also from a visual appearance perspective and is found to be acceptable and does not harm the character of the area or Conservation Area.
