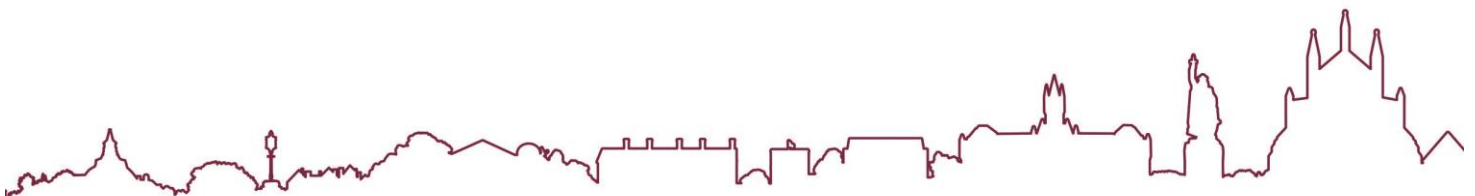

- Terms of reference drafted, to include areas adjacent to the unparished area of Winchester and addressing outstanding governance issues
- Terms of reference agreed by Licensing & Regulation Committee on 29 September (subject to minor amends)
- Briefing for affected parish councils on 29 October
- Terms of reference published, and consultation started, on 3 November

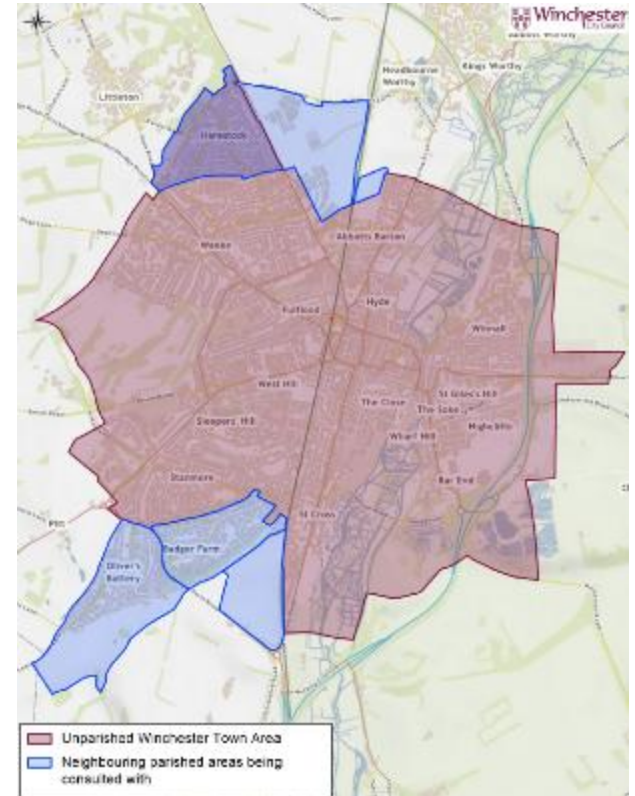
