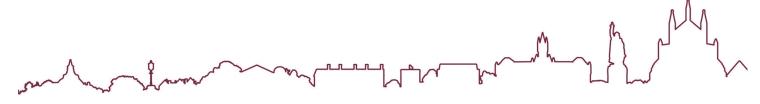

1 Introduction

- 1.1 This report results from a Stage 1/2 Road Safety Audit carried out following instructions from Mayer Brown Limited's Bristol Office, on the proposed vehicular access to the Lidl supermarket store in Whiteley, Hampshire. The Road Safety Audit was carried out on 9th February 2018.
- 1.2 The Road Safety Audit Team membership was as follows:

- 1.3 The Road Safety Audit took place at the Woking Office of Mayer Brown Limited on 9th February 2018. The Road Safety Audit comprised an examination of the detailed design drawings provided.
- 1.4 The Audit Team have not been made aware of any departures from standard.
- 1.5 A site visit was conducted by both Road Safety Audit Team Members on 8th February 2018 from 12:00hrs onwards, during which the weather was fine and the existing road surface was dry. Observed traffic conditions were low.
- 1.6 The terms of reference of the Road Safety Audit are as described in HD 19/15. The Road Safety Audit Team has examined and reported only on the road safety implications of the scheme as presented and has not examined or verified the compliance of the designs to any other criteria.
- 1.7 The Audit is concerned only with the works that are to be adopted by Hampshire County Council.

- 1.9 The proposed works include the provision of a new vehicular access providing access to a new foodstore car park. In addition, improved pedestrian facilities are to be provided on Solent Way and Rookery Avenue.

Items Raised at the Stage 1/2 Road Safety Audit

General

Site Access

2.1 Problem:

Location: Site access / Solent Way

Summary: Servicing Arrangements

It is important that service vehicles can access the site appropriately without traversing the footway or requiring reversing manoeuvres within the highway.

On-street parking was seen to occur on Solent Way between the vehicular access and Rookery Avenue. The parked vehicles could obstruct large delivery vehicles, possibly resulting in reversing manoeuvres or encroachment onto the footway(s), putting pedestrians or other road users at risk.

Recommendation

Undertake swept path analysis using an anticipated service vehicle to ensure that the vehicle can access the site appropriately when on-street parking is occurring.

If on-street parking creates a problem within the extent of the swept paths, Hampshire County Council should consider implementing a traffic management order prohibiting vehicles from waiting at any time within the critical areas.



2.2 Problem

Location: Site access / Solent Way

Summary: On-street parking blocking visibility splays

On-street parking was observed on both the western and eastern sides of the proposed access, these parked vehicles will block the visibility splays indicated on the plans provided, and this would increase the risk of emerging vehicles being hit by passing traffic.

Recommendation:

Hampshire County Council should consider implementing a traffic management order prohibiting vehicles from waiting at any time within the extents of the visibility splays.

Non-Motorised Users (NMUs)

2.3 Problem

Location: Rookery Avenue - Proposed uncontrolled crossing

Summary: Visibility – Pedestrian & vehicle collisions

To reduce the risk of pedestrians stepping in front of moving vehicles, it will be important that the proposed pedestrians crossing landing points are visible to approaching traffic.

Recommendation

Ensure appropriate forward visibility splays to pedestrian landing points and that the splays are not restricted beyond a vertical height of 0.6m. Any vegetation within the splays should be maintained to avoid being obstructed by overgrowing foliage.
