providing comments on the application:

"The principle of the redevelopment of this site is accepted as it is within the Whiteley settlement boundary but there are objections to the detail which are set out below.

The application is for a single dwelling although there is a yet to be determined application for seven houses on the site of The Spinney and this proposal should be considered as part of a larger scheme.

The Noise Impact Assessment is noted which appears to record higher than acceptable levels of noise from the M27 but without any practical proposals as to how this will be reduced to acceptable levels without keeping windows closed, particularly first floor windows.

The proposals are contrary to Policy LPP1 CP10 in that there is no detail for the improvements to Lady Bettys Drive to ensure its suitability for the additional traffic generated by the new development including improving visibility at the junction with Whiteley Lane.

Lady Betty's Drive has no safe pedestrian access to the local bus network or schools, the nearest play areas at Mollison Rise and Cheshire Close are not safety accessibly on foot.

There are ongoing concerns that the development will exacerbate existing flooding issues for properties to the north of the site.

There are ongoing concerns about unmonitored clearance of the site and the impact on its ecology.

Request that the application is heard by the Planning Committee if the officer is minded to use delegated power to grant permission."

"Whiteley Town Council would like to withdraw its requests that the application for The Spinney is heard by the planning committee".
