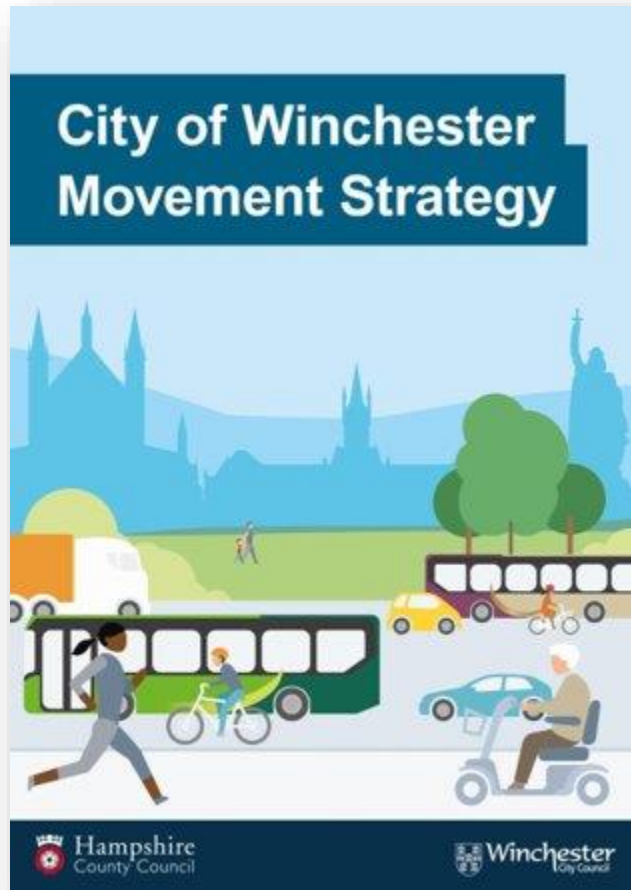

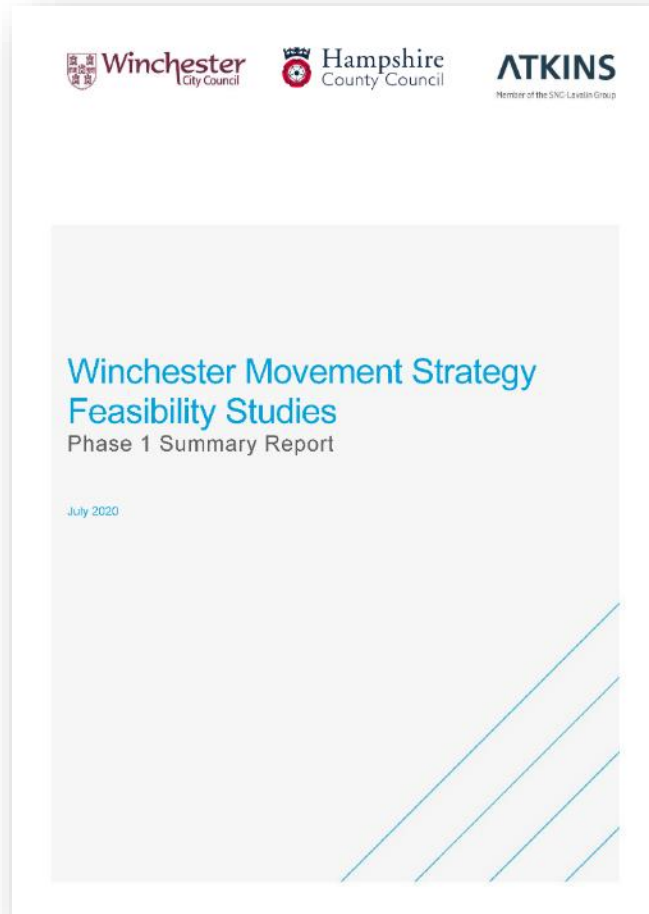


Movement Strategy

- Priority workstream:
 - Park and Ride - increasing the capacity of Park and Ride
 - “City Council has acquired the Vaultex site at Bar End to increase East P&R offer.”

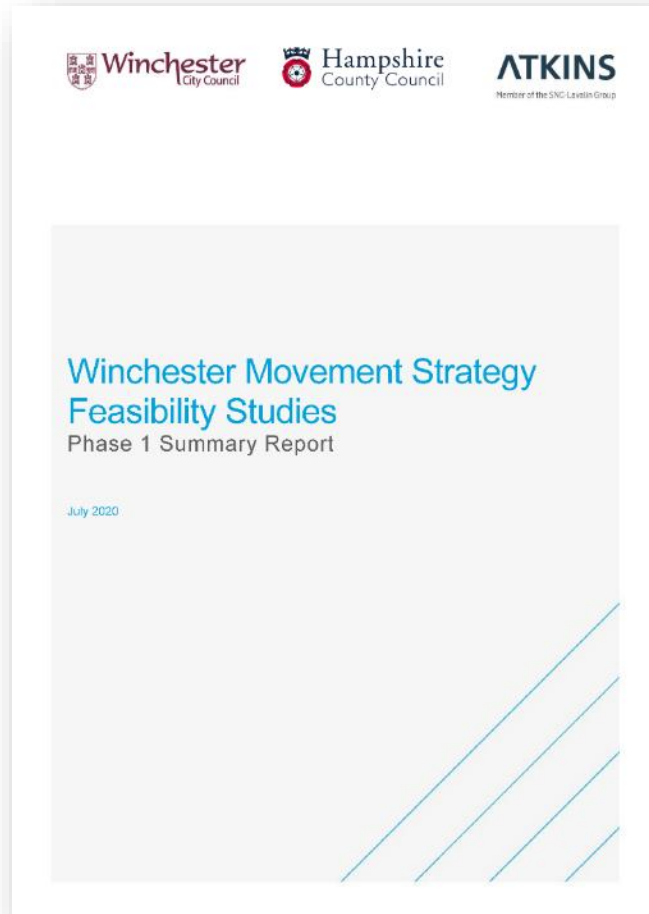
Movement Strategy – Phase 1 Feasibility



- “The WMS, WMS Action Plan and draft Winchester Parking and Access Strategy identify substantial expansion of P&R services in Winchester as important to delivering the overall WMS strategy.”
- “The shortlisted potential P&R options are provided below” ... “Barfield and St Catherine’s – extensions of existing provision”
 - “The former Vaultex site – Currently at a funding application stage to provide 300 additional spaces (including electric vehicle charging) as an extension to Barfield P&R site. An initial 100 space surface car park is at the planning application stage.”
