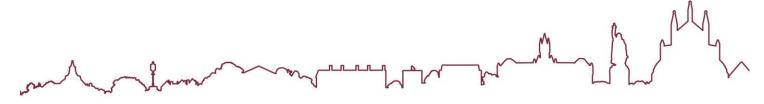

<u>Update</u>

Condition 07 has been amended to include references to restrictions made in the submitted noise assessment. The condition therefore now reads:

'Prior to the use of the development hereby permitted, an Operation Management Plan (OMP) must be submitted to and approved in writing by the Local Planning Authority.

The OMP must include:

- Booking procedures including confirmation the site will only be used at the designated booking time for exclusive use only.
- Confirmation no more than 4 dogs shall be exercised on the land at any one time
- Confirmation that no more than 2 vehicles will be parked within the proposed car park at any one time.
- Confirmation the site will not be used for dog training purposes
- Provision and details of signage (clearly visible from all entrances) stating the re-calling of dogs must be kept to a minimum including other conditions of use of the site.
- Procedure for noise complaints including prohibiting customers from use of the site following a complaint.

The use of the site must continue in accordance with the approved OMP.

Reason: To preserve the visual amenities of the locality and to control the use of the site.
