

In accordance with the Licensing Act 2003 (Hearings) Regulations 2005, the hearing will take the form of a discussion led by the Sub-Committee. Cross-examination will not be permitted unless the Sub-Committee considers it necessary to properly consider the matter.

Written objections, representations and petitions will be circulated with the Agenda and Report and will be taken into account by Members of the Sub-Committee. Only those who have made "relevant representations" within the meaning of the Licensing Act 2003 will be entitled to be heard as of right by the Sub-Committee.

- 1. The **Chairperson** will set out the procedure to be followed during the hearing
- 2. **The Licensing Manager** will introduce the Report.
- 3. **Members** of the Sub-Committee may ask questions of the **Licensing Manager**.
- 4. The **Applicant** or representative may address the Sub-Committee as follows:- a) to clarify any points which the Licensing Authority has given notice of (Regulation 7(1)(d) of the Licensing Act 2003 (Hearings) Regulations 2005; b) to address the Sub-Committee and present the application.
- 5. **Members** of the Sub-Committee may ask questions of the **Applicant** or representative

Responsible Authorities who have made representations will then be allowed to introduce their representations. The Sub-Committee may ask them questions, and (subject to the permission of the Sub-Committee) the Applicant or representative may ask them questions.

1. Application

Applicant: Fasu Miah

Premises: Kassia Lounge

Crawford House Hambledon Road

- 1.1 This report is to consider an application for a New Premises Licence under section 17 of the Licensing Act 2003 for Kassia Lounge, Crawford House, Hambledon Road, Denmead, PO7 6NU. The premises is a retail unit surrounded by residential properties.
- 1.2 The application describes the premises as a restaurant and bar serving Indian food and seeks to provide the following licensable activities at the following times:

1.3 Hampshire Constabulary made a representation against this application on the grounds of the Prevention of Crime and Disorder and Protection of Children from Harm licensing objectives. During the consultation period a number of conditions were agreed between Hampshire Constabulary and the applicant, and the representation was subsequently withdrawn. These conditions are reflected in Section 5 of this report.

- 1.4 Environmental Health made a representation against this application on the ground of the Prevention of Public Nuisance licensing objective. This is shown in Appendix 2.
- 1.5 No representations were received by any other Responsible Authorities.
- 1.6 Representations have been received from 26 Other Persons, all of which are against the application. These representations are set out in Appendix 3 and primarily relate to the Prevention of Public Nuisance licensing objective.
- 1.7 Notice of the application was displayed outside of the premises for a period of 28 days until 11 February 2020, and advertised in the Petersfield Post and its sister publications which reach Denmead under their distribution list on 22 January 2020.

3. Representations from Other Persons

Representations have been received from 26 'Other Persons', all of which are against the application. The main concerns are with regard to the Prevention of Public Nuisance licensing objective.

4. Observations

The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

In making its decision, the Sub-Committee is also obliged to have regard to the national Guidance and the Council's Licensing Policy.

The Sub-Committee must have regard to all of the representations.

The Sub-Committee must take such of the following steps it considers appropriate to promote the Licensing Objectives:

- Grant the licence subject to conditions in accordance with the operating schedule (modified to such extent as the authority considers appropriate for the promotion of the licensing objectives) and the mandatory conditions;
- 2. exclude from the scope of the licence any of the licensable activities to which the application relates;
- 3. reject the application.

Terminal hours

The Sub-Committee should take account of the national Guidance and the Council's Licensing Policy with regard to terminal hours and take such steps as it considers appropriate to promote the Licensing Objectives.

(Licensing Policy Part 4, A8)

Licensing Objectives

Crime and Disorder

The Sub-Committee should consider any appropriate conditions to prevent crime and public disorder relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy 1.9, 2.11, 2.17 and Part 4 Section A)

Public Safety

The Sub-Committee should consider any appropriate conditions relating to public safety having regard to the relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, B2, B3)

Public Nuisance

The Sub-Committee should consider any appropriate conditions to prevent public nuisance caused by noise pollution from the premises relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, Section C)

Protection of Children

The Sub-Committee should consider any necessary conditions for the Protection of Children relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, D6, D7)

Human Rights

It is considered that Articles 6 (right to a fair trial); 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, appropriate in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

5. Conditions

Mandatory Conditions

The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

- effective from 1 October 2014

- 1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a times limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carried a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol,

identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 4. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other an alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
 - (iii) still wine in a glass: 125ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014 – effective from 28 May 2014

- A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1-
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula- P = D + (D x V)

where-

- (i) **P** is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) **V** is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph 2 applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Possible Conditions

If the application is granted, the Sub-Committee may wish to consider the following conditions to reflect the Operating Schedule:

Conditions in italics are those which have been suggested by Hampshire Constabulary, and subsequently agreed with the applicant.

Operating Hours

1. The hours the premises may be used for regulated entertainment shall be:

Live Music	Monday to Sunday Christmas Eve New Years Eve	1100 to 0000 1100 to 0300 1100 to 0300
Recorded Music	Sunday to Thursday Friday and Saturday Christmas Eve New Years Eve	0900 to 0000 0900 to 0030 0900 to 0300 0900 to 0300

2. The hours the premises may be used for late night refreshment shall be:

Sunday to Thursday	2300 to 0000
Friday and Saturday	2300 to 0100
Christmas Eve	2300 to 0300
New Years Eve	2300 to 0300

3. The hours the premises may be used for the sale of alcohol (on and off the premises) shall be:

Sunday to Thursday	0900 to 0000
Friday and Saturday	0900 to 0100
Christmas Eve	0900 to 0300
New Years Eve	0900 to 0300

4. The hours the premises may open for other than Licensable Activities shall be:

Sunday to Thursday 0900 to 0000 Friday and Saturday 0900 to 0100

All Licensing Objectives

- A1: The premises licence holder shall ensure that a training package is in place in order for all staff involved with the sale or supply of alcohol to be sufficiently trained in licensing matters proportionate to their role and aware of their responsibilities. Particular attention should be paid to underage sales / ID verification and the refusal of alcohol sales to a drunk person. Records shall be kept of this training, dated and signed by the staff member and trainer. Refresher training shall be completed at least every 12 months again with documented records made and to be available for inspection by Police and other responsible authorities.
- A2: A written record shall be retained at each bar to show the staff that have been authorised to sell alcohol. This shall be made available to the Police and other responsible authorities on request.
- A3: The Designated Premises Supervisor, or an appointed deputy (who holds the written authorisation of the DPS) who also holds a personal licence, will be on the premises at all times when they are open for licensable activities.

Crime and Disorder

- CD1: The premises licence holder shall ensure that a refusals book / incident book or log is maintained at the premises. These records shall be retained for a minimum of 1 year and be made available to the Police and other responsible authorities upon request.
- CD2: The premises licence holder shall ensure that recordable CCTV is in place when licensable activity is taking place. This must be of a standard acceptable to the local Police. There shall be sufficient cameras to cover all primary public areas in addition to cameras covering the entrance, exit and external smoking areas.
- CD3: Imagery obtained must be retained for a minimum of 28 days on a rolling basis. This must be made available in a format that can be viewed by Police and council officials and must be given to them on request.
- CD4: The need for Security Industry Authority (SIA) door staff will be risk assessed for any event at the premises which deviates from the standard restaurant operation where there is a focus on alcohol sales or regulated entertainment and on any other occasion as deemed necessary by the designated premises supervisor and/or premises

management. This risk assessment will be recorded appropriately and retained at the premises for a minimum of 12 months for authorities to review.

Public Safety

Public Nuisance

PN1: The Premises Licence Holder shall ensure that signage requesting quiet exit and respect for neighbours is displayed at the premises.

PN2: The Premises Licence Holder shall ensure that deliveries are carried out at a time and in such a manner that will cause minimal disturbance to local residents.

Protection of Children

PC1: The premises licence holder shall ensure that a system is in place to ensure that every individual who appears to be under 25 years of age seeking to purchase or be supplied with alcohol at or from the premises, shall produce acceptable means of identification and age confirmation. Acceptable identification shall be a passport, photo driving licence or PASS accredited photo ID. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.

6. Other Considerations

Council Strategy Outcome (Relevance To:)

This report relates to the fourth Strategic Outcome; 'Improving the quality of the District's environment' by working with partners and using powers available to us to make Winchester a safe and pleasant place to live, work and visit.

Resource Implications

Please accept this email as a representation regarding the above application on behalf of the Environmental Protection Team. This representation is made on the grounds that the applicant has failed to demonstrate how they will ensure compliance with the public nuisance licensing objective.

When issuing planning permission for this premises, concerns were raised regarding the potential for noise disturbance to the occupants of nearby residential dwellings. Accordingly, it was recommended that this could be effectively controlled if the opening hours of the premises were restricted. This licensing application proposes to extend the opening hours far beyond those permitted by the Local Planning Authority. Accordingly, I wish to object to the application for a New Premises Licence for the Kassai Lounge, Denmead on the grounds of the Prevention of Public Nuisance. The reasons for my objection are as follows:

- 1, Recorded and live music I propose that the times be amended as follows:

 Monday to Sunday 1100 to 2300

 Christmas and New Years Eve 1100 to 0100
- 2. Recorded and Live music noise levels The application makes no reference to the ambient noise levels for the music beyond the physical built boundaries of the Kassai Lounge. I consider that any licence awarded should set strict limits to ambient noise levels outside the Kassia Lounge premises to ensure that it does not cause a nuisance to residents of neighbouring properties and passers-by in this otherwise peaceful rural village
- 3. Late night refreshment I propose that any refreshment served should be limited to no later than 2300.
- 4. Supply of alcohol (On premises) I propose that the times be amended as follows:

Monday to Sunday - 1100 to 2300 Christmas and New Years Eve - 1100 to 0100

5. Supply of Alcohol (Off Premises) - The application does not make it clear as to what "Off Premises" means. If "Off Premises" refers to the provision of alcohol to persons sitting at tables outside the Kassai Lounge, it becomes even more important that this should not normally happen later than 2300 since this could become a source of nuisance to residents of neighbouring properties.

However, if "Off Premises" refers to the provision of alcohol to premises other than the Kassai Lounge then this should be refused and become the subject of a special licence on a case by case basis.

We are writing to express concern about the extent of the licensing permissions being sought by Kassia Lounge in Denmead. Our concerns relate to two issues: The prevention of (crime) and disorder The prevention of public nuisance We live at 1 Clarendon Close in Denmead. Currently we are disturbed at night by loud music and the sounds of customers leaving The White Hart at closing time or after a special event. The disturbance is more obvious in the summer when windows are open and sound travels. We are very concerned that allowing Kassia to operate beyond the opening hours for the pub will exacerbate the noise nuisance that we are already experiencing since moving to Denmead in October 2018. In our view this constitutes a public nuisance since it impacts on our sleep and must affect other residents too.

In addition, we used to live in Drayton where Kassia has had a lounge for the last five years. Although we did not live close enough to be affected by the noise, we understand that the police were called regularly to address issues relating to public order.

The supply of alcohol off premises until 12.00 every night and 1.00 on Fridays and Saturdays is particularly alarming to those who seek to reduce public disorder and where there is little evidence of a police presence to address any concerns. How can this be considered appropriate in a place which seeks to retain the character of a village?

Whilst I do not object in principle to these premises being granted Music and Alcohol licences, the times being proposed are excessively late. Living in close proximity to these premises means that my wife and I will be required to tolerate whatever noise and possible rowdiness is generated by these activities. Times of 23:00 (Sunday to Thursday) and 00:00 (Friday to Saturday) or earlier would be more acceptable upper limits. Christmas Eve and New Years Eve should also be limited to 02:00. As you are probably aware, interrupted and/or poor quality sleep due to noise is harmful for both children and adults alike.

The application does not make clear whether music and the drinking of alcohol will take place outside the building (e.g. in the garden of the premises or in the car park area at the front of the building). This must not be permitted as it will inevitably constitute a public nuisance especially for domestic properties adjoining these gardens.

I also strongly suggest that with recent break ins to both the Co-op and the Bakery in Denmead as well as thefts from nearby properties and the continued lack of any significant Police presence in Denmead, it would be prudent for Winchester to take this opportunity to monitor the shop frontages including the Kassia Lounge with CCTV cameras to ensure that Denmead remains a peaceful and desirable Hampshire village. None of the shops are open late and the Coop has already been targeted and had the ATM machine stolen. There are a number of Commercial properties which could be potential targets along with a Church and Church Hall. The development my mother lives in is one of the nearest residential properties and as she is on the ground floor this makes her a potential target. She is 89/90 years old and should this go ahead she will feel unsafe in her home.

Public Safety - We feel the additional traffic and people will cause additional litter and rubbish. There are already issues with Rats from the Coop which is adjacent to my mother's property because of the rubbish left in the Car Park. 



3. Late night refreshment

Although the Licensing Authority has laid down the conditions to be agreed by the Applicant and the Police, there have been reports of fighting outside a similar business in Clanfield causing a Public Nuisance.

If these hours are allowed it could become a "watering hole" for those who seek alcohol when other premises are closed.

Late opening will involve movement of vehicles, slamming car doors and raised voices as people say, 'farewell'.

Also staff will leave later, so the disturbance could go on into the early hours disturbing the rest of local people.


