In accordance with the Licensing Act 2003 (Hearings) Regulations 2005, the hearing will take the form of a discussion led by the Sub-Committee. Cross-examination will not be permitted unless the Sub-Committee considers it necessary to properly consider the matter.

Written objections, representations and petitions will be circulated with the Agenda and Report and will be taken into account by Members of the Sub-Committee. Only those who have made "relevant representations" within the meaning of the Licensing Act 2003 will be entitled to be heard as of right by the Sub-Committee.

- 1. The **Chairperson** will set out the procedure to be followed during the hearing
- 2. The Licensing Manager will introduce the Report.
- 3. **Members** of the Sub-Committee may ask questions of the Licensing Manager.
- 4. The **Applicant** or representative may address the Sub-Committee as follows:- a) to clarify any points which the Licensing Authority has given notice of (Regulation 7(1)(d) of the Licensing Act 2003 (Hearings) Regulations 2005; b) to address the Sub-Committee and present the application.
- 5. Members of the Sub-Committee may ask questions of the Applicant or representative

Responsible Authorities who have made representations will then be allowed to introduce their representations. The Sub-Committee may ask them questions, and (subject to the permission of the Sub-Committee) the Applicant or representative may ask them questions.

## Part A.

#### 1. <u>Application</u>

Applicant: Sainsbury's Supermarkets Ltd

**Premises:** Sainsbury's Supermarkets Ltd, Winchester Road, Bishops Waltham, Southampton, Hampshire, SO32 1BA

- 1.1 This application is for the grant of a new premises licence under section 17 of the Licensing Act 2003 for Sainsbury's Supermarkets Ltd, Winchester Road, Bishops Waltham, Southampton, Hampshire, SO32 1BA.
- 1.2 The premises was previously owned by Budgens Stores Ltd, who have held a premises licence permitting the sale of alcohol at this site since 2005.
- 1.3 The application specifies the supply of alcohol (for consumption off the premises only) as the only licensable activity, between the hours of 0600 and 0000 Monday to Sunday.
- 1.4 The application also specifies the premises' opening hours as between 0000 and 0000 Monday to Sunday (24 hours).
- 1.5 During the consultation period a number of conditions were agreed between Hampshire Constabulary and the applicant. These conditions are reflected in Section 5 of this report.
- 1.6 Following consultation with Hampshire Council Council's Trading Standards team, the applicant amended the terminal hour for the sale of alcohol to 2300 to promote the prevention of crime and disorder licensing objective.
- 1.7 No representations were received by Responsible Authorities.
- 1.8 One representation has been received from Bishops Waltham Parish Council, and is against the application. The representation is set out in Appendix 2 to this report, and primarily relates to the prevention of crime and disorder, public safety and the prevention of public nuisance licensing objectives.
- 1.9 Notice of the application was displayed outside of the premises for a period of 28 days until 26 August 2020, and advertised in the Hampshire Chronicle on 6 August 2020.
- 1.10 Notices of the hearing were sent to all Parties on 7 September 2020.

## 3. <u>Representations from Other Persons</u>

One representation has been received from Bishops Waltham Parish Council, and is against the application. The representation is set out in Appendix 2 to this report, and primarily relates to the prevention of crime and disorder, public safety and the prevention of public nuisance licensing objectives.

## 4. <u>Observations</u>

The Sub-Committee is obliged to determine this application with a view to promoting the Licensing Objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

In making its decision, the Sub-Committee is also obliged to have regard to the National Guidance and the Council's Licensing Policy.

The Sub-Committee must have regard to all of the representations.

The Sub-Committee must take such of the following steps it considers appropriate to promote the Licensing Objectives:

- 1. Grant the licence subject to conditions in accordance with the operating schedule (modified to such extent as the authority considers appropriate for the promotion of the licensing objectives) and the mandatory conditions;
- 2. exclude from the scope of the licence any of the licensable activities to which the application relates;
- 3. reject the application.

#### **Terminal hours**

The Sub-Committee should take account of the National Guidance and the Council's Licensing Policy with regard to terminal hours and take such steps as it considers appropriate to promote the Licensing Objectives.

(Licensing Policy Part 4, A8)

#### Licensing Objectives

#### Crime and Disorder

The Sub-Committee should consider any appropriate conditions to prevent crime and public disorder relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy 1.9, 2.11, 2.17 and Part 4 Section A)

#### Public Safety

The Sub-Committee should consider any appropriate conditions relating to public safety having regard to the relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, B2, B3)

#### Public Nuisance

The Sub-Committee should consider any appropriate conditions to prevent public nuisance caused by noise pollution from the premises relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, Section C)

Protection of Children

The Sub-Committee should consider any necessary conditions for the Protection of Children relating to the premises having regard to the operating schedule and the representations.

(Licensing Policy Part 4, D6, D7)

#### **Human Rights**

It is considered that Articles 6 (right to a fair trial) 8 (right to respect for private and family life) and Article 1 of the First Protocol (right to peaceable enjoyment of possessions) may be relevant. As there is a right of appeal to the Magistrates' Court, it is considered that there would be no infringement of Article 6. Article 8 is relevant, insofar as the nearby residents could claim that this right would be infringed by disturbance from customers. This should be balanced against the applicants' right to use of their premises under Article 1 of the First Protocol. Interference with these rights is permitted, where this interference is lawful, appropriate in a democratic society, and proportionate. Likewise, the residents may argue that their rights under Article 1 of the First Protocol would be infringed. If conditions are imposed, there should be no interference with any convention rights. To the extent that any interference may occur, it would be justifiable in a democratic society, and proportionate.

## 5. <u>Conditions</u>

#### **Mandatory Conditions**

#### Where the Licence Authorises Supply of Alcohol:

- 1. No supply of alcohol may be made under the premises licence:
  - (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

## - effective from 1 October 2014

- 1. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date or birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.

#### Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014 – effective from 28 May 2014

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1-
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula- P = D
     + (D x V)
     where-

vnere-

- (i) **P** is the permitted price,
- D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph 2 applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

## Possible Conditions

If the application is granted, the Sub-Committee may wish to consider the following conditions to reflect the Operating Schedule. Conditions in italics are those agreed between the applicant and Hampshire Constabulary during the consultation period.

## **Operating Hours**

2. The hours the premises may be used for the sale of alcohol shall be:

## Monday to Sunday 0600 to 2300

3. The hours the premises may open for other than Licensable Activities shall be:

Monday to Sunday 0000 to 0000

#### All Licensing Objectives

#### A1: Training

- (i) All staff engaged or to be engaged in the sale of alcohol on the premises shall receive training in age restricted sales.
- (ii) Induction training must be completed and documented prior to the sale of alcohol by the staff member.
- (iii) Refresher/reinforcement training must be completed and documented at intervals of no more than 6 months.
- (iv) Training records will be kept at the premises available for inspection by a police officer or other authorised officer on request.

#### Crime and Disorder

#### CD1: CCTV

- (i) The licence holder will ensure that the premises benefit from a CCTV system that operates at all times when licensable activities are taking place.
- (ii) The system will incorporate a camera covering each of the entrance doors and the main alcohol display area and will be capable of providing an image which is regarded as identification standard. The precise positions of the cameras may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.
- (iii) The system will incorporate a recording facility and any recording will be retained and stored in a suitable and secure manner for a minimum of 30 days and will be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.
- (iv) The system must be able to export recorded images to a removable means e.g. CD/DVD and have its own software enabled to allow playback/review.
- (v) A member of staff trained in the use of the CCTV system must be available at the premises at all times that the premises are open to the public.
- (vi) The system will display, on any recording, the correct time and date of the recording.

## CD2: Refusals

- (i) All cashiers shall be trained to record refusals of sales of alcohol in a refusals register. The register will contain:
  - details of the time and date the refusal was made;
  - the identity of the staff member refusing the sale;
  - details of the alcohol the person attempted to purchase.
- (ii) This register will be available for inspection by a police officer or other authorised officer on request.

## Public Safety

**PS1:** The licence holder will at all times maintain adequate levels of staff and security. Such staff and security levels will be disclosed, on request, to the licensing authority and police.

## Public Nuisance

**PN1:** Signage will be displayed at the exit of the premises requesting customers leaving the premises late at night to do so quietly and with consideration so as not to disturb nearby residents.

## Protection of Children

**PC1:** The premises licence holder will ensure that an age verification policy will apply to the premises whereby all cashiers will be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form of identification that complies with any mandatory condition that may apply to this licence.

b) The prevention of crime and disorder

1. The licence holder will ensure that the premises benefit from a CCTV system that operates at all times when licensable activities are taking place.

2. The system will incorporate a camera covering each of the entrance doors and the main alcohol display area and will be capable of providing an image which is regarded as identification standard. The precise positions of the cameras may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.

3. The system will incorporate a recording facility and any recording will be retained and stored in a suitable and secure manner for a minimum of 30 days and will be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.

4. The system must be able to export recorded images to a removable means e.g. CD/DVD and have its own software enabled to allow playback/review.

5. A member of staff trained in the use of the CCTV system must be available at the premises at all times that the premises are open to the public.

6. The system will display, on any recording, the correct time and date of the recording.

c) Public safety

The applicant will at all times maintain adequate levels of staff and security. Such staff and security levels will be disclosed, on request, to the licensing authority and police.

d) The prevention of public nuisance

Signage will be displayed at the exit of the premises requesting customers leaving the premises late at night to do so quietly and with consideration so as not to disturb nearby residents.

e) The protection of children from harm

The premises licence holder will ensure that an age verification policy will apply to the premises whereby all cashiers will be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form of identification that complies with any mandatory condition that may apply to this licence.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

# Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

#### Documents which demonstrate entitlement to work in the UK

- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 18(3) or 20(2)
   of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
  - evidence of the applicant's own identity such as a passport,
  - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

(i) any page containing the holder's personal details including nationality;

(ii) any page containing the holder's photograph;

(iii) any page containing the holder's signature;

(iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

#### Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <u>https://www.gov.uk/prove-right-to-work</u>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

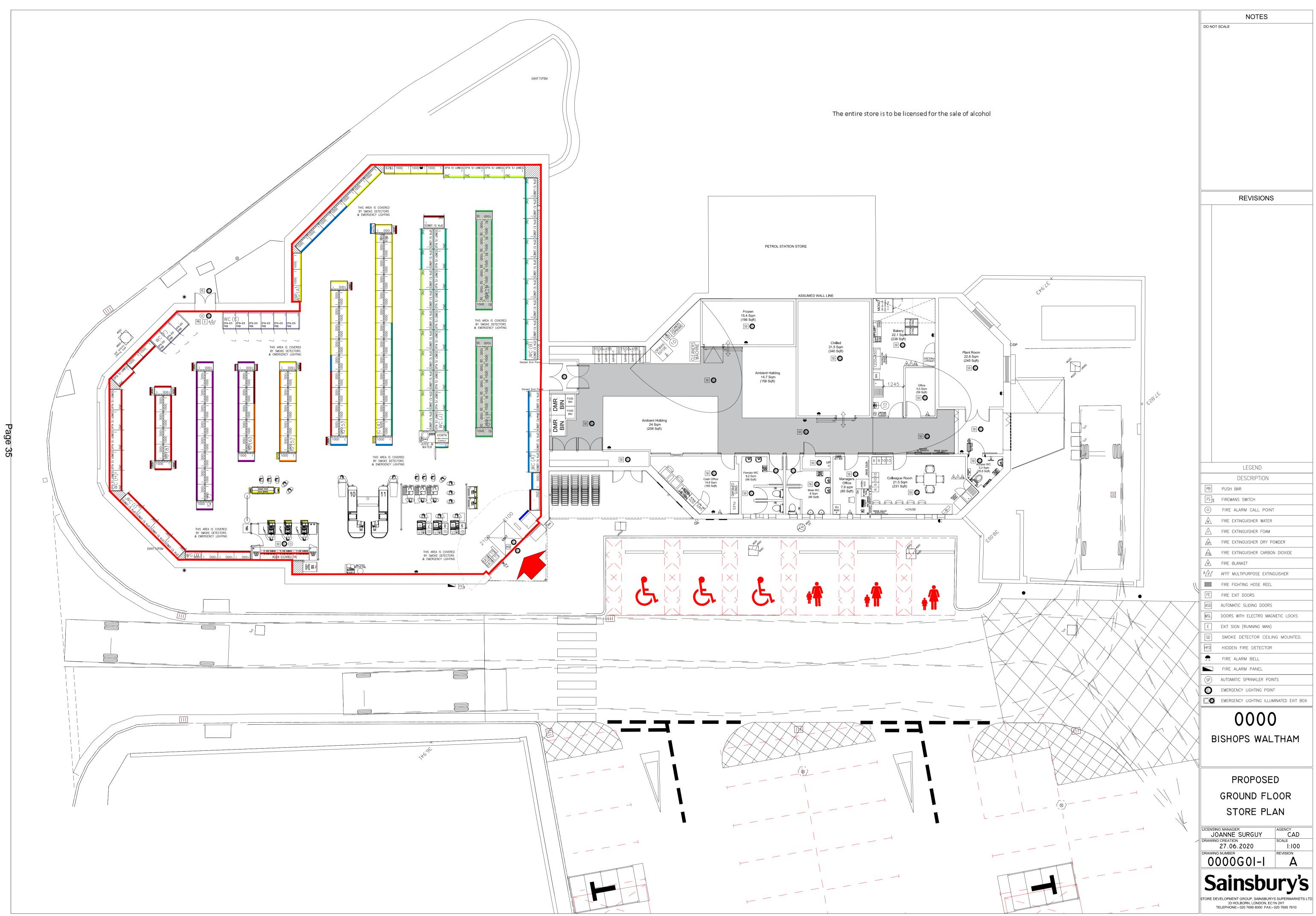

- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.

Application from Sainsbury's Supermarkets Ltd, 33 Holborn, London, EC1N 2HT for a New Premises Licence for Sainsbury's Supermarkets Ltd, Winchester Road, Bishops Waltham, Southampton, Hampshire SO32 1BA (previously Budgens Store). The purpose of the application is to provide licensable activities as detailed below:-

Bishop's Waltham Parish Council resolved at the meeting on 11<sup>th</sup> August 2020 to object to this application on the following grounds:

#### i) Prevention of Public Nuisance.

The Parish Council is not aware of any issues of public nuisance relating to the current Budgens store. Councillors are concerned that the change to the supply of alcohol and opening hours could result in an increase in the number of people using the store later in the evenings/night. The store is within a residential area; indeed the immediate neighbouring properties are occupied by some of our most vulnerable residents. The opportunity to purchase alcohol from the store after other licenced premises have closed could result in a rise in an unacceptable noise nuisance, litter and anti-social behaviour that would have an adverse impact on the immediate neighbours.

#### ii) Prevention of Crime and Disorder.

An increase in the hours for the supply of alcohol could result in people using the store after other licenced premises have closed, when possibly individuals are already under the influence of alcohol. This would have the potential for a rise in the incidents of crime and/or disorder in the vicinity. The Council is not aware of any incidents at the current Budgens store.

#### iii) Public Safety.

An increase in the hours for the supply of alcohol and opening hours could result in a rise in the number of people using he store late into the evening/night. This could impact on the safety of the neighbouring properties and cause concern amongst our more vulnerable residents (see (i) above). The Council is not aware of any incidents at the current Budgens store.

We're writing to notify you of a new Sainsbury's store that we will shortly be opening in Bishops Waltham. The store will replace the existing Budgens on Winchester Road, which will be fully refurbished prior to opening as a Sainsbury's.

We are looking forward to bringing our convenience store offer to Bishops Waltham. The new store will be around 5,000 sq ft and provide a range of our popular everyday essentials, including household products, ready meals, fresh products and chilled food, as well as some food to go and an Argos collection point. The store will open between 8.00am and 10.00pm Monday to Saturday and from 10.00am to 4.00pm on Sundays.

As the new Sainsbury's store will be replacing the existing Budgens, there will be a temporary closure for approximately 12 weeks from the beginning of September whilst the building is refurbished and made ready to open as a new Sainsbury's store. We are however committed to minimising any impact on local people and these works are not expected to be disruptive.

External works will only be carried out between 8.00am and 6.00pm from Monday to Friday, and from 9.00am to 3.00pm on Saturdays. Some non-disruptive internal works may be carried out outside of these hours. We are expecting to open the new Sainsbury's store in November, once the fit-out works are complete.

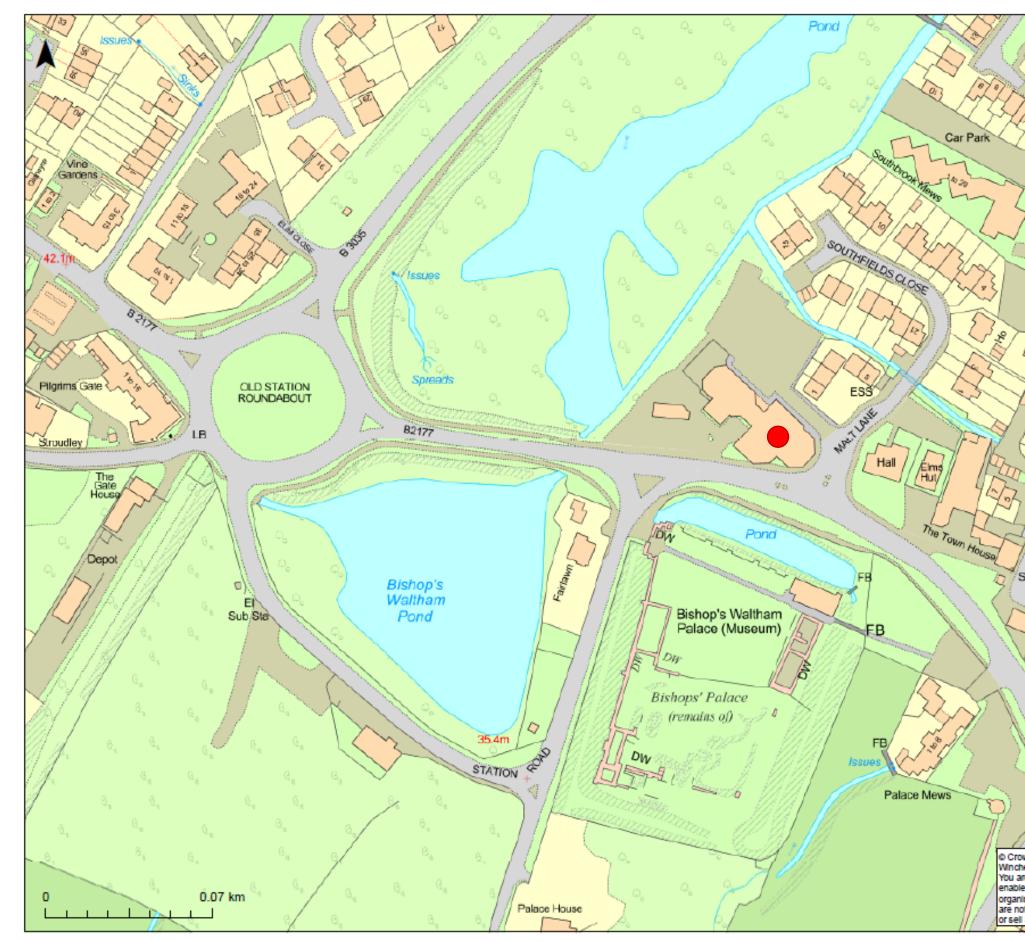
