Item 6: Proposal Description: Regulation 3 planning application for the erection of car park to provide 287 park & ride car parking spaces including 800m2 of photovoltaic panels, 16 Electric Vehicle (EV) charging bays, with associated access, turning and landscape proposals; and retrospective permission for i) formation of piling mat; ii) foundations and iii) partial construction of structure

At the invitation of the Chair, the Service Lead: Legal addressed the committee to provide the following announcement:

“As members will be aware, the application has been accompanied by a number of detailed technical appraisals. In response to previous comments by objectors, the Council on last Friday, 17 September 2021, published a number of updated papers to deal with those points.

At 10.34 this morning, the Council received an email from one of the objector’s solicitors asserting that they had had insufficient time to consider the Council’s responses, and in addition other objectors would also be in a similar position and unable to articulate these to the planning committee.

Whilst the Council does not necessarily agree with this, the Council has concluded, in an abundance of caution, that in the interests of fairness to objectors, it is not appropriate to proceed with this matter today, and the application will be deferred.”
