That Authority be delegated to the Head of Programme: Place,</li> </ol>	<p>The phone payment system allows customers to pay on-line as another option to the traditional cash or card payment methods provided at the council's car park payment machines. It gives customers the ability to purchase parking sessions through their device/mobile phone, either via a call, SMS text, or using an application. RingGo is the sole incumbent operator/supplier, their solution is used in all the council's chargeable car parks.</p> <p>The current contract with RingGo expires on 22nd November 2024. The council could not offer a phone payment system but this was rejected as it is a popular system which offers choice and flexibility to customers. The other payment methods such as cash and credit card will also remain available.</li> <li>2.
