The city council is required by the regulations to undertake public consultation on the Winchester District Proposed Submission Local Plan (Regulation 19) in order to meet the legal requirements for production of a Local Plan. It is, therefore, not an option to not proceed with public consultation if the city council is to continue to progress the adoption of a new Local Plan.

As set out in the report, it is considered that the Winchester District Proposed Submission Local Plan (Regulation 19) meets the test of soundness and is therefore ready for public consultation and submission. It is considered that there is

The Council's adopted Local Development Scheme (the timetable for preparing the Local Plan) will need to be slightly adjusted to align with the planned consultation and submission of the Winchester District Proposed Submission Local Plan (Regulation 19).

Once the new Plan is adopted, it will replace the current Local Plan (Local Plan Part 1 – Joint Core Strategy, Local Plan Part 2 – Development Management and Site Allocations and the Gypsy, Traveller and Travelling Showpeople Development Plan Document). When it has been adopted, it will be the

Both Option 2 and Option 3 would result in significant costs to the city council.
