This application offers no detail what so ever as to either the nature of the event, the recurrence of the event (weekly or annually) or any measures what so ever to promote the any of the four licensing objectives.

“Grassed field with large circus type big tops, the exact position of bars will be detailed in the EMP 30 days before the event” just is not sufficient on any level.

In section “M” of the application where this should be detailed, it just offers, “An EMP will be supplied 30 days prior to the event. Again, this is wholly unacceptable.


As the intention is too supply alcohol and provide regulated entertainment, I cannot determine anything from this and as such can only assume that the licensing objectives cannot be promoted.

New Premises Application - Wickham Ideas Festival (field - grid reference SU56912459) Blind Lane, Wickham, Hampshire

Please accept this email on behalf of Environmental Health as a representation regarding the above application on grounds of failure to promote the following two licensing objectives:

- Prevention of Public Nuisance
- Public Safety

Environmental Health is aware of the representation made by the Licensing team (Briony Appletree) and the reply received, so we will not revisit such matters. However, we still have the following concerns:

### **Prevention of Public Nuisance**

The applicant is seeking live and recorded music between the hours of 09:00 and 22:30 on Wednesday 09:00 to 17:00 on the Thursday. In accordance with Winchester's licensing policy we are concerned about the cumulative effect of this event with that of the Wickham Festival (PREM638) that occurs immediately after (using the same infrastructure). We are not satisfied that this combination will result in the public nuisance licencing objective being met. I have discussed this matter with the applicant and it is my understanding that the daytime live/recorded music hours are being sought for ancillary music associated with presentations/awards etc, which in my view is unlikely to be considered licensable activity. I have therefore advised that the applicant gives consideration to removing this element of the application or as a minimum reduces it significantly to a duration of several hours. This could still facilitate one significant live music act being offered as part of the hospitality for the Wednesday evening. Further I have recommended that they minimise the impact by finishing before 20:00 and include proposals for assessing and monitoring the noise from any significant live music event i.e. utilising one of the main Wickham festival stages.

### **Public Safety**

The proposed time for this event to cease licensable activity is 17:00 on the Thursday and PREM638 for the Wickham festival commences immediately thereafter (17:00). This would allow commencement of this festival's licensable activity immediately thereafter on the same redlined site. I am concerned the

applicant has failed to explain how they will manage both the egress of persons from the proposed event (up to 4,999 unless offering a condition reducing this number) whilst simultaneously managing the ingress to the Wickham festival event (licensed for 7,000). These concerns include crowd safety, car parking arrangements and wider traffic management considerations. I have requested that further information is provided regarding this matter and consideration is given to altering the proposed hours for this event to provide a defined short break between the two events. At this stage, I am concerned that the safety of people attending this event could therefore be compromised and this is a failure to demonstrate the promotion of the public safety licensing objective.

Although outside the licensable activity associated with PREM638 we are aware that attendees to the Wickham festival arrive from Wednesday evening onwards to the camping and RV areas associated with this event. Further through a TEN application entertainment has in previous years been provided for them. Further clarity is requested on how this element interacts with the demands that would result from the implementation of this proposed event. The full detail of which is accepted could then be provided through an EMP already being offered by the applicant.

***I am awaiting the applicant's response regarding the above matters, at which point it may be possible to withdraw my representation.***
