Update on Station Approach CAB3349 Addendum

Scrutiny Committee met on Wednesday 13 July 2022 and made several suggestions and recommendations to Cabinet. Each of these have been reviewed and are addressed below.

Include the names of phases to appendix 2 to clarify the timelines.

The Project Team have reviewed 'The Journey' diagram and are updating it to show each phase with the timelines as requested. The updated Journey diagram will be ready for the launch of the engagement programme.

Review how the accessibility of the interactive maps could be improved when viewed on older or different forms of technology.

The interactive map has been designed as a mobile first tool and accessibility will be tested on multiple platforms prior to 'going live' to ensure that it works on different mobiles/computers.

Consider the strategic areas across the district that could be used for the distribution of the paper copy survey.

The website will advise that if people would like a paper copy of the survey they can call a free phone telephone number or e-mail to request one.

Enable the distribution of the newsletter online and via social media.

The newsletter will be distributed on-line and via social media.

Consider whether the newsletter distribution be wider than a radius of 1/4 of a mile of the site

The original intention was to distribute the newsletter and survey to every household within a $\frac{1}{4}$ mile radius of the site this would cover 1,740 properties. We have reviewed this decision and will extend the area to $\frac{1}{2}$ mile radius this will increase the coverage to 5,602 properties.

Provide further clarity for residents around the reasons for consultation at each stage to ensure understanding of the process.

It is important that the process is as transparent and as clear as possible to ensure that as many people as possible can contribute to the process. At each stage the Council will set out what is being engaged and/or consulted on.

<u>Consider providing "walkabout" sessions for residents as part of the consultation</u> programme and consider virtual "walkabouts" for those unable to access in person.

Suggestion agreed and to be organised.

Consider how to optimise engagement across the wider district.

The social media strategy will reach across Winchester not just the Station Approach area.

All Parish Councils will be informed of the project and engagement plan and be provided with copies of the newsletter and other communications for them to put on their notice boards and websites.

Regular updates will be produced for Your Council News and Parish Connect publications.

The project page on the Council's website will be updated regularly.

Review the red line in para 11.7 to ensure accuracy (with specific reference to the gueries concerning land adjacent the Records Office).

The land in question has been reviewed and it is owned by Hampshire County Council and the red line is therefore accurate. However, it is important that the project looks at how to integrate (and improve) the public realm of adjacent land, buildings and transport/pedestrian routes and junctions.

The map has been updated (see blue hatched areas) to show areas of other potential sites in the vicinity which could include working with other partners/landholdings, if they are supportive, which will assist in bringing forward a potentially broader comprehensive scheme for the whole area as well as ensure that public realm issues are appropriately considered.

See map attached – this should replace the map currently shown in 11.7. and referred to in recommendation 2.

Extend Consultation Period

Consideration has been given as to whether the consultation period could be extended further given that students of the universities and college won't be returning until September. The programme has been reviewed and it is suggested that the engagement runs from 1 August to 23 October (a twelve-week period). If this is acceptable then recommendation 5 should be amended to read:

Agree to launch the public engagement and consultation process for the Station Approach project on 1st August 2022 and run to 23 October 2022.
