ROAD TRAFFIC REGULATION ACT 1984

THE HAMPSHIRE (VARIOUS ROADS, BISHOPS WALTHAM) (RESTRICTION OF WAITING) ORDER 1985 (VARIATION NO.4) ORDER 2022

Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers and duties under Sections 1, 2, 4 and 122(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Regulation (Parking) Act 1986 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order :-

- 1. In this order the "Principal Order" means "The Hampshire (Various Roads, Bishops Waltham) (Restriction of Waiting) Order 1985" as amended.
- 2. The Principal Order shall have effect as though the following definitions shall be inserted into Article 1 (1):

"Civil Enforcement Officer" has the same meaning as in Section 76 of the Traffic Management Act of 2004;

"Goods Vehicle" has the same meaning as in Section 192 of the Road Traffic Act 1988;

- 3. The Principal Order shall have effect in that the items specified in Schedule 1 of this Order shall be deleted from the Principal Order.
- 4. The Principal Order shall have effect in that the items specified in Schedule 2 of this Order shall be inserted in Schedule I of the Principal Order.
- 5. The Principal Order shall have effect in that the items specified in Schedule 3 of this Order shall be inserted in Schedule II of the Principal Order.
- 6. The Principal Order shall have effect in that the items specified in Schedule 4 of this Order shall be inserted in Schedule III of the Principal Order.
- 7. The Principal Order shall have effect in that the term 'traffic wardens' in Article 2 is replaced with 'Civil Enforcement Officer'.
- 8. The Principal Order shall have effect as though a new Article 2 (f) and (g) is added:
 "2 (f) between the hours of 8.00 am and 4.00 pm on Monday to Friday (inclusive) on any of the sides of the road specified in Schedule VI of this Order.

2 (g) between the hours of 9am to 6pm on the side of the road as specified in Schedule VII of this Order for a period longer than 20 minutes or if a period of less than 40 minutes has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same side of the road.

9. The Principal Order shall have effect as though a new Article 2A is added:

"Save as provided in Article 3, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any vehicle to wait in the parking places set out in Schedule VIII to this Order, unless that vehicle is a Disabled Persons Vehicle."

10. The Principal Order shall have effect as though a new Article 2B is added:

"Save as provided in Article 3 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or Civil Enforcement Officer, cause or permit any vehicle to wait on any sides of the road specified in Schedule IX between the hours of 6am and 7pm, unless that vehicle is a Goods Vehicle and it is engaged in loading or unloading."

11. The Principal Order shall have effect as though a new Article 2C is added:

"Save as provided in Article 3 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or Civil Enforcement Officer, cause or permit any vehicle to wait for the purpose of loading or unloading of goods, on any sides of the road specified in Schedule X of this Order,"

12. The Principal Order shall have effect as though a new Article 2D is added:

"Save as provided by in Article 3 of this order no person shall, except upon the direction or with the permission of a police constable in uniform or Civil Enforcement Officer, cause or permit any vehicle to stop on the school entrance on any sides of the road specified in Schedule XI to this Order"

13. The Principal Order shall have effect in that the following amendment is made to Article 3 as follows:

"Nothing in Article 2 of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of road referred to in that Article for so long as may be necessary"

shall be replaced with

"Nothing in Articles 2, 2A, 2B 2C and 2D of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of road referred to in those Articles for so long as may be necessary"

- 14. The Principal Order shall have effect as to revoke Article 3 (b) and replace with the following:: "to enable goods to be loaded or unloaded from the vehicle, except in respect to any sides of the road and in accordance with the restriction specified in Schedule IX of this Order and except in respect to any sides of the road specified in Schedule X of this Order.
- 15. The Principal Order shall have effect as though the items specified in Schedule 5 to this Order, shall be inserted into the Principal Order as the new Schedule VI - No waiting Mon-Fri 8am-4pm.
- The Principal Order shall have effect as though the items specified in Schedule 6 to this Order, shall be inserted into the Principal Order as the new Schedule_VII– Limited waiting 9am-6pm 20mins no return within 40mins.
- The Principal Order shall have effect as though the items specified in Schedule 7 to this Order, shall be inserted into the Principal Order as the new Schedule VIII – Disabled Persons Vehicles Only
- The Principal Order shall have effect as though the items specified in Schedule 8 to this Order, shall be inserted into the Principal Order as the new Schedule IX– Goods vehicles loading only 6am-7pm
- The Principal Order shall have effect as though the items specified in Schedule 9 to this Order, shall be inserted into the Principal Order as the new Schedule X – No Loading At Any Time
- 20. The Principal Order shall have effect as though the items specified in Schedule 10 to this Order, shall be inserted into the Principal Order as the new Schedule XI – No Stopping On School Entrance Marking At Any Time

21. This Order shall come into operation on 2022 and may be cited as The Hampshire (Various Roads, Bishops Waltham) (Restriction of Waiting) Order 1985 (Variation No. 4) Order 2022
