Yes	Regular team, project and board meetings are held where officers can share knowledge and raise any concerns about the implementation of the new service.
3	Have previous consultations highlighted any concerns about the service from an equality impact perspective?	No	In Autumn 2023 the council conducted an online survey which asked residents about their household waste and recycling habits. We received over 8,500 responses from across the district. 58% of residents are receptive to a recycling system that would allow them to recycle food waste. Of the 20% who were not keen to recycle food waste their key issues where concerns around: • Space – not having enough space for another bin/ no room in the kitchen of an inside bin. • Mess and smell. • It will attract pests/vermin. • No need for the service – already have minimal food waste or compost already. The council has commissioned a bin store survey of communal properties across the district which will help to inform implementation for these residents.

			No issues or concerns were highlighted about the service from an equality impact perspective.
4	Do you have any concerns regarding the implementation of this service?	No	The service will be made all available to all residents. Communal properties/ flats represent more of a challenge in terms of implementation, but the communal bin store survey will help inform this process and a targeted communications strategy to help such residents is being planned.
5	Does any accessible data regarding the area which your service will address identify any areas of concern or potential problems which may impact on your work?	No	Race: Most Winchester residents describe themselves as white British. 6.4% of the district population defined themselves as belonging to other ethnic groups. Language barriers could impact on communicating the service change to some groups. Disability: 19,566 (15%) residents' day-to-day activities are limited a little or a lot due to physical or mental health conditions. Age: 13,123 (10.3%) residents are aged 75+.
6	Do you have any past experience delivering a similar service which may inform the implementation of your scheme from an equality impact point of view?	Yes	 Green Waste collection. Glass recycling. Officers are also talking to other local authorities which have implemented a food waste collection service.
7	Are there any other issues that you think will be relevant?	Yes	Some understanding of the scheme from a language perspective may be an issue. Our communications programme will consider and seek to address this.

3	Briefly describe the aim and purpose of this work.	The Environment Act was passed into UK law in 2021 which set out the mandatory requirement to introduce separate, weekly food waste collections by 31 March 2026. The council intends to implement weekly food waste collections from October 2025.
4	What are the associated objectives of this work?	 Meet the government's directive for 'Simpler Recycling' by 31 March 2026. Reduce the impact of food waste on climate change ie carbon reduction. Prevent contamination of waste that could otherwise be recycled. Reduce the amount of residual waste.
