St Matthews Road

I refer to the above Notice and would confirm my objections to the proposals contained therein. These objections are made in the interests of safety, both to the public and vehicles using the locality.

I assume that when the parking bays were determined within St. Matthews Road, this determination reflected the adequacy of the requirement and the siting of it in a safe location. Any change to this deliberation therefore makes the proposed amendments, by definition, less safe. I do not comment on the adequacy as that is a matter for Winchester City.

My objections are two-fold:

- 1. The proposed parking bays moved nearer to the junctions of Stoney Lane / St. Matthews Road and Vernham Road / St. Matthews Road may have sight lines that comply with traffic regulations but the vision is significantly altered and less safe. Travelling along Stoney Lane, to avoid the parked vehicles, turning cars would have to be in the middle of the St. Matthews Road. A similar, but not as significant problem, existing at the Vernham Road junction.
- 2. The effect of the above is compounded by the traffic using the new 'Hazeley Development' entrance road. There would appear to be a conflict here.

  Whereas the entrance is not included on the block plan 810402/425/01 dated 25/10/18 (Lunderstand the most recent block plan available has been used in the proposal) for ease of reference Lattach a copy of planning drawing dated 02.02,2017 which helps to identify this conflict.

I would be very grateful if you could inform me as to the process beyond the cut-off date for representations and objections of 28 December, furthermore whether the public are informed of your decision.

Dear Sirs

As a resident of St Matthews Road, I wish to comment on the above proposals concerning possible changes to parking bays and vehicle access.:

St Matthew Road has been the subject of noise, disruption and upheaval for the past year or more due to the redevelopment of St Thomas Place, which is adjacent to my property at No. 4. We have been plagued by large construction vehicles of all kinds delivering to the site and using the road ass turning circles. We residents are very much looking forward to the early New Year which promises an end to this disruption and the reinstatement of St Matthews Road as the quiet residential road it used to be. We are now asked to consider even more upheaval with the potential redevelopment of No. 49 Stoney Lane permission for which appears to be dependent upon approval of the above changes.

St Thomas Place has introduced one new and one existing vehicle outlets on to St Matthews Road, very close to a busy corner, with potentially an extra 16 vehicles entering and exiting the site. We are now asked to consider the practicality of yet another two vehicles outlets on the opposite side of the road. All this on to what used to be a quiet side road, and one which is much used by dogwalkers on their way to St Matthews Field and families with young children and push chairs on their way to and from school.

I would ask the council to consider very carefully its decision on this matter, to which there is likely to be strong local objection. The site in question at 49 Stoney Lane has existing access on to Stoney Lane. Surely the site itself is big enough to redesign the layout so that the existing vehicle access is used for the increased number of properties. Why should the current vogue replacing one property with several, presumably for financial gain, take precedence over the safety and convenience of a whole neighbourhood?

I look forward to your comments.

I am writing to state that I agree completely with my husband's , letter to you dated 19th December 2018. In particular paragraph 5 in which he writes about his concern about a blind spot being created with the proposed move of the white parking boundary lines in St. Matthews Road closer to the corner with Stoney Lane.

I have personally, experiences this exact problem. Last week I was turning left into St. Matthews Road from Stoney Lane and a vehicle was parked in this precise position forcing me to drive into the oncoming side of the road. I was carrying out this manoeuvre when another vehicle approached from my opposite direction almost adjacent to the parked vehicle.

It was fortunate that we were both driving extremely slowly otherwise there would have been a collision.

In conclusion, on safety grounds, I would appreciate it if further serious consideration could be given to the proposed changes of parking in St. Matthews Road.

## Reference: Order 2010 (Variation Order No.55) Order 2018, St. Matthews Road.

I acknowledge, with thanks, receipt of a letter, dated 10th December 2018, from Mr. Crisp, Traffic Engineer, regarding the proposed changes to the waiting and parking restrictions in St. Matthews Road, and would wish to comment as follows.

With reference to the question in item 1 of my letter (dated 3rd December 2018) Mr Crisp has failed to provide an answer stating that he was not involved in the previous planning application (July 2017). I reiterate my question why the initial planning proposal was declined on traffic flow and safety grounds, whilst this project with an apparent much larger development (there appears to be three rectangular blocks at the moment) is considered safe.

With reference to my pointing out that the St. Thomas Moore site block plan (810402/425/001) is out of date, as the church has been demolished and the site redeveloped with eight dwellings and with a single vehicle and pedestrian entrance/exit for sixteen vehicles in St Matthews Road opposite the proposed dropped kerb positions. As a resident living just round the corner I am most concerned that adding additional access points from the proposed development of No. 49 Stoney Lane into St Matthews Road will very seriously impact on safety of traffic flows in a busy area (eg a" rat run" from Bereweeke Avenue, via Vernham and St. Matthews Roads, to Weeke shops and primary school)

With reference to my request in item 2. for details with respect to the proposed devlopment of 49 Stoney Lane (eg number of dwellings and associated car parking, Mr. Crisp advised me that the Developer was not willing, at this stage, to release this information.

In addition to the foregoing, I would record my serious concern with the proposal to move the white parking boundary in St.Matthews Road closer to the corner of Stoney Lane. The result of this action creates a blind spot when entering (in an a car) from Stoney Lane into St. Matthews Road from the left, and I write this from recorded experience.

In conclusion, as a resident in very close proxmity to St.Matthews Road, and based as such on information made available to me, I wish to record my objection to the proposals.

I refer to the above Notice and would confirm my objection to the proposals contained therein. This objection is made in the interests of safety, both to the public and vehicles using the locality.

My objection centres on the movement of a parking bay closer to the Stoney Lane, St. Matthews Road junction.

By allowing cars and high-sided vehicles to park so close to this junction vehicles coming from Stoney Lane into St. Matthews will be forced into the middle of the road with very limited vision.

There is now an access to the new development very near this corner for the eight properties just being built. The combination of these issues could lead to a serious traffic conflict.

The parking habits of the operatives on the building site have emphasised this point.


This situation could be made worst if the proposed development goes ahead as there will be an increase in traffic from that, unfortunately the Council has denied us access to the details of any proposal.
