SUMMARY

- Issues regarding the use of the existing advisory disabled parking bays adjacent
 to the Alresford Community Centre in West Street, New Alresford and parking of
 the New Alresford Town Trust mini-bus on Fridays to enable residents of the
 nearby villages to visit Alresford to shop escalated to a point where intervention
 was necessary by the police.
- A meeting was subsequently arranged for the various interested parties to discuss the problems and establish a potential solution.
- It was agreed to pursue a change to the existing advisory disabled bays to "Disabled Blue Badge Holders Only Monday to Thursday and Saturday and No Stopping Except Mini-buses Friday" restrictions so that the mini-bus could stop as necessary on Fridays and the advisory disabled parking bays would be clear for use by bona fide blue badge holders at other times.

- The proposed changes were advertised on 14 November 2018. Notices were
 posted on street in the immediate vicinity of the proposed changes, published in
 the Mid Hants Observer, placed on the Council's website and held on deposit in
 the City Office reception. No responses were received in relation to the proposal.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded through the Traffic Management Agency Agreement with Hampshire County Council and/or the budget provided by Winchester City Council. There will be no additional enforcement costs.
- Copy of the plan showing the location and extent of the proposal is attached (Appendix 1).
- Copy of proposed schedule and statement of reasons is attached (Appendix 2).

DECISION

- 1. That restrictions be introduced as detailed in the schedule attached (Appendix 2).
- 2. That the Head of Legal (Interim) be authorised to make the necessary order.
