#### **TOPIC - TRAFFIC REGULATION ORDER - ST JAMES LANE, WINCHESTER**

#### **SUMMARY**

- The proposal is the result of complaints received from the City Council's Landscapes and Open Spaces Team regarding inconsiderate parking in the layby adjacent to the entrance of Westhill Cemetery in St James Lane, Winchester causing access problems for grounds staff and visitors to the cemetery.
- The lay-by area is not part of the public highway and was not included in the
  original controlled zone traffic regulation order and therefore did not have any
  restrictions on parking. Advisory signs requesting motorists not to park were in
  place, but these were not being observed.

- Due to the above it was agreed that restrictions should be introduced and it was proposed to introduce enforceable 2 hours limited waiting parking restrictions with permit holder exemption in the lay-by area to help control parking.
- The proposed changes were advertised on 16 January 2019. Notices were
  posted on street in the immediate vicinity of the proposed changes, published in
  the Mid Hants Observer, placed on the Council's website and held on deposit in
  the City Office reception. No responses were received in relation to the proposal.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded through the Traffic Management Agency Agreement with Hampshire County Council and/or the budget provided by Winchester City Council. There will be no additional enforcement costs.
- Copy of the plan showing the location and extent of the proposal is attached (Appendix 1).
- Copy of proposed schedule and statement of reasons is attached (Appendix 2).

#### PROPOSED DECISION

- That restrictions be introduced as detailed in the schedule attached (Appendix 2).
- 2. That the Head of Legal Services [Interim] be authorised to make the necessary order.
