THE HAMPSHIRE (VARIOUS ROADS, WINCHESTER)
(PARKING PLACES AND RESTRICTION OF WAITING)
(CONTROLLED ZONE) (CONSOLIDATION) ORDER 2010

STATEMENT OF REASONS FOR REVISION:-

The proposals are to address issues with allocation of amenity permits and business permits to establishments within the new Zone Z6 which were omitted from the Variation Orders introduced on 19 March 2018.

EXISTING CLAUSES TO BE AMENDED:-

EXISTING CLAUSE

- 24 Any proprietor of business premises situated in:-
- 24.1 permit zones F and V may apply to the Council for the issue of a permit for the leaving of a relevant vehicle at any time in any parking place situated in the same permit zone as those business premises by any person normally employed at those premises;.
- 24.2 permit zone V may apply to the Council for the issue of a permit for the leaving of a relevant vehicle at any time in any parking place situated in that permit zone by any customer of that business, subject to no more than 6 permits being available for use in respect of that business address.
- 26 Any person or organisation whose premises are situated in the inner or outer areas may apply to the Council for the issue of a permit for the leaving of a relevant vehicle by any person attending those premises for the purpose of participating in activities organised by an amenity or community group, at any time in any parking place specified in Schedule 1 this Order situated in the same permit zone as those premises, subject to no more than 20 such permits being available for use in respect of any particular premises.

PROPOSED CLAUSES TO BE INCLUDED IN CPZ ORDER VARIATION

REVISED CLAUSE

- 24 Any proprietor of business premises situated in:-
- 24.1 permit zones F, V and Z6 may apply to the Council for the issue of a permit for the leaving of a relevant vehicle at any time in any parking place situated in the same permit zone as those business premises by any person normally employed at those premises;.
- 24.2 permit zone V and Z6 may apply to the Council for the issue of a permit for the leaving of a relevant vehicle at any time in any parking place situated in that permit zone by any customer of that business, subject to no more than 6 permits being available for use in respect of that business address.
- 26 Any person, organisation or school whose premises are situated in the inner or outer areas may apply to the Council for the issue of a permit for the leaving of a relevant vehicle by any person attending those premises for the purpose of participating in activities organised by an amenity, community group or school, at any time in any parking place specified in Schedule 1 this Order situated in the same permit zone as those premises, subject to no more than 20 such permits being available for use in respect of any particular premises.
