- i.) the total nominal value of the securities exceeds£25,000 or one hundredth of the total issued shared capital of that body; OR
- ii.) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, or your partner, have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Chapter 8, and other securities of any description, other than money deposited with a building society.

NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Member or Co-opted Member of the Parish Council or any other relevant authority for a period not exceeding five years.
